





Figure 1- Intilop's Differentiators

4. Delivery, Warranty, and Support

Once the equipment is secured, Intilop will arrange shipment via insured carriers to the Lottery Commission's designated location in Charleston, West Virginia. All deliveries will be FOB Destination, meaning that we take full responsibility for transportation, risk, and insurance until the equipment is received and



accepted by the Commission.
