SPECIFICATIONS

1. **PURPOSE AND SCOPE:** The West Virginia Purchasing Division is soliciting bids on behalf of Alcohol Beverage and Control Administration to establish a contract for the one-time purchase of 2 Palo Alto Networks Enterprise Firewall (PAN-PA-550), 2 Palo Alto Networks network device rack mount shelf - 1U and 4 Palo Alto Networks - SFP+ transceiver module - 10GbE.
2. **DEFINITIONS:** The terms listed below shall have the meanings assigned to them below. Additional definitions can be found in section 2 of the General Terms and Conditions.
 - 2.1 **"Contract Item"** means firewalls, rack mounting shelves and transceiver modules as more fully described by these specifications.
 - 2.2 **"Pricing Page"** means the pages, contained in wvOASIS or attached as Exhibit A, upon which Vendor should list its proposed price for the Contract Items.
 - 2.3 **"Solicitation"** means the official notice of an opportunity to supply the State with goods or services that is published by the Purchasing Division.
 - 2.4 **"GB"** means gigabyte which is a multiple of the unit byte for digital information.
 - 2.5 **"Gbps"** means gigabits per second, a data transfer speed measurement for high-speed networks such as gigabit ethernet.
 - 2.6 **"Mbps"** means megabits per second which is a unit of measurement for bandwidth and throughput on a network.
 - 2.7 **"OEM"** means original equipment manufacturer.
 - 2.8 **"RMA"** means Return Merchandise Authorization, which is a process that allows customers to return a product to a seller for a refund, replacement, or repair, typically within a warranty period
 - 2.9 **"VLAN"** means Virtual Local Area Network.
 - 2.10 **"DNS"** means Domain Name Servers which is the Internet's system for converting alphabetic domain names into numerical IP addresses.
 - 2.11 **"DMZ"** means a physical or logical subnetwork that contains and exposes an organization's external-facing services to an untrusted network, usually the internet.

2.12 "SQL" means Structured Query Language which is a domain-specific language used in programming and designed for managing data held in a relational database management system (RDBMS), or for stream processing in a relational data stream management system (RDSMS).

2.13 "SFP+" means Enhanced Small Form-Factor Pluggable which is a compact, hot-pluggable network interface module that is used for data communications.

2.14 "ML" means Machine Learning which is subset of artificial intelligence (AI) that focuses on algorithms that enable computers to learn from and make predictions based on data without being explicitly programmed for each task.

3. GENERAL REQUIREMENTS:

3.1 Mandatory Contract Item Requirements: Contract Item must meet or exceed the mandatory requirements listed below.

3.1.1 Palo Alto Networks Next-Generation Firewall (PAN-PA-550) or Equal (Qty 2)

3.1.1.1 System must have embedded machine learning (ML) in the core of the firewall to provide inline signatureless attack prevention.

3.1.1.2 System must identify applications and users across all ports, regardless of evasion tactics or encryption, allowing for granular policy control.

3.1.1.3 System must receive software updates from designated servers located in the US.

3.1.1.4 System must support high availability with active/active and active/passive modes.

3.1.1.5 System must support centralized administration with Panorama® network security management or equal.

3.1.1.6 System must have audit logs that document security-related events.

3.1.1.7 System must have a minimum Firewall Throughput of 6.5 Gbps.

3.1.1.8 System must be capable of locking administrator accounts after no more than three (3) unsuccessful attempts to logon with an invalid password.

3.1.1.9 System must be configurable to require multi-factor authentication for remote device management.

3.1.1.10 Vendor must be an authorized reseller of all equipment bid. All equipment must be new and genuine; refurbished or gray market equipment will not be accepted.

3.1.2 Palo Alto Networks network device rack mount shelf - 1U (PAN-1RU-4POST-RACK-11) or Equal (Qty 2)

3.1.2.1 Shelf must be four post rack-mountable design with a height of one rack unit.

3.1.2.2 Shelf must be compatible with PAN-PA-550 firewall or equal.

3.1.3 Palo Alto Networks - SFP+ transceiver module - 10GbE (PAN-SFP-PLUS-SR) or Equal (Qty 4)

3.1.3.1 Transceiver modules must work with 10 Gigabit Ethernet data link protocol, enabling a data transfer rate of 10 Gb/s.

3.1.3.2 Modules must have an Ethernet 10GBase-SR interface.

3.1.3.3 SFP+ modules must be compatible with PAN-PA-550 firewall or equal.

3.2 Alternate 'or Equal' Submission

3.2.1 Vendor submitting an alternate brand must include manufacturer part/model numbers with bid pricing. Vendors submitting an alternate brand of firewall must provide technical documentation demonstrating that the proposed equipment meets or exceeds all mandatory functional specifications in Section 3.1.1. For alternate firewall submissions, the vendor is solely responsible for including all necessary security software subscriptions (including, but not limited to, WildFire, Advanced Threat Prevention, and

management capabilities equivalent to those provided by the state's enterprise agreement) for the duration of the hardware life. For any alternate accessory items bid (e.g., non-Palo Alto SFP+ transceiver modules), the vendor must provide documentation confirming hardware compatibility and full interoperability with the firewall appliances being provided. Vendor must include alternate brand information with alternative part numbers on the Pricing Sheet.

3.2.2 If Vendor is submitting an "or Equal" product, this information must be provided at the time of submitting bid response. Any documentation supporting such should be submitted with bid response. This information may be required before award of contract.

3.2.3 Vendor will assume any costs related to any required installation of new software, hardware and/or training of the alternate submission provide as part of this agreement.

4. CONTRACT AWARD:

4.1 Contract Award: The Contract is intended to provide Agencies with a purchase price for the Contract Items. The Contract shall be awarded to the Vendor that provides the Contract Items meeting the required specifications for the lowest overall total cost as shown on the Pricing Pages.

4.2 Pricing Page: Vendor should complete the Pricing Page by filling in the unit price and total prices for each line item. Vendor should complete the Pricing Page in full as failure to complete the Pricing Page in its entirety may result in Vendor's bid being disqualified.

Vendor should type or electronically enter the information into the Pricing Page to prevent errors in the evaluation.

5. PAYMENT:

5.1 Payment: Vendor shall accept payment in accordance with the payment procedures of the State of West Virginia.

6. DELIVERY AND RETURN:

6.1 Shipment and Delivery: Vendor shall ship the Contract Items immediately after being awarded this Contract and receiving a purchase order or notice to proceed. Vendor shall deliver the Contract Items within 60 working days after receiving a purchase order or notice to proceed. Contract Items must be delivered to Agency at 900 Pennsylvania Ave. 4th floor, Charleston, WV 25302.

6.2 Late Delivery: The Agency placing the order under this Contract must be notified in writing if the shipment of the Contract Items will be delayed for any reason. Any delay in delivery that could cause harm to an Agency will be grounds for cancellation of the Contract, and/or obtaining the Contract Items from a third party.

Any Agency seeking to obtain the Contract Items from a third party under this provision must first obtain approval of the Purchasing Division.

6.3 Delivery Payment/Risk of Loss: Vendor shall deliver the Contract Items F.O.B. destination to the Agency's location.

6.4 Return of Unacceptable Items: If the Agency deems the Contract Items to be unacceptable, the Contract Items shall be returned to Vendor at Vendor's expense and with no restocking charge. Vendor shall either make arrangements for the return within five (5) days of being notified that items are unacceptable, or permit the Agency to arrange for the return and reimburse Agency for delivery expenses. If the original packaging cannot be utilized for the return, Vendor will supply the Agency with appropriate return packaging upon request. All returns of unacceptable items shall be F.O.B. the Agency's location. The returned product shall either be replaced, or the Agency shall receive a full credit or refund for the purchase price, at the Agency's discretion.

6.5 Return Due to Agency Error: Items ordered in error by the Agency will be returned for credit within 30 days of receipt, F.O.B. Vendor's location. Vendor shall not charge a restocking fee if returned products are in a resalable condition. Items shall be deemed to be in a resalable condition if they are unused and in the original packaging. Any restocking fee for items not in a resalable condition shall be the lower of the Vendor's customary restocking fee or 5% of the total invoiced value of the returned items.

7 VENDOR DEFAULT:

7.1 The following shall be considered a vendor default under this Contract.

7.1.1 Failure to provide Contract Items in accordance with the requirements contained herein.

Q1. Is this a new design or a rip-and-replace? What products do you currently have in place? Do you have specs for the firewall and SFPs? This will help us to determine what products to offer.

A: This is a hardware refresh. The state will not be disclosing details regarding existing internal network models or active configurations. Technical requirements for the firewalls and transceiver modules are fully detailed in Section 3.1 of the RFQ specifications.

Q2. The spec asks for central management like Panorama, but Panorama only manages Palo Alto firewalls - with any other brand you would be getting a different management system either way. With Check Point, a pair of firewalls can be managed from the appliances themselves at no added cost, or from a separate management system we would price into the bid. Which do you need?

A: If submitting an alternate brand, the vendor must include centralized management software/capabilities equivalent to Panorama (capable of unified logging, template-based policy distribution, and multi-device administration) priced into the bid, in accordance with Section 3.1.1.5 and Section 3.2.1. Managing appliances individually without a centralized management platform is not acceptable.

Q3. The spec asks for both active/active and active/passive. Active/active is a highly unusual setup for a pair of firewalls - is that something you are intending to run, or will you be using active/standby?

A: The requirement specifies that the hardware/operating system platform must support both Active/Active and Active/Passive High Availability modes to meet state standards. The primary intended operational deployment is Active/Passive (active/standby).

Q4. It says to include the security software "for the duration of the hardware life," but does not say how many years, and there is no line on the pricing page to put it on.

A: For any alternate "or Equal" firewall submission, software subscription pricing must cover a 5-year lifecycle. All subscription costs must be included in the unit/extended pricing provided on Exhibit A (Pricing Page) under Item 1 for the firewall hardware, as outlined in Section 3.2.1. Separate line-item software fees will not be accepted.

Q5. Which address should this ship to? The spec says 900 Pennsylvania Avenue in Charleston, wvOASIS says the ABCA warehouse in Nitro.

A: Please deliver to the official RFQ delivery address specified in Section 6.1: West Virginia Alcohol Beverage Control Administration, 900 Pennsylvania Ave., 4th Floor, Charleston, WV 25302.

- 21. APPLICABLE LAW:** This Contract is governed by and interpreted under West Virginia law without giving effect to its choice of law principles. Any information provided in specification manuals, or any other source, verbal or written, which contradicts or violates the West Virginia Constitution, West Virginia Code, or West Virginia Code of State Rules is void and of no effect.
- 22. COMPLIANCE WITH LAWS:** Vendor shall comply with all applicable federal, state, and local laws, regulations and ordinances. By submitting a bid, Vendor acknowledges that it has reviewed, understands, and will comply with all applicable laws, regulations, and ordinances.

Any change to existing contracts that adds work or changes contract cost, and were not included in the original contract, must be approved by the Purchasing Division and the Attorney General's Office (as to form) prior to the implementation of the change or commencement of work affected by the change.
- 25. WAIVER:** The failure of either party to insist upon a strict performance of any of the terms or provision of this Contract, or to exercise any option, right, or remedy herein contained, shall not be construed as a waiver or a relinquishment for the future of such term, provision, option, right, or remedy, but the same shall continue in full force and effect. Any waiver must be expressly stated in writing and signed by the waiving party.

- 26. SUBSEQUENT FORMS:** The terms and conditions contained in this Contract shall supersede any and all subsequent terms and conditions which may appear on any form documents submitted by Vendor to the Agency or Purchasing Division such as price lists, order forms, invoices, sales agreements, or maintenance agreements, and includes internet websites or other electronic documents. - 28. WARRANTY:** The Vendor expressly warrants that the goods and/or services covered by this Contract will: (a) conform to the specifications, drawings, samples, or other description furnished or specified by the Agency; (b) be merchantable and fit for the purpose intended; and (c) be free from defect in material and workmanship.
- 29. STATE EMPLOYEES:** State employees are not permitted to utilize this Contract for personal use and the Vendor is prohibited from permitting or facilitating the same.
- 30. PRIVACY, SECURITY, AND CONFIDENTIALITY:** The Vendor agrees that it will not disclose to anyone, directly or indirectly, any such personally identifiable information or other confidential information gained from the Agency, unless the individual who is the subject of the information consents to the disclosure in writing or the disclosure is made pursuant to the Agency's policies, procedures, and rules. Vendor further agrees to comply with the Confidentiality Policies and Information Security Accountability Requirements, set forth in www.state.wv.us/admin/purchase/privacy.
- 31. YOUR SUBMISSION IS A PUBLIC DOCUMENT:** Vendor's entire response to the Solicitation and the resulting Contract are public documents. As public documents, they will be disclosed to the public following the bid/proposal opening or award of the contract, as required by the competitive bidding laws of West Virginia Code §§ 5A-3-1 et seq., 5-22-1 et seq., and 5G-1-1 et seq. and the Freedom of Information Act West Virginia Code §§ 29B-1-1 et seq.

DO NOT SUBMIT MATERIAL YOU CONSIDER TO BE CONFIDENTIAL, A TRADE SECRET, OR OTHERWISE NOT SUBJECT TO PUBLIC DISCLOSURE.

Vendor shall be responsible for selecting, supervising, and compensating any and all individuals employed pursuant to the terms of this Solicitation and resulting contract. Neither the Vendor, nor any employees or subcontractors of the Vendor, shall be deemed to be employees of the State for any purpose whatsoever. Vendor shall be exclusively responsible for payment of employees and contractors for all wages and salaries, taxes, withholding payments, penalties, fees, fringe benefits, professional liability insurance premiums, contributions to insurance and pension, or other deferred compensation plans, including but not limited to, Workers' Compensation and Social Security obligations, licensing fees, etc. and the filing of all necessary documents, forms, and returns pertinent to all of the foregoing.

Vendor shall hold harmless the State, and shall provide the State and Agency with a defense against any and all claims including, but not limited to, the foregoing payments, withholdings, contributions, taxes, Social Security taxes, and employer income tax returns.

41. PREFERENCE FOR USE OF DOMESTIC STEEL PRODUCTS: Except when authorized by the Director of the Purchasing Division pursuant to W. Va. Code § 5A-3-56, no contractor may use or supply steel products for a State Contract Project other than those steel products made in the United States. A contractor who uses steel products in violation of this section may be subject to civil penalties pursuant to W. Va. Code § 5A-3-56. As used in this section:

- a. “State Contract Project” means any erection or construction of, or any addition to, alteration of or other improvement to any building or structure, including, but not limited to, roads or highways, or the installation of any heating or cooling or ventilating plants or other equipment, or the supply of and materials for such projects, pursuant to a contract with the State of West Virginia for which bids were solicited on or after June 6, 2001.
- b. “Steel Products” means products rolled, formed, shaped, drawn, extruded, forged, cast, fabricated or otherwise similarly processed, or processed by a combination of two or more or such operations, from steel made by the open hearth, basic oxygen, electric furnace, Bessemer or other steel making process.
- c. The Purchasing Division Director may, in writing, authorize the use of foreign steel products if:
 - 1. The cost for each contract item used does not exceed one tenth of one percent (.1%) of the total contract cost or two thousand five hundred dollars (\$2,500.00) , whichever is greater. For the purposes of this section, the cost is the value of the steel product as delivered to the project; or
 - 2. The Director of the Purchasing Division determines that specified steel materials are not produced in the United States in sufficient quantity or otherwise are not reasonably available to meet contract requirements.

42. PREFERENCE FOR USE OF DOMESTIC ALUMINUM, GLASS, AND STEEL: In Accordance with W. Va. Code § 5-19-1 et seq., and W. Va. CSR § 148-10-1 et seq., for every contract or subcontract, subject to the limitations contained herein, for the construction, reconstruction, alteration, repair, improvement or maintenance of public works or for the purchase of any item of machinery or equipment to be used at sites of public works, only domestic aluminum, glass or steel products shall be supplied unless the spending officer determines, in writing, after the receipt of offers or bids, (1) that the cost of domestic aluminum, glass or steel products is unreasonable or inconsistent with the public interest of the State of West Virginia, (2) that domestic aluminum, glass or steel products are not produced in sufficient quantities to meet the contract requirements, or (3) the available domestic aluminum, glass, or steel do not meet the contract specifications. The cost of domestic aluminum, glass, or steel products may be unreasonable if the cost is more than twenty percent (20%) of the bid or offered price for foreign made aluminum, glass, or steel products. If the domestic aluminum, glass or steel products to be supplied or produced in a “substantial labor surplus area”, as defined by the United States Department of Labor, the cost of domestic aluminum, glass, or steel products may be unreasonable if the cost is more than thirty percent (30%) of the bid or offered price for foreign made aluminum, glass, or steel products. This preference shall be applied to an item of machinery or equipment, as indicated above, when the item is a single unit of equipment or machinery manufactured primarily of aluminum, glass or steel, is part of a public works contract and has the sole purpose or of being a permanent part of a single public works project. This provision does not apply to equipment or machinery purchased by a spending unit for use by that spending unit and not as part of a single public works project.

All bids and offers including domestic aluminum, glass or steel products that exceed bid or offer prices including foreign aluminum, glass or steel products after application of the preferences provided in this provision may be reduced to a price equal to or lower than the lowest bid or offer price for foreign aluminum, glass or steel products plus the applicable preference. If the reduced bid or offer prices are made in writing and supersede the prior bid or offer prices, all bids or offers, including the reduced bid or offer prices, will be reevaluated in accordance with this rule.

43. INTERESTED PARTY SUPPLEMENTAL DISCLOSURE: W. Va. Code § 6D-1-2 requires that for contracts with an actual or estimated value of at least \$1 million, the Vendor must submit to the Agency a disclosure of interested parties prior to beginning work under this Contract. 3.1.6 Alternate 'or Equal' Submission

3.1.6.1 Vendor submitting an alternate brand must include manufacturer part/model numbers with bid pricing. Vendor submitting an alternate

brand must include documentation confirming interoperability with Extreme Networks hardware with their bid. Vendor must include alternate brand information with alternative part numbers on the Pricing Sheet.

3.1.6.2 If Vendor is submitting an "or Equal" product, this information must be provided at the time of submitting bid response. Any documentation supporting such should be submitted with bid response. This information may be required before award of contract.

3.1.6.3 Vendor will assume any costs related to any required installation of new software, hardware and/or training of the alternate submission provide as part of this agreement.

6.2 Late Delivery: The Agency placing the order under this Contract must be notified in writing if the shipment of the Contract Items will be delayed for any reason. Any delay in delivery that could cause harm to an Agency will be grounds for cancellation of the Contract, and/or obtaining the Contract Items from a third party.

Any Agency seeking to obtain the Contract Items from a third party under this provision must first obtain approval of the Purchasing Division.

6.3 Delivery Payment/Risk of Loss: Vendor shall deliver the Contract Items F.O.B. destination to the Agency's location.

6.4 Return of Unacceptable Items: If the Agency deems the Contract Items to be unacceptable, the Contract Items shall be returned to Vendor at Vendor's expense and with no restocking charge. Vendor shall either make arrangements for the return within five (5) days of being notified that items are unacceptable, or permit the Agency to arrange for the return and reimburse Agency for delivery expenses.

If the original packaging cannot be utilized for the return, Vendor will supply the Agency with appropriate return packaging upon request. All returns of unacceptable items shall be F.O.B. the Agency's location. The returned product shall either be replaced, or the Agency shall receive a full credit or refund for the purchase price, at the Agency's discretion.

7.2.2 Immediate cancellation of one or more release orders issued under this Contract.

7.2.3 Any other remedies available in law or equity.
