1. Awards will be made in the best interest of the State of West Virginia.
2. The State may accept or reject in part, or in whole, any bid.
3. All quotations are governed by the *West Virginia Code* and the *Legislative Rules* of the Purchasing Division.
4. Prior to any award, the apparent successful vendor must be properly registered with the Purchasing Division and have paid the required \$45 fee.
5. All services performed or goods delivered under State Purchase Orders/Contracts are to be continued for the term of the Purchase Order/Contracts, contingent upon funds being appropriated by the Legislature or otherwise being made available. In the event funds are not appropriated or otherwise available for these services or goods, this Purchase Order/Contract becomes void and of no effect after June 30.
6. Payment may only be made after the delivery and acceptance of goods or services.
7. Interest may be paid for late payment in accordance with the *West Virginia Code*.
8. Vendor preference will be granted upon written request in accordance with the *West Virginia Code*.
9. The State of West Virginia is exempt from Federal and State taxes and will not pay or reimburse such taxes.
10. The Director of Purchasing may cancel any Purchase Order/Contract upon 30 days written notice to the seller.
11. The laws of the State of West Virginia and the *Legislative Rules* of the Purchasing Division shall govern all rights and duties under the Contract, including without limitation the validity of this Purchase Order/Contract.
12. Any reference to automatic renewal is hereby deleted. The Contract may be renewed only upon mutual written agreement of the parties.

SCOPE OF WORK

- Install Meter Socket and complete all necessary work to make ready for Allegheny Power to connect service. Install conduit and electrical wire from meter to panel box. Trenching and backfill will be completed per NPS Specifications (See Diagram A-1 for trench specifications). Trenching work through the parking lot will be done during the weekend as not to interfere with commuter parking. (See Diagram A for trench location) Contractor will not be required to replace pavement.

- Install conduit for data cables and telephone.

Conduit shall be installed in same trench as electrical conduit, be of the same specifications, be one (1) inch in diameter. A minimum ¼ inch pull rope will be placed through the conduit.

- Install and connect panel box

The panel box shall be 200 Amps. It shall consist of 40 circuits with a 200 Amp main breaker. Enclosure shall be rain tight. Only commercial grade switch gear will be accepted. Panel box will be waterproof and lockable. Panel box is to be installed at location indicated in diagram (B), unless otherwise approved by State Rail Authority Representative.

- Install four circuits, one for lights located on eastbound platform, one for lights located on westbound platform, and one circuit for subways and entrances. Additionally, install two weatherproof, 120 volt receptacles, one at each end of the.
- Connect all existing wiring for platforms and subway as illustrated in diagram(C).
- Replace all existing wall mounted tunnel lights with 175 watt Metal Halide wall mounted wall packs. All fixtures shall have manufacturers' vandalism wire guards. (see Diagram D)

- Add three additional 175 watt Metal Halide wall mounted wall packs at places indicated in Diagram (D).
- Replace the two hanging lights in tunnel stairway with 175 watt minimum, 250 watt maximum Metal Halide ceiling mounted lights of same configuration..
- Replace existing platform lights with 175 watt Metal Halide lights. Lights are to be equipped with photo cells and set to turn on at dusk and off at dawn. (Note, the platforms are subject to headlights and ditch lights of passing locomotives. This shall be taken into account when setting the photocells).
- All existing wiring is to be brought to and new wiring is to meet NEC code. All existing and new wiring is to be in conduit. Conduit can be ENT or IMC Rigid. If ENT is used all fittings must be steel and water proof.

Contractor is responsible for:

- Purchase of all material necessary to complete project. Contractor will provide list to SRA.

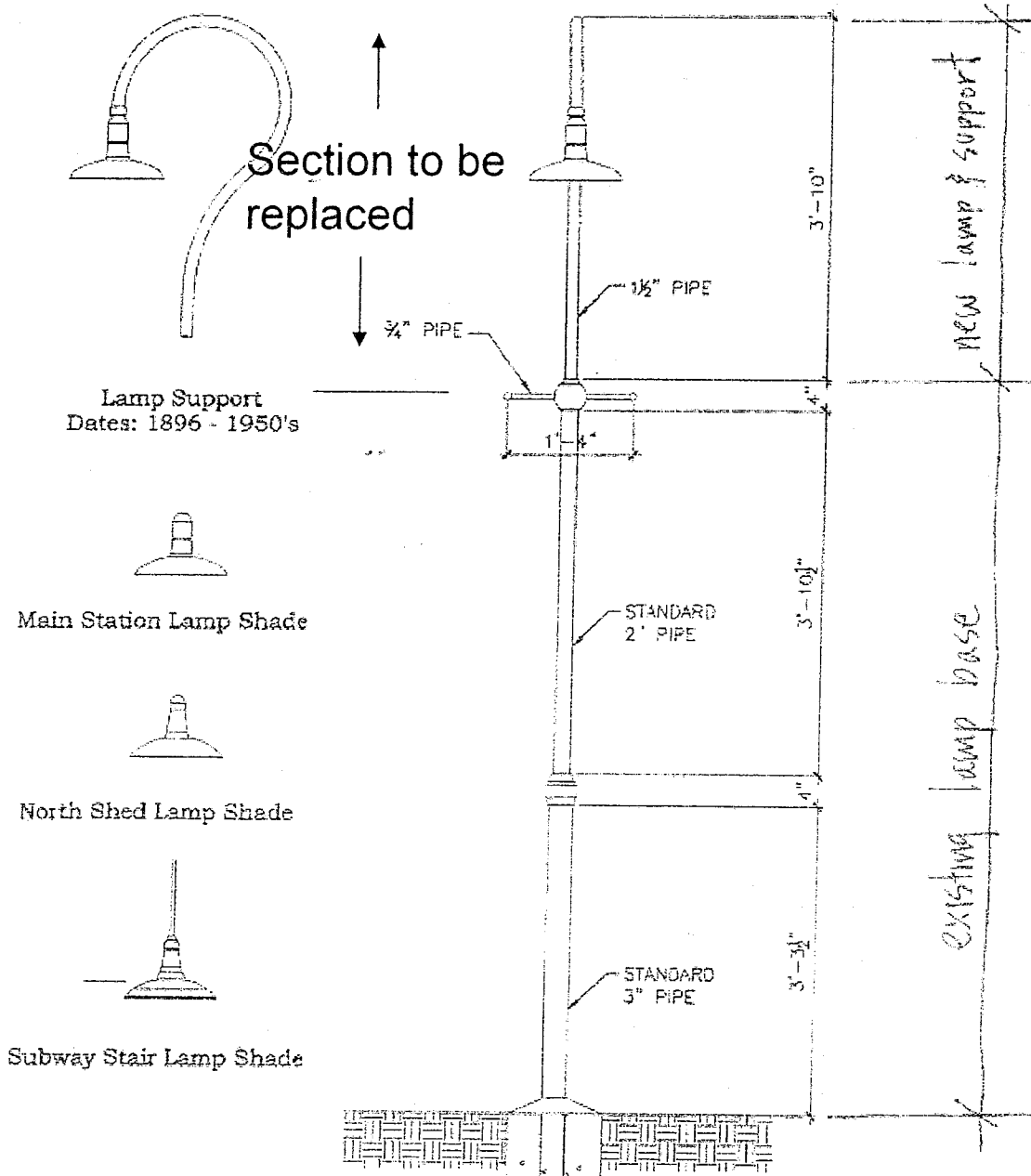

West Virginia Code §5A-3-10a states:

No contract or renewal of any contract may be awarded by the state or any of its political subdivisions to any vendor or prospective vendor when the vendor or prospective vendor or a related party to the vendor or prospective vendor is a debtor and the debt owned is an amount greater than one thousand dollars in the aggregate.

DEFINITIONS:

"Debt" means any assessment, premium, penalty, fine, tax or other amount of money owed to the state or any of its political subdivisions because of a judgment, fine, permit violation, license assessment, defaulted workers' compensation premium, penalty or other assessment presently delinquent or due and required to be paid to the state or any of its political subdivisions, including any interest or additional penalties accrued thereon.

EXCEPTION:

The prohibition of this section does not apply where a vendor has contested any tax administered pursuant to chapter eleven of this code, workers' compensation premium, permit fee or environmental fee or assessment and the matter has not become final or where the vendor has entered into a payment plan or agreement and the vendor is not in default of any of the provisions of such plan or agreement.

LICENSING:

The vendor must be licensed in accordance with any and all state requirements to do business with the state of West Virginia.
