3. All quotations are governed by the *West Virginia Code* and the *Legislative Rules* of the Purchasing Division.
4. Prior to any award, the apparent successful vendor must be properly registered with the Purchasing Division and have paid the required \$45 fee.
5. All services performed or goods delivered under State Purchase Orders/Contracts are to be continued for the term of the Purchase Order/Contracts, contingent upon funds being appropriated by the Legislature or otherwise being made available. In the event funds are not appropriated or otherwise available for these services or goods, this Purchase Order/Contract becomes void and of no effect after June 30.
6. Payment may only be made after the delivery and acceptance of goods or services.
7. Interest may be paid for late payment in accordance with the *West Virginia Code*.
8. Vendor preference will be granted upon written request in accordance with the *West Virginia Code*.
9. The State of West Virginia is exempt from Federal and State taxes and will not pay or reimburse such taxes.
10. The Director of Purchasing may cancel any Purchase Order/Contract upon 30 days written notice to the seller.
11. The laws of the State of West Virginia and the *Legislative Rules* of the Purchasing Division shall govern all rights and duties under the Contract, including without limitation the validity of this Purchase Order/Contract.

RFQ for mattresses

All mattresses shall be HBSW compliant when installed in an HBSW compliant bed, shall comply with CFR 1632 (FF-4-72) Standards and California Technical Bulletin 129, and shall be approved for use by the fire Marshall of West Virginia using NFPA tests number 261 and 267. Written documentation by an independent testing source certifying that mattresses meet all Federal and State Regulatory requirements shall accompany the submission of bids.

120 patient mattresses (Vendor furnished/Vendor installed) shall be the following or approved equal.

Gaymar Industries Inc IMR3584 Isoflex Pressure/Shear Management System  
Mattress sized to match the selected bed platform.

SCHEDULE:

The schedule for receipt of the mattresses shall be no earlier than August 1, 2006 nor later than September 15, 2006, and further shall be subject to a specific delivery date and on-site location established with the administrator of the Nursing Home or his designee.

All shipping charges and insurances shall be included in the Seller's proposal and shall be prepaid.

The successful Vendor shall notify the Nursing Home by June 1, 2006 of their intent to deliver the mattresses on a date and at a drop-off point to be defined by the Purchaser.

The Vendor shall send to the Nursing Home on or before 30 days in advance of the scheduled delivery date the following: copies of all warranties, pre-delivery check lists, service manuals, product user manuals and in-service training aids. At that time a pre-delivery meeting will be scheduled, if required.

The pre-delivery meeting will visit and confirm the drop-off point and the date of delivery of the mattresses.

INSTALLATION:

Mattresses shall be uncrated at the drop-off point and placed on the beds, after micro-amperage leakage testing of the beds has been preformed.

**INSTRUCTION:**

The facility staff shall be instructed in the capabilities and use of the mattresses by a qualified representative of the Vendor.

**WARRANTY:**

Mattresses shall be covered by the Vendor's standard warranties, copies of which shall be provided to the facility. The warranty copy shall be imprinted with the serial number for each mattress.

# AFFIDAVIT

**West Virginia Code §5A-3-10a states:**

No contract or renewal of any contract may be awarded by the state or any of its political subdivisions to any vendor or prospective vendor when the vendor or prospective vendor or a related party to the vendor or prospective vendor is a debtor and the debt owned is an amount greater than one thousand dollars in the aggregate.

**DEFINITIONS:**

"Debt" means any assessment, premium, penalty, fine, tax or other amount of money owed to the state or any of its political subdivisions because of a judgment, fine, permit violation, license assessment, defaulted workers' compensation premium, penalty or other assessment presently delinquent or due and required to be paid to the state or any of its political subdivisions, including any interest or additional penalties accrued thereon.

"Debtor" means any individual, corporation, partnership, association, limited liability company or any other form or business association owing a debt to the state or any of its political subdivisions.

"Political subdivision" means any county commission; municipality; county board of education; any instrumentality established by a county or municipality; any separate corporation or instrumentality established by one or more counties or municipalities, as permitted by law; or any public body charged by law with the performance of a government function or whose jurisdiction is coextensive with one or more counties or municipalities.

"Related party" means a party, whether an individual, corporation, partnership, association, limited liability company or any other form or business association or other entity whatsoever, related to any vendor by blood, marriage, ownership or contract through which the party has a relationship of ownership or other interest with the vendor so that the party will actually or by effect receive or control a portion of the benefit, profit or other consideration from performance of a vendor contract with the party receiving an amount that meets or exceeds five percent of the total contract amount.

**EXCEPTION:**

The prohibition of this section does not apply where a vendor has contested any tax administered pursuant to chapter eleven of this code, workers' compensation premium, permit fee or environmental fee or assessment and the matter has not become final or where the vendor has entered into a payment plan or agreement and the vendor is not in default of any of the provisions of such plan or agreement.

**LICENSING:**

The vendor must be licensed in accordance with any and all state requirements to do business with the state of West Virginia.

**CONFIDENTIALITY:**

The vendor agrees that he or she will not disclose to anyone, directly or indirectly, any such personally identifiable information or other confidential information gained from the agency, unless the individual who is the subject of the information consents to the disclosure in writing or the disclosure is made pursuant to the agency's policies, procedures and rules. Vendors should visit [www.state.wv.us/admin/purchase/privacy](http://www.state.wv.us/admin/purchase/privacy) for the Notice of Agency Confidentiality Policies.
