- 1. Awards will be made in the best interest of the State of West Virginia.
- 2. The State may accept or reject in part, or in whole, any bid.
- 3. All quotations are governed by the West Virginia Code and the Legislative Rules of the Purchasing Division.
- 4. Prior to any award, the apparent successful vendor must be properly registered with the Purchasing Division and have paid the required \$125.00 registration fee.
- 5. All services performed or goods delivered under State Purchase Orders/Contracts are to be continued for the term of the Purchase Order/Contract, contingent upon funds being appropriated by the Legislature or otherwise being made available. In the event funds are not appropriated or otherwise available for these services or goods, this Purchase Order/Contract becomes void and of no effect after June 30.
- 6. Payment may only be made after the delivery and acceptance of goods or services.
- 7. Interest may be paid for late payment in accordance with the West Virginia Code.
- 8. Vendor preference will be granted upon written request in accordance with the West Virginia Code.
- 9. The State of West Virginia is exempt from federal and state taxes and will not pay or reimburse such taxes.
- 10. The Director of Purchasing may cancel any Purchase Order/Contract upon 30 days written notice to the seller.
- 11. The laws of the State of West Virginia and the *Legislative Rules* of the Purchasing Division shall govern all rights and duties under the Contract, including without limitation the validity of this Purchase Order/Contract.

EMERGENCY LIGHTING

The following specifications are for the Whelen Super-LED Talon™, Model TLN1B or equal. The remote directional head assembly shall come complete with all standard mounting hardware and brackets to mount the unit on the windshield.

1.0 **DESIGN**

- The directional head assembly shall have one (1) Linear Super-LED module which contains a minimum of six (6) individual Super-LEDs (Generation 3.5) that are mounted in a single reflector in a straight line with a diffuser panel in front of it to provide considerable light at a 90 degree angle. The unit shall be Blue and have a clear outer lens, and shall be mounted in black polycarbonate housing for long life and durability. The unit will be mounted inside the passenger compartment. It must come complete with a bail mounting bracket to allow the unit to be mounted to the windshield (via suction cups), dash, deck or headliner of the vehicle. The unit shall draw less than .5 amps and have a minimum 10 ft. cord with cigarette lighter plug that includes an On/Off switch and LED "On" indicator, all on the end of the plug.
- There shall be a minimum total of fifteen (15) flash patterns to choose from via a recessed button located on the back of the unit. Lights that have an external pattern control button are not acceptable. This will assist in the agency's effort to have the same lighting configuration on every vehicle. The unit will have a non-volatile memory and stay in the pattern selected until changed by the operator.
- 1.3 The lighthead assembly shall measure a minimum of 5-1/2 inches long x 3-1/2 to 4 inches high with the mounting bracket, and a minimum of 2-1/4 inches deep without the shroud (The maximum size allowable is 5-3/4 inches with the shroud). The lighthead shall be molded polycarbonate with rounded over corners.
- 1.4 The unit shall be supplied standard with a snap-on hood (also constructed of a polycarbonate material) with stick-on chrome to reduce flashback and increase light output.
- 1.5 The outer lens shall be made of clear polycarbonate for stealth look. When the unit is off, it shall appear clear; when turned on, only then will the unit reflect a color.

2.0 WARRANTY

2.1 The light assembly shall be warranted by the manufacturer to the end user directly, to be free from defects of material or workmanship for a period of two (2) years from date of

manufacture. Super-LED modules shall be warranted for a period of five (5) years. Written proof of this warranty by the manufacturer must be furnished by the bidder and attached to the bid.

3.0 **SAMPLE**

- 3.1 A sample may be requested and shall be provided for bid evaluation purposes only. The bidder is responsible for shipping to a and from the designated location as requested by the agency.
- 4.0 <u>Mounting Options:</u> The West Virginia Division of Natural Resources operates a variety of vehicles. Due to the wide applications of this light, all of the brackets must be made available to insure proper installation in every vehicle. Please indicate all available mounting bracket models and price.

SPECIFICATION FOR A DUAL SWITCH

The following specifications are for the Whelen 2SWITCH w/(2) PC1 switches or equal.

1.0 <u>DESIGN</u>

- 1.1 The switch bracket will be made of aluminum. It will be bent at 90degrees, "L bracket". It should measure a minimum of 3" across and maximum of 3.5 inches wide. It needs to hold 2 rocker type switches.
- 1.2 The rocker switches need to be lighted SPST, rated for 12volts and 15amps. The switch needs to be a minimum of 5/8" wide and a maximum of 3/4 inch wide.

2.0 SAMPLE

AFFIDAVIT

West Virginia Code §5A-3-10a states:

"Debt" means any assessment, premium, penalty, fine, tax or other amount of money owed to the state or any of its political subdivisions because of a judgment, fine, permit violation, license assessment, defaulted workers' compensation premium, penalty or other assessment presently delinquent or due and required to be paid to the state or any of its political subdivisions, including any interest or additional penalties accrued thereon.

"Debtor" means any individual, corporation, partnership, association, limited liability company or any other form or business association owing a debt to the state or any of its political subdivisions. "Political subdivision" means any county commission; municipality; county board of education; any instrumentality established by a county or municipality; any separate corporation or instrumentality established by one or more counties or municipalities, as permitted by law; or any public body charged by law with the performance of a government function or whose jurisdiction is coextensive with one or more counties or municipalities. "Related party" means a party, whether an individual, corporation, partnership, association, limited liability company or any other form or business association or other entity whatsoever, related to any vendor by blood, marriage, ownership or contract through which the party has a relationship of ownership or other interest with the vendor so that the party will actually or by effect receive or control a portion of the benefit, profit or other consideration from performance of a vendor contract with the party receiving an amount that meets or exceed five percent of the total contract amount.

EXCEPTION:

The prohibition of this section does not apply where a vendor has contested any tax administered pursuant to chapter eleven of this code, workers' compensation premium, permit fee or environmental fee or assessment and the matter has not become final or where the vendor has entered into a payment plan or agreement and the vendor is not in default of any of the provisions of such plan or agreement.

LICENSING:

Vendors must be licensed and in good standing in accordance with any and all state and local laws and requirements by any state or local agency of West Virginia, including, but not limited to, the West Virginia Secretary of State's Office, the West Virginia Tax Department, West Virginia Insurance Commission, or any other state agencies or political subdivision. Furthermore, the vendor must provide all necessary releases to obtain information to enable the Director or spending unit to verify that the vendor is licensed and in good standing with the above entities.

CONFIDENTIALITY:

The vendor agrees that he or she will not disclose to anyone, directly or indirectly, any such personally identifiable information or other confidential information gained from the agency, unless the individual who is the subject of the information consents to the disclosure in writing or the disclosure is made pursuant to the agency's policies, procedures and rules.
