3. All quotations are governed by the *West Virginia Code* and the *Legislative Rules* of the Purchasing Division.
4. Prior to any award, the apparent successful vendor must be properly registered with the Purchasing Division and have paid the required \$125.00 registration fee.
5. All services performed or goods delivered under State Purchase Orders/Contracts are to be continued for the term of the Purchase Order/Contract, contingent upon funds being appropriated by the Legislature or otherwise being made available. In the event funds are not appropriated or otherwise available for these services or goods, this Purchase Order/Contract becomes void and of no effect after June 30.
6. Payment may only be made after the delivery and acceptance of goods or services.
7. Interest may be paid for late payment in accordance with the *West Virginia Code*.
8. Vendor preference will be granted upon written request in accordance with the *West Virginia Code*.
9. The State of West Virginia is exempt from federal and state taxes and will not pay or reimburse such taxes.
10. The Director of Purchasing may cancel any Purchase Order/Contract upon 30 days written notice to the seller.
11. The laws of the State of West Virginia and the *Legislative Rules* of the Purchasing Division shall govern all rights and duties under the Contract, including without limitation the validity of this Purchase Order/Contract.

**Need**

**A person is needed to serve as a consultant for the West Virginia Department of Education to serve as a *Learn & Serve Training Specialist* beginning upon award and extending to July 31, 2007 (1 year with two possible renewals at the same yearly rate upon successful performance) to meet the WV requirements of a three-year federal grant with the Corporation for National and Community Service (CNCS) and the successful vendor must perform the following duties:**

1. Arrange on-site sub-grantee consultation visits to provide in-depth training to statewide WV students, teachers, administrators, parents and community partners to expand and strengthen service-learning, teambuilding, diversity, communication, leadership, character education, community and faith-based programming, homeland security, anger management/tolerance, multi-cultural awareness/cultural awareness, reading and writing focused service-learning projects, art (music, singing, theater, painting, drawing), and healthy lifestyles (obesity, wellness, etc.);
2. Train at least 40 K-12 students and 50 adults per year;
3. Develop Learn & Serve written materials, and a monthly newsletter as part of contract;
4. Train at least two classroom teachers for each sub-grantee (16 in 2006) to serve as Service-Learning Teachers (SLTs) and two students to serve as WV Youth Action Council (WVYAC) members during each academic school year in service-learning 101 techniques including rationale, benefits, reflection, curriculum integration, and how to create effective teambuilding activities, community partnerships and collaborations and orientation sessions, and monitor and evaluate the integration of at least one service-learning project into their classroom curriculum through developing , planning and completing objectives tied directly to their class goals;
5. Assist in monitoring and evaluation (WVDE form) each sub-grantees' student experiences of coordinating and completing a service-learning project of their own design in neighborhood improvement based upon student research of the needs in their community;
6. Work with WVDE to plan, coordinate and operate the annual three-day, statewide Learn & Serve Workshop involving training to students, teachers, administrators, community-based personnel and/or faith-based personnel.
7. Write and compile semi-annual progress reports (WVDE form) and materials for the WV K-12 Service Learning Program as needed.

**Requirements**

Vendor must have a minimum of a Masters degree.

Vendor must have a minimum of five-years experience working with Learn & Serve educational programs.

**Funding**

Position contingent upon receipt of federal funding.

**Cost Proposal**

Vendors are asked to submit an hourly rate computed to include all incidentals such as travel or other reimbursable expenses.

**Terms and Renewal of Contract:**

This contract is to commence upon award by the Purchasing Division and will extend until July 31, 2007. Renewal of this contract shall only occur only after written mutual agreement by both parties and be limited to two one-year renewal periods. Subsequent terms shall extend from August 1 to the following July 31.

**Bid Submission**

As there is only one rate to be established on this contract, to facilitate evaluation of bids, the lowest hourly rate shall be awarded the contract. However, it is the intent of the RFQ that this contract be awarded as an open-ended contract. The actual hours needed for program customization is anticipated to fluctuate and unknown at this time. The vendor's rate will be established as a result of this award, but the quantity of hours will be considered open-ended, to be authorized in advance by the WVDOE, not to exceed 1,040 in any one-year period.

**Verification of Qualifications**

The West Virginia Department of Education plans to hire a service-learning specialist who will monitor, evaluate and provide technical assistance to the WV K-12 Learn and Serve Programs over the next three years. Therefore, the Department is seeking a vendor who possesses experience with the Learn & Serve program. It is preferred the vendor submit verifiable proof of qualifications with their bid response. If not, the agency reserves the right to request this information after the bid opening and the vendor must provide requested information within 48 hours. Failure to provide current educational qualifications may result in disqualification of the vendor's bid.

**Incurring Costs**

The state and any of its employees or officers shall not be held liable for any expenses incurred by any bidder responding to this RFQ for expenses to prepare, deliver the bid, or to attend any meetings, oral presentations or protest hearings.

**Price Quotations**

The price(s) quoted in the bidder's proposal will not be subject to any increase and will be considered firm for the life of the contract.

Any anticipated overhead, support staff, travel expenses, indirect costing of expenses or any other reimbursable expenses must be incorporated into the vendor's fee. No separate payments for these types of expenses will be made, and they shall be considered the sole responsibility of the vendor.

**Evaluation and Award**

The vendor's bid shall consist of a single hourly rate and award will be made to the responsible vendor submitting the lowest hourly rate.

**West Virginia Code §5A-3-10a states:**

No contract or renewal of any contract may be awarded by the state or any of its political subdivisions to any vendor or prospective vendor when the vendor or prospective vendor or a related party to the vendor or prospective vendor is a debtor and the debt owned is an amount greater than one thousand dollars in the aggregate.

**DEFINITIONS:**

“Debt” means any assessment, premium, penalty, fine, tax or other amount of money owed to the state or any of its political subdivisions because of a judgment, fine, permit violation, license assessment, defaulted workers’ compensation premium, penalty or other assessment presently delinquent or due and required to be paid to the state or any of its political subdivisions, including any interest or additional penalties accrued thereon.

“Debtor” means any individual, corporation, partnership, association, limited liability company or any other form or business association owing a debt to the state or any of its political subdivisions.

“Political subdivision” means any county commission; municipality; county board of education; any instrumentality established by a county or municipality; any separate corporation or instrumentality established by one or more counties or municipalities, as permitted by law; or any public body charged by law with the performance of a government function or whose jurisdiction is coextensive with one or more counties or municipalities.

“Related party” means a party, whether an individual, corporation, partnership, association, limited liability company or any other form or business association or other entity whatsoever, related to any vendor by blood, marriage, ownership or contract through which the party has a relationship of ownership or other interest with the vendor so that the party will actually or by effect receive or control a portion of the benefit, profit or other consideration from performance of a vendor contract with the party receiving an amount that meets or exceed five percent of the total contract amount.

**EXCEPTION:**

The prohibition of this section does not apply where a vendor has contested any tax administered pursuant to chapter eleven of this code, workers’ compensation premium, permit fee or environmental fee or assessment and the matter has not become final or where the vendor has entered into a payment plan or agreement and the vendor is not in default of any of the provisions of such plan or agreement.

**LICENSING:**

The vendor must be licensed in accordance with any and all state requirements to do business with the state of West Virginia.

**CONFIDENTIALITY:**

The vendor agrees that he or she will not disclose to anyone, directly or indirectly, any such personally identifiable information or other confidential information gained from the agency, unless the individual who is the subject of the information consents to the disclosure in writing or the disclosure is made pursuant to the agency’s policies, procedures and rules.
