1. Awards will be made in the best interest of the State of West Virginia.
2. The State may accept or reject in part, or in whole, any bid.
3. All quotations are governed by the *West Virginia Code* and the *Legislative Rules* of the Purchasing Division.
4. Prior to any award, the apparent successful vendor must be properly registered with the Purchasing Division and have paid the required \$125.00 registration fee.
5. All services performed or goods delivered under State Purchase Orders/Contracts are to be continued for the term of the Purchase Order/Contract, contingent upon funds being appropriated by the Legislature or otherwise being made available. In the event funds are not appropriated or otherwise available for these services or goods, this Purchase Order/Contract becomes void and of no effect after June 30.
6. Payment may only be made after the delivery and acceptance of goods or services.
7. Interest may be paid for late payment in accordance with the *West Virginia Code*.
8. Vendor preference will be granted upon written request in accordance with the *West Virginia Code*.
9. The State of West Virginia is exempt from federal and state taxes and will not pay or reimburse such taxes.
10. The Director of Purchasing may cancel any Purchase Order/Contract upon 30 days written notice to the seller.
11. The laws of the State of West Virginia and the *Legislative Rules* of the Purchasing Division shall govern all rights and duties under the Contract, including without limitation the validity of this Purchase Order/Contract.

SPECIFICATIONS

The West Virginia Department of Education (WVDOE) is soliciting bids for books recorded onto compact discs (CD) designed to assist students who are blind, dyslexic, or have other diagnosed learning disabilities within the 21 juvenile schools sites operated by the WVDOE through the Office of Institutional Education Programs (OIEP). The goal of this RFQ is to have equipment and services in which books recorded on CD are available to our schools on an as-needed basis, including the capability to add new books in the future.

Minimum Standards:

Our programs are open-entry/open-exit, and many of our students are eligible for special education services. Due to the unique circumstances of enrolling students year round, the WVDOE/OIEP requires a service that has state adopted texts, leisure reading books, and GED texts available on CD. We require a subscription-based or book rental program in order to return books as students exit and enter causing student demographic changes. Purchasing books on CD is not preferred, as it would result in purchasing books that are not used. If quoting a subscription, return postage costs for CD's must be included in the subscription.

The CD player must have the capability to go to a specific page, chapter and/or section and bookmark the location for continuation at a later time. Due to using this player with children identified with special needs, the capability of speeding up or slowing down the voice is required. The player must have a rechargeable battery and accompanying AC adapter in order to cut down on replacement battery costs. The player should resemble a typical compact disc player. This will normalize the experience for special education students.

Accessories for the player must include a six-way adapter in order for six students to listen to the same book for group reading instruction and standard compact headphones. There shall be no material loss of signal strength through the six-way adapter. The "ear bud" styles currently popular with many players will not be acceptable as they pose a sanitation risk in an institution. The large oversized headphones are obtrusive in a classroom setting, as it will draw attention and stigma to special education students. The standard compact headphone is required as it will continue to normalize the experience resembling a typical compact disc player that a child's peer might use to listen to music. Headphones must cover the accepted audible range of the human ear, defined as the range from 20 Hz to 20 Khtz.

Terms of Contract:

The contract term shall be annual, initiated from the date of the purchase order.

Warranty:

Vendor's quote must include a manufacturers warranty of not less than one year in duration.

The price(s) quoted in the bidder's RFQ will not be subject to any increase and will be considered firm for the life of the contract.

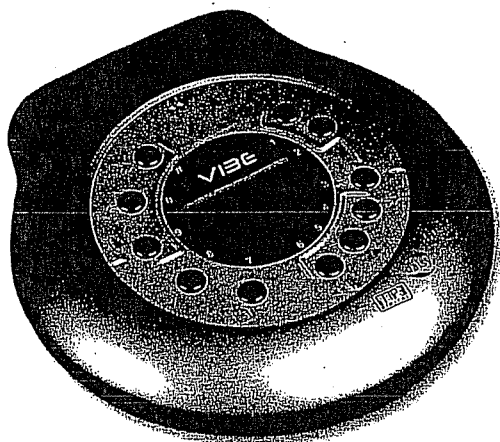

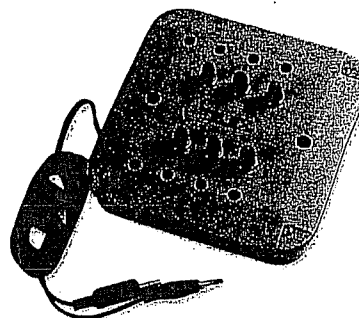

West Virginia Code §5A-3-10a states:

No contract or renewal of any contract may be awarded by the state or any of its political subdivisions to any vendor or prospective vendor when the vendor or prospective vendor or a related party to the vendor or prospective vendor is a debtor and the debt owned is an amount greater than one thousand dollars in the aggregate

DEFINITIONS:

"Debt" means any assessment, premium, penalty, fine, tax or other amount of money owed to the state or any of its political subdivisions because of a judgment, fine, permit violation, license assessment, defaulted workers' compensation premium, penalty or other assessment presently delinquent or due and required to be paid to the state or any of its political subdivisions, including any interest or additional penalties accrued thereon.

"Debtor" means any individual, corporation, partnership, association, limited liability company or any other form or business association owing a debt to the state or any of its political subdivisions. "Political subdivision" means any county commission; municipality; county board of education; any instrumentality established by a county or municipality; any separate corporation or instrumentality established by one or more counties or municipalities, as permitted by law; or any public body charged by law with the performance of a government function or whose jurisdiction is coextensive with one or more counties or municipalities. "Related party" means a party, whether an individual, corporation, partnership, association, limited liability company or any other form or business association or other entity whatsoever, related to any vendor by blood, marriage, ownership or contract through which the party has a relationship of ownership or other interest with the vendor so that the party will actually or by effect receive or control a portion of the benefit, profit or other consideration from performance of a vendor contract with the party receiving an amount that meets or exceed five percent of the total contract amount.

EXCEPTION:

The prohibition of this section does not apply where a vendor has contested any tax administered pursuant to chapter eleven of this code, workers' compensation premium, permit fee or environmental fee or assessment and the matter has not become final or where the vendor has entered into a payment plan or agreement and the vendor is not in default of any of the provisions of such plan or agreement.

LICENSING:

Vendors must be licensed and in good standing in accordance with any and all state and local laws and requirements by any state or local agency of West Virginia, including, but not limited to, the West Virginia Secretary of State's Office, the West Virginia Tax Department, West Virginia Insurance Commission, or any other state agencies or political subdivision. Furthermore, the vendor must provide all necessary releases to obtain information to enable the Director or spending unit to verify that the vendor is licensed and in good standing with the above entities.

CONFIDENTIALITY:

The vendor agrees that he or she will not disclose to anyone, directly or indirectly, any such personally identifiable information or other confidential information gained from the agency, unless the individual who is the subject of the information consents to the disclosure in writing or the disclosure is made pursuant to the agency's policies, procedures and rules.
