REQUEST FOR QUOTATION (RFQ) AND REQUEST FOR PROPOSAL (RFP)**

1. Awards will be made in the best interest of the State of West Virginia.
2. The State may accept or reject in part, or in whole, any bid.
3. All quotations are governed by the *West Virginia Code* and the *Legislative Rules* of the Purchasing Division.
4. Prior to any award, the apparent successful vendor must be properly registered with the Purchasing Division and have paid the required \$125.00 registration fee.
5. All services performed or goods delivered under State Purchase Orders/Contracts are to be continued for the term of the Purchase Order/Contract, contingent upon funds being appropriated by the Legislature or otherwise being made available. In the event funds are not appropriated or otherwise available for these services or goods, this Purchase Order/Contract becomes void and of no effect after June 30.
6. Payment may only be made after the delivery and acceptance of goods or services.
7. Interest may be paid for late payment in accordance with the *West Virginia Code*.
8. Vendor preference will be granted upon written request in accordance with the *West Virginia Code*.
9. The State of West Virginia is exempt from federal and state taxes and will not pay or reimburse such taxes.
10. The Director of Purchasing may cancel any Purchase Order/Contract upon 30 days written notice to the seller.
11. The laws of the State of West Virginia and the *Legislative Rules* of the Purchasing Division shall govern all rights and duties under the Contract, including without limitation the validity of this Purchase Order/Contract.
12. Any reference to automatic renewal is hereby deleted. The Contract may be renewed only upon mutual written agreement of the parties.
13. **BANKRUPTCY:** In the event the vendor/contractor files for bankruptcy protection, this contract is automatically null and void, and is terminated without further order.

Gaymar Isoflex IMR 3584 reflects construction and gel configuration required, subject to specifications following.

SPECIFICATIONS:

Each mattress shall:

- Be manufactured in a FDA approved facility under the Quality System Regulations, 21CFR Part 820 and the facility must have been audited in the past 12 month period
- Be approved by the Fire Marshall of the State of West Virginia prior to the award of the bid
- Meet FDA entrapment safety guidelines, ie: Be HBSW compliant in zones 1-4 when used in conjunction with the Stryker Secure II bed frame sized 35" X 84"
- Provide a minimum of a 10 year non pro-rated warranty on the mattress unit and a minimum of a 5 year non pro-rated warranty on the cover
- Have a mattress cover that is shear resistant and anti-microbial with a minimum of 95% effectiveness in killing methicillin-resistant Staphylococcus aureus infections.
- Have a sloped heel section for the reduction of pressure ulcers on the heel
- Provide in writing, a clinical guarantee program that provides for a minimum of (2) no cost, low pressure air alternative mattresses or overlays for treatment of a pressure ulcer that develops while a resident is utilizing the awarded mattress.
- Have a 500 pound weight capacity

Each bid submission shall have as part of the vendor response copies of all warranties, guarantees, approvals and/or technical information supporting vendor's allegation of compliance with above noted specifications unless exception is noted within the body of the specifications.

LOCATION: Each resident room as per room designation.

DELIVERY: The schedule for receipt of the items shall be no earlier than October 30, 2006 and no later than November 9, 2006 for at least

twenty mattresses and all remaining mattresses to be delivered no later than November 15, 2006. Vendor will contact facility to arrange for actual delivery date and time. The address for delivery shall be One Freedom's Way, Clarksburg, WV 25301. All shipping charges, insurance and/or postage shall be included in the seller's proposal and prepaid by the Vendor.

All pre-delivery check lists, service manuals, product user manuals, and in-service training aids as required are to be delivered to the facility prior to the initial delivery of goods. A pre-delivery meeting shall be scheduled if needed.

INSTALLATION: Vendor is responsible for delivery, set up and disposal of debris associated with shipping of mattresses.

WARRANTY: Documents to reflect above noted specification to be provided to facility prior to delivery.

AFFIDAVIT

West Virginia Code §5A-3-10a states:

No contract or renewal of any contract may be awarded by the state or any of its political subdivisions to any vendor or prospective vendor when the vendor or prospective vendor or a related party to the vendor or prospective vendor is a debtor and the debt owned is an amount greater than one thousand dollars in the aggregate.

DEFINITIONS:

"Debt" means any assessment, premium, penalty, fine, tax or other amount of money owed to the state or any of its political subdivisions because of a judgment, fine, permit violation, license assessment, defaulted workers' compensation premium, penalty or other assessment presently delinquent or due and required to be paid to the state or any of its political subdivisions, including any interest or additional penalties accrued thereon.

"Debtor" means any individual, corporation, partnership, association, limited liability company or any other form or business association owing a debt to the state or any of its political subdivisions.

"Political subdivision" means any county commission; municipality; county board of education; any instrumentality established by a county or municipality; any separate corporation or instrumentality established by one or more counties or municipalities, as permitted by law; or any public body charged by law with the performance of a government function or whose jurisdiction is coextensive with one or more counties or municipalities.

"Related party" means a party, whether an individual, corporation, partnership, association, limited liability company or any other form or business association or other entity whatsoever, related to any vendor by blood, marriage, ownership or contract through which the party has a relationship of ownership or other interest with the vendor so that the party will actually or by effect receive or control a portion of the benefit, profit or other consideration from performance of a vendor contract with the party receiving an amount that meets or exceed five percent of the total contract amount.

EXCEPTION:

The prohibition of this section does not apply where a vendor has contested any tax administered pursuant to chapter eleven of this code, workers' compensation premium, permit fee or environmental fee or assessment and the matter has not become final or where the vendor has entered into a payment plan or agreement and the vendor is not in default of any of the provisions of such plan or agreement.

LICENSING:

The vendor must be licensed in accordance with any and all state requirements to do business with the state of West Virginia.

CONFIDENTIALITY:

The vendor agrees that he or she will not disclose to anyone, directly or indirectly, any such personally identifiable information or other confidential information gained from the agency, unless the individual who is the subject of the information consents to the disclosure in writing or the disclosure is made pursuant to the agency's policies, procedures and rules. Vendors should visit www.state.wv.us/admin/purchase/privacy for the Notice of Agency Confidentiality Policies.

Under penalty of law for false swearing (West Virginia Code, §61-5-3), it is hereby certified that the vendor acknowledges the information in this said affidavit and are in compliance with the requirements as stated.
