- Awards will be made in the best interest of the State of West Virginia.
- 2. The State may accept or reject in part, or in whole, any bid.
- 3. All quotations are governed by the West Virginia Code and the Legislative Rules of the Purchasing Division.
- 4. Prior to any award, the apparent successful vendor must be properly registered with the Purchasing Division and have paid the required \$125.00 registration fee.
- 5. All services performed or goods delivered under State Purchase Orders/Contracts are to be continued for the term of the Purchase Order/Contract, contingent upon funds being appropriated by the Legislature or otherwise being made available. In the event funds are not appropriated or otherwise available for these services or goods, this Purchase Order/Contract becomes void and of no effect after June 30.
- 6. Payment may only be made after the delivery and acceptance of goods or services.
- 7. Interest may be paid for late payment in accordance with the West Virginia Code.
- 8. Vendor preference will be granted upon written request in accordance with the West Virginia Code.
- 9. The State of West Virginia is exempt from federal and state taxes and will not pay or reimburse such taxes.
- 10. The Director of Purchasing may cancel any Purchase Order/Contract upon 30 days written notice to the seller.
- 11. The laws of the State of West Virginia and the *Legislative Rules* of the Purchasing Division shall govern all rights and duties under the Contract, including without limitation the validity of this Purchase Order/Contract.

## SPECIFICATIONS FOR LIQUID HOT WATER CLEANING COMPOUND

1. This specification establishes the requirement for a hot water cleaning compound intended for use in high pressure hot water cleaning machines and which will not discolor in any way aluminum, chrome, and factory painted trucks, cars, and industrial equipment.

#### 2. REQUIREMENTS:

- A. QUALIFICATION: The cleaning compounds furnished under this specification shall be a product which has been tested and has passed the qualification and tests specified.
- B. TEMPERATURE STABILITY: The cleaning compound must not break down in field tests at 210°F and pressure of 100 psi. During the field test it must maintain stability and clean surfaces without spotting or streaking when left in the sun to dry.
- C. STORAGE: The cleaning compound shall not separate, crystalize, no show other visable evidence of deterioration during a 6 month storage period.
- D. FIELD PERFORMANCE TESTS: The tests performed by the Equipment Division of the WV Division of Highways shall consist of field evaluation conducted in accordance with Standard Operation Procedures on the following:
  - One enamel painted piece of industrial equipment. Must clean exterior satisfactorily.
  - (2) One car, factory painted with acrylic. Must clean exterior and not streak after being rinsed with cold water.
  - (3) One dump truck. Steam clean exterior, undercarriage, engine and engine compartment. Must remove dirt, mud, salt, calcium, grease, etc.
  - (4) One chemical spreader. Must remove salt, calcium, hydraulic oil and grease.
  - (5) One crawler tractor. Steam clean exterior, undercarriage, tracks, track frames, engine and engine compartment. Must remove mud, hydraulic oil, engine oil, grease, etc.

E. MATERIALS: The materials used in the manufacture of of the cleaning compound shall be of high quality, suitable for the purpose intended and when finally compounded shall form a sediment-free hot water cleaning compound meeting the requirements of this specification. All anionic and nonionic compounds shall be at least 80 percent biodegradable. The material shall contain at least 12% active solids.

### F. LABORATORY TESTING:

- (1) The Ph of the material shall be at least 8.0 when tested in accordance with ASTM D1172.
- (2) The material shall retain its original uniformity after three freeze-thaw cycles. The material, as recieved, shall be placed in a freezer a 0 ± 5° F overnight, allowed to stand at room temperature during the day. This shall be performed on three consecutice days. The test material shall not separate into distinct layers.
- (3) The product when diluted as per manufacturer's instructions, shall be instantly soluble in water and shall no become cloudy or precipitate.
- G. The manufacturer shall provide certification for the 80% biodegradable and active solids contents.
- 3. ACCEPTANCE SAMPLING: For the purpose of acceptance, the State may take samples at random from each shipment of cleaning compound. These samples will be taken by Department personnel for testing purposes prior to delivery. A one gallon sample will be required.
- 4. Material to be stored for shippment in 55 gallon metal drums, or plastic drums.
  - A. Drums are to be <u>NEW</u> not reconditioned
  - B. Drums shall be 20-18 gauge steel

# STATE OF WEST VIRGINIA Purchasing Division

## **PURCHASING AFFIDAVIT**

West Virginia Code §5A-3-10a states: No contract or renewal of any contract may be awarded by the state or any of its political subdivisions to any vendor or prospective vendor when the vendor or prospective vendor or a related party to the vendor or prospective vendor is a debtor and the debt owned is an amount greater than one thousand dollars in the aggregate

#### **DEFINITIONS:**

"Debt" means any assessment, premium, penalty, fine, tax or other amount of money owed to the state or any of its political subdivisions because of a judgment, fine, permit violation, license assessment, defaulted workers' compensation premium, penalty or other assessment presently delinquent or due and required to be paid to the state or any of its political subdivisions, including any interest or additional penalties accrued thereon.

"Debtor" means any individual, corporation, partnership, association, limited liability company or any other form or business association owing a debt to the state or any of its political subdivisions. "Political subdivision" means any county commission; municipality; county board of education; any instrumentality established by a county or municipality; any separate corporation or instrumentality established by one or more counties or municipalities, as permitted by law; or any public body charged by law with the performance of a government function or whose jurisdiction is coextensive with one or more counties or municipalities. "Related party" means a party, whether an individual, corporation, partnership, association, limited liability company or any other form or business association or other entity whatsoever, related to any vendor by blood, marriage, ownership or contract through which the party has a relationship of ownership or other interest with the vendor so that the party will actually or by effect receive or control a portion of the benefit, profit or other consideration from performance of a vendor contract with the party receiving an amount that meets or exceed five percent of the total contract amount.

**EXCEPTION:** The prohibition of this section does not apply where a vendor has contested any tax administered pursuant to chapter eleven of this code, workers' compensation premium, permit fee or environmental fee or assessment and the matter has not become final or where the vendor has entered into a payment plan or agreement and the vendor is not in default of any of the provisions of such plan or agreement.

**LICENSING:** Vendors must be licensed and in good standing in accordance with any and all state and local laws and requirements by any state or local agency of West Virginia, including, but not limited to, the West Virginia Secretary of State's Office, the West Virginia Tax Department, West Virginia Insurance Commission, or any other state agencies or political subdivision. Furthermore, the vendor must provide all necessary releases to obtain information to enable the Director or spending unit to verify that the vendor is licensed and in good standing with the above entities.

**CONFIDENTIALITY:** The vendor agrees that he or she will not disclose to anyone, directly or indirectly, any such personally identifiable information or other confidential information gained from the agency, unless the individual who is the subject of the information consents to the disclosure in writing or the disclosure is made pursuant to the agency's policies, procedures and rules. Vendors should visit **www.state.wv.us/admin/purchase/privacy** for the Notice of Agency Confidentiality Policies.
