- 1. Awards will be made in the best interest of the State of West Virginia.
- 2. The State may accept or reject in part, or in whole, any bid.
- 3. All quotations are governed by the West Virginia Code and the Legislative Rules of the Purchasing Division.
- 4. Prior to any award, the apparent successful vendor must be properly registered with the Purchasing Division and have paid the required \$125.00 registration fee.
- 5. All services performed or goods delivered under State Purchase Orders/Contracts are to be continued for the term of the Purchase Order/Contract, contingent upon funds being appropriated by the Legislature or otherwise being made available. In the event funds are not appropriated or otherwise available for these services or goods, this Purchase Order/Contract becomes void and of no effect after June 30.
- 6. Payment may only be made after the delivery and acceptance of goods or services.
- 7. Interest may be paid for late payment in accordance with the West Virginia Code.
- 8. Vendor preference will be granted upon written request in accordance with the West Virginia Code.
- 9. The State of West Virginia is exempt from federal and state taxes and will not pay or reimburse such taxes.
- 10. The Director of Purchasing may cancel any Purchase Order/Contract upon 30 days written notice to the seller.
- 11. The laws of the State of West Virginia and the *Legislative Rules* of the Purchasing Division shall govern all rights and duties under the Contract, including without limitation the validity of this Purchase Order/Contract.

- A. Site: The attached schematic is an approximation provided for general information (See Attachment 1). The awarded contractor will be responsible for field measuring all distances and surveyor support as needed. These specifications include reference to Standard Technical Design (STD) Number 872-90-15 from the Omaha Nebraska District of the US Army Corps of Engineer and dated 03/17/2004 which is provided as attachment 2 and excerpted below for convenience; the STD has precedence if a conflict exists.
- B. Cables shall be continuous from deadman to deadman. No splices in cable shall be allowed. Cable barrier shall be US domestic ¾ inch 6X19 class wire rope, regular lay, extra improved plow steel (EIPS), independent wire rope core (1WRC), Class A galvanized, in accordance with (IAW) ASTM F1145. Wire rope clamps shall be Type 1, Class 1, galvanized, IAW FS FF-C-450.
- C. U-bolts on line posts shall be installed perpendicular to the strand of the wire rope and shall be tightened after sag in cable barrier has been removed. U-bolts and hex nuts shall be ½ inch galvanized IAW ASTM A307 and ASTM A563.
- D. Brace panels with deadmen shall be spaced at 200 foot maximum interval and at changes in alignment exceeding 45 degrees. Threaded rods shall be  $1 \frac{1}{4}$  inch galvanized IAW ASTM A307 or A36. Welded brace rails shall be installed as per the plans and AWS D1.1 (structural welding code steel) at corner, end, gate, and pull posts. Damage to galvanized surface shall be repair IAW AWS WZC.
- E. The contractor is reponsible for coordinating for material storage which is limited at this site.
- F. The contractor may need to coordinate with the County for traffic control on Coonskin Drive due to constrained workspace.
- G. The contractor will seed, fertilize, and mulch all disturbed areas and will submit fertilizer and seed content for approval prior to application.

I. Liqidated Damages: Liquidated damages shall be imposed at the rate of \$1,345.13 per day each day after failing to meet the contracted completion date. 






DEADMAN ANCHOR BOLT DETAI



## STATE OF WEST VIRGINIA Purchasing Division

### **PURCHASING AFFIDAVIT**

West Virginia Code §5A-3-10a states: No contract or renewal of any contract may be awarded by the state or any of its political subdivisions to any vendor or prospective vendor when the vendor or prospective vendor or a related party to the vendor or prospective vendor is a debtor and the debt owed is an amount greater than one thousand dollars in the aggregate

#### **DEFINITIONS:**

"Debt" means any assessment, premium, penalty, fine, tax or other amount of money owed to the state or any of its political subdivisions because of a judgment, fine, permit violation, license assessment, defaulted workers' compensation premium, penalty or other assessment presently delinquent or due and required to be paid to the state or any of its political subdivisions, including any interest or additional penalties accrued thereon.

"Debtor" means any individual, corporation, partnership, association, limited liability company or any other form or business association owing a debt to the state or any of its political subdivisions. "Political subdivision" means any county commission; municipality; county board of education; any instrumentality established by a county or municipality; any separate corporation or instrumentality established by one or more counties or municipalities, as permitted by law; or any public body charged by law with the performance of a government function or whose jurisdiction is coextensive with one or more counties or municipalities. "Related party" means a party, whether an individual, corporation, partnership, association, limited liability company or any other form or business association or other entity whatsoever, related to any vendor by blood, marriage, ownership or contract through which the party has a relationship of ownership or other interest with the vendor so that the party will actually or by effect receive or control a portion of the benefit, profit or other consideration from performance of a vendor contract with the party receiving an amount that meets or exceed five percent of the total contract amount.

**EXCEPTION:** The prohibition of this section does not apply where a vendor has contested any tax administered pursuant to chapter eleven of this code, workers' compensation premium, permit fee or environmental fee or assessment and the matter has not become final or where the vendor has entered into a payment plan or agreement and the vendor is not in default of any of the provisions of such plan or agreement.

LICENSING: Vendors must be licensed and in good standing in accordance with any and all state and local laws and requirements by any state or local agency of West Virginia, including, but not limited to, the West Virginia Secretary of State's Office, the West Virginia Tax Department, West Virginia Insurance Commission, or any other state agencies or political subdivision. Furthermore, the vendor must provide all necessary releases to obtain information to enable the Director or spending unit to verify that the vendor is licensed and in good standing with the above entities.

**CONFIDENTIALITY:** The vendor agrees that he or she will not disclose to anyone, directly or indirectly, any such personally identifiable information or other confidential information gained from the agency, unless the individual who is the subject of the information consents to the disclosure in writing or the disclosure is made pursuant to the agency's policies, procedures and rules. Vendors should visit **www.state.wv.us/admin/purchase/privacy** for the Notice of Agency Confidentiality Policies.
