## GENERAL TERMS & CONDITIONS REQUEST FOR QUOTATION (RFQ) AND REQUEST FOR PROPOSAL (RFP)

- 1. Awards will be made in the best interest of the State of West Virginia.
- 2. The State may accept or reject in part, or in whole, any bid.
- 3. All quotations are governed by the West Virginia Code and the Legislative Rules of the Purchasing Division.
- 4. Prior to any award, the apparent successful vendor must be properly registered with the Purchasing Division and have paid the required \$125.00 registration fee.
- 5. All services performed or goods delivered under State Purchase Orders/Contracts are to be continued for the term of the Purchase Order/Contract, contingent upon funds being appropriated by the Legislature or otherwise being made available. In the event funds are not appropriated or otherwise available for these services or goods, this Purchase Order/Contract becomes void and of no effect after June 30.
- 6. Payment may only be made after the delivery and acceptance of goods or services.
- 7. Interest may be paid for late payment in accordance with the West Virginia Code.
- 8. Vendor preference will be granted upon written request in accordance with the West Virginia Code.
- 9. The State of West Virginia is exempt from federal and state taxes and will not pay or reimburse such taxes.
- 10. The Director of Purchasing may cancel any Purchase Order/Contract upon 30 days written notice to the seller.
- 11. The laws of the State of West Virginia and the Legislative Rules of the Purchasing Division shall govern all rights and duties under the Contract, including without limitation the validity of this Purchase Order/Contract.
- 12. Any reference to automatic renewal is hereby deleted. The Contract may be renewed only upon mutual written agreement of the parties.
- 13. BANKRUPTCY: In the event the vendor/contractor files for bankruptcy protection, this Contract may be deemed null and void, and terminated without further order.
- 14. HIPAA Business Associate Addendum The West Viginia State Government HIPAA Business Associate Addendum (BAA), approved by the Attorney General, and available online at the Purchasing Division's web site (http://www.state.wv.us/admin/purchase/vrc/hipaa.htm) is hereby made part of the agreement. Provided that, the Agency meets the definition of a Covered Entity (45 CFR §160.103) and will be disclosing Protected Health Information (45 CFR §160.103) to the vendor.

#### **INSTRUCTIONS TO BIDDERS**

- 1. Use the quotation forms provided by the Purchasing Division.
- 2. SPECIFICATIONS: Items offered must be in compliance with the specifications. Any deviation from the specifications must be clearly indicated by the bidder. Alternates offered by the bidder as EQUAL to the specifications must be clearly defined. A bidder offering an alternate should attach complete specifications and literature to the bid. The Purchasing Division may waive minor deviations to specifications.
- 3. Complete all sections of the quotation form.
- 4. Unit prices shall prevail in cases of discrepancy.
- 5. All quotations are considered F.O.B. destination unless alternate shipping terms are clearly identified in the quotation.
- 6. BID SUBMISSION: All quotations must be delivered by the bidder to the office listed below prior to the date and time of the bid opening. Failure of the bidder to deliver the quotations on time will result in bid disqualifications.

#### CORRECTIONS TO CONSTRUCTION SPECIFICATIONS

Add to Specification  $5.1 - 2^{nd}$  paragraph – "This plan shall include a copy of the reclamation plan showing the location of the Contractor's proposed sediment control measures."

Add Specification "6.2.4.4 Soil Cover – Soil cover shall consist of a six (6) inch thick layer of suitable soil material capable of supporting vegetation."

Change Specification 10.3.3 Asphalt – Last sentence now reads "The area shall be paved with the two-inch overlay". The sentence shall be changed to read "The area shall be paved with the one-inch overlay".

Change Specification 12.2.1 Pump House – The first sentence now reads "Materials to repair damage done by the Contractor to the pump shall consist of better than or equal to existing materials." The sentence shall be changed to read "Materials to repair damage done by the Contractor to the pump house shall consist of better than or equal to existing materials."

#### CORRECTIONS TO DESIGN DRAWINGS

Sheet 6 – Section A-A shall be changed to Section B-B and Section B-B shall be changed to Section A-A.

### QUESTIONS ASKED AT PUMPHOUSE AREA

Q: Does this structure (lean to) get rebuilt?

A: This structure is to be repaired to a better than or equal to condition as specified in Section 12 of the Construction Specifications.

Q: The whole structure?

A: If the whole structure is damaged, it will be necessary to rebuild according to Section 12 of the Construction Specifications and according to the Design Drawings.

Q: So the shed (lean to) will be smaller?

A: Yes, according to the Construction Specifications and the Design Drawings.

Q: If the back half of the lean to is removed, does it have to be added anywhere? A: No, it is to be repaired according to the Construction Specifications and Design Drawings.

Q: Question asked to landowner (Mr. Merincil) –Is that (mine portal) where you are getting your water from now?

A: Water from the mine portal is used for the pool. The main water supply is from a nearby well. There are two pumps in the pump house.

Q: Question asked to landowner – Do you drink the water from the portal.

A: No, that water is not fit for consumption.

Q: Will the Contractor have to furnish water to the resident while working on the pumphouse site?

A: Yes.

Q: Where does the power come into the pump?

A: There is an electric line that comes from the direction of the home.

Q: Is the mine directly behind the pump house?

A: Yes, as shown on the Design Drawings.

## Page 3 of 4 of Attachment

Q: So we are supposed to build a pump house and construct a mine seal behind the new pumphouse?

A: The pump house will be moved out from in front of the mine seal.

Q: Question asked to the landowner – Do you have a diagram of how all that fits together (wiring, pumps, fixtures inside the pump house)?

A: No. This pump house was here when the I (the resident) moved in.

Q: Question asked to the landowner – Are there water filters in here?

A: Yes.

Q: Question asked to the landowner – Are you using the water filters.

A: Resident responded that he uses the sand filters.

Q: Question asked to the landowner – Can the Contractor work with you on what needs to be replaced?

A: Resident responded "Yes".

Q: All this stuff under the lean to, will the Contractor be required to remove it? (Refers to personal items stored by the landowner.)

A: The resident responded that he will have the items removed before the Contractor moves in.

## QUESTIONS ASKED AT ROCK OVERHANG AREA

Q: What does the wall look like?

A: The wall details are shown on the Design Drawings.

Q: Is the wall a straight wall?

A: The wall details are shown on the Design Drawings.

Q: How far is the footer to be excavated?

A: The proposed excavation is shown on the Design Drawings.

Q: Is the footer to be excavated to the mine floor?

A: No. Only to the level shown on the Design Drawings.

Q: Is the footer to be built directly under the rock?

A: Yes, as is shown on the Design Drawings.

Q: How far down is the bottom of the footer?

A: The bottom of the footer is shown on the Design Drawings.

Q: Will the Contractor have to get the electric company to come out to relocate the guy wires?

A: All utility work shall be done according to Section 9.0 "Utilities" of the Construction Specifications.

## QUESTIONS ASKED AT THE TWO MINE SEALS

Q: Does the Contractor have to burn the trees?

A: The burning and stockpiling of marketable trees is specified in Section 4.0 "Site Prep" of the Construction Specifications.

Q: Can the Contractor use the yard to stockpile materials? (Outside construction limits) A: The Contractor will be responsible for getting agreements with landowners to

stockpile materials for any areas outside the construction limits.

## QUESTIONS ASKED AT DROP INLET AREA

Q: Where are the 1" asphalt overlay areas?

A: The 1" ashpalt overlay areas are shown on the Design Drawings.

Q: Is the Contractor required to start the drainage construction at the discharge end of the road crossing and construct up the hill to the mine portals?

A: Yes, the drainage must be in place prior to opening the mine portals.

Q: How many manholes are to be installed?

A: The manhole locations are shown on the Construction Drawings.
