1. Awards will be made in the best interest of the State of West Virginia.
2. The State may accept or reject in part, or in whole, any bid.
3. All quotations are governed by the *West Virginia Code* and the *Legislative Rules* of the Purchasing Division.
4. Prior to any award, the apparent successful vendor must be properly registered with the Purchasing Division and have paid the required \$125.00 registration fee.
5. All services performed or goods delivered under State Purchase Orders/Contracts are to be continued for the term of the Purchase Order/Contract, contingent upon funds being appropriated by the Legislature or otherwise being made available. In the event funds are not appropriated or otherwise available for these services or goods, this Purchase Order/Contract becomes void and of no effect after June 30.
6. Payment may only be made after the delivery and acceptance of goods or services.
7. Interest may be paid for late payment in accordance with the *West Virginia Code*.
8. Vendor preference will be granted upon written request in accordance with the *West Virginia Code*.
9. The State of West Virginia is exempt from federal and state taxes and will not pay or reimburse such taxes.
10. The Director of Purchasing may cancel any Purchase Order/Contract upon 30 days written notice to the seller.
11. The laws of the State of West Virginia and the *Legislative Rules* of the Purchasing Division shall govern all rights and duties under the Contract, including without limitation the validity of this Purchase Order/Contract.
12. Any reference to automatic renewal is hereby deleted. The Contract may be renewed only upon mutual written agreement of the parties.
13. **BANKRUPTCY:** In the event the vendor/contractor files for bankruptcy protection, this contract is automatically null and void, and is terminated without further order.

DPS0804 - POSTAGE METER REQUEST FOR QUOTATION

The West Virginia State Police are soliciting competitive bids for a lease/purchase agreement for a postage machine to be located at the State Police Headquarters mail room. This is located at 725 Jefferson Road, South Charleston, WV. Vendors do not need to be a registered vendor to submit a bid for this lease. However, the apparent low bidder that meets the minimum specifications must register with the State of WV before being awarded the bid and pay the \$125.00 Vendor registration fee.

GENERAL:

This machine *must* be a Pitney Bowes DM900 digital mailing system *or equal*.

SPECIFICATIONS:

The machine *must* meet the following specifications:

- Be equipped with an automatic feed capability that processes a minimum of 240 pieces of mail per minute.
- Mailing system must be a digital machine capable of handling large volumes of mail as well as packages up to 30 lbs.
- Mailing machine must be capable of processing up to a minimum of 110 mixed weight pieces per minute in a single operation.
- Capability of handling mail up to 3/4 inch thick, sealed or unsealed.
- Auto oversize feature that identifies mail requiring a surcharge based on size including the new shape based rate.
- Capability of Differential weighing.
- Moistener capability to seal envelopes
- 25 Department Accounting.
- Drop stacker
- Digital Inkjet printing.
- Capability of adding postage by phone with no additional fees or charges.
- Access to postage 24/7 with one-touch postage resets.
- Software capable to handle postage rate changes to be downloaded to meter.
- Removable meter head for resetting postage or downloading rates and software.
- Option to electronically process USPS special services at a later date, i.e. certified mail, signature confirmation and delivery confirmation without an extra computer.

SERVICES:

This lease *will* include the following to be provided by the vendor.

- All required maintenance on the mail machine or any component of same will be the responsibility of the vendor at no additional cost to the WV State Police.
- Emergency maintenance to the machine will be provided by the vendor within 24 hours of notification by the WVSP.
- Vendor will provide all software updates at no additional cost to the WVSP.
- Vendor will include any and all fees that would cause an increase amount in the amount quoted, aside from consumable supplies which will be purchased by the WVSP.

LENGTH OF LEASE:

The vendor *will* provide pricing for a 60 month lease.

TRAINING AND INSTALLATION:

Vendor *will* install any and all equipment at no cost to the WVSP.

Vendor *will* provide training to WVSP Personnel in the operation of the mail machine.

PURCHASING AFFIDAVIT

West Virginia Code §5A-3-10a states: No contract or renewal of any contract may be awarded by the state or any of its political subdivisions to any vendor or prospective vendor when the vendor or prospective vendor or a related party to the vendor or prospective vendor is a debtor and the debt owned is an amount greater than one thousand dollars in the aggregate

DEFINITIONS:

“Debt” means any assessment, premium, penalty, fine, tax or other amount of money owed to the state or any of its political subdivisions because of a judgment, fine, permit violation, license assessment, defaulted workers’ compensation premium, penalty or other assessment presently delinquent or due and required to be paid to the state or any of its political subdivisions, including any interest or additional penalties accrued thereon.

“Debtor” means any individual, corporation, partnership, association, limited liability company or any other form or business association owing a debt to the state or any of its political subdivisions. “Political subdivision” means any county commission; municipality; county board of education; any instrumentality established by a county or municipality; any separate corporation or instrumentality established by one or more counties or municipalities, as permitted by law; or any public body charged by law with the performance of a government function or whose jurisdiction is coextensive with one or more counties or municipalities. “Related party” means a party, whether an individual, corporation, partnership, association, limited liability company or any other form or business association or other entity whatsoever, related to any vendor by blood, marriage, ownership or contract through which the party has a relationship of ownership or other interest with the vendor so that the party will actually or by effect receive or control a portion of the benefit, profit or other consideration from performance of a vendor contract with the party receiving an amount that meets or exceed five percent of the total contract amount.

EXCEPTION: The prohibition of this section does not apply where a vendor has contested any tax administered pursuant to chapter eleven of this code, workers’ compensation premium, permit fee or environmental fee or assessment and the matter has not become final or where the vendor has entered into a payment plan or agreement and the vendor is not in default of any of the provisions of such plan or agreement.

LICENSING: Vendors must be licensed and in good standing in accordance with any and all state and local laws and requirements by any state or local agency of West Virginia, including, but not limited to, the West Virginia Secretary of State’s Office, the West Virginia Tax Department, West Virginia Insurance Commission, or any other state agencies or political subdivision. Furthermore, the vendor must provide all necessary releases to obtain information to enable the Director or spending unit to verify that the vendor is licensed and in good standing with the above entities.

CONFIDENTIALITY: The vendor agrees that he or she will not disclose to anyone, directly or indirectly, any such personally identifiable information or other confidential information gained from the agency, unless the individual who is the subject of the information consents to the disclosure in writing or the disclosure is made pursuant to the agency’s policies, procedures and rules. Vendors should visit www.state.wv.us/admin/purchase/privacy for the Notice of Agency Confidentiality Policies.

Under penalty of law for false swearing (West Virginia Code, §61-5-3), it is hereby certified that the vendor acknowledges the information in this said affidavit and are in compliance with the requirements as stated.
