1. Awards will be made in the best interest of the State of West Virginia.
2. The State may accept or reject in part, or in whole, any bid.
3. All quotations are governed by the *West Virginia Code* and the *Legislative Rules* of the Purchasing Division.
4. Prior to any award, the apparent successful vendor must be properly registered with the Purchasing Division and have paid the required \$125.00 registration fee.
5. All services performed or goods delivered under State Purchase Orders/Contracts are to be continued for the term of the Purchase Order/Contract, contingent upon funds being appropriated by the Legislature or otherwise being made available. In the event funds are not appropriated or otherwise available for these services or goods, this Purchase Order/Contract becomes void and of no effect after June 30.
6. Payment may only be made after the delivery and acceptance of goods or services.
7. Interest may be paid for late payment in accordance with the *West Virginia Code*.
8. Vendor preference will be granted upon written request in accordance with the *West Virginia Code*.
9. The State of West Virginia is exempt from federal and state taxes and will not pay or reimburse such taxes.
10. The Director of Purchasing may cancel any Purchase Order/Contract upon 30 days written notice to the seller.
11. The laws of the State of West Virginia and the *Legislative Rules* of the Purchasing Division shall govern all rights and duties under the Contract, including without limitation the validity of this Purchase Order/Contract.
12. Any reference to automatic renewal is hereby deleted. The Contract may be renewed only upon mutual written agreement of the parties.
13. **BANKRUPTCY:** In the event the vendor/contractor files for bankruptcy protection, this Contract may be deemed null and void, and terminated without further order.

The West Virginia Office of Technology (WVOT) provides account management services for the Executive Branch of State government. We are requesting quotes for software that provides for the administration of accounts and groups in Microsoft Active Directory. The system shall also provide for the recovery of objects in Microsoft Active Directory.

Requirements of the system shall include:

- Vendor must supply a Commercial-Off-the-Shelf (COTS) application. No custom applications will be considered.
- Vendor's product solution, at a minimum, must include both "Quest's Active Roles Server 6.0" OR EQUAL, and "Quest's Recovery Manager for Active Directory" OR EQUAL. It is the sole authority of WVOT technical staff to determine what constitutes "or equal."
- Vendor's product must be delivered for installation within three (3) weeks of receiving the purchase order.
- Vendor's solution must provide the following:
- Automated provisioning of users that follow a set of defined rules/steps.
 - Includes account creation with the ability to generate pre-defined attributes.
 - Includes Exchange mailbox creation.
 - Includes resource provisioning.
 - Offers delegation of provisioning process.
- Automated re-provisioning of user accounts for change within State government.
 - Delegation of re-provisioning process.
- Automated de-provisioning of user accounts.
 - Delegation of de-provisioning process.
- Ability to interface with data sources so that Active Directory can be updated automatically. Data sources must include comma delimited text files and Microsoft SQL server.
- Must provide a web based self-service interface for modifying information identified by WVOT as being managed by end-users.
- Allows customization of the web based interface.
- Provide centralized audit logs on all Active Directory related actions.
- Must be scalable to allow for load distribution.
- Must be fault tolerant.
- Shall not rely on native Active Directory permissions of the user performing an action through the software, eliminating uncontrolled access through native tools.
- Allows the use of dynamic group membership based on attributes defined by WVOT staff.
- Provides automated compliance of values stored in attributes based on rule sets defined by WVOT staff.

- Ability to define and utilize custom attributes without the need to extend Active Directory schema.
- Vendor must provide a full set of specifications for all hardware required to implement the solution.
- Vendor shall have been in business for a minimum of five (5) years.
- Vendor must present an implementation plan for the State's approval and work with WVOT staff during initial design and setup.
- Vendor's bid must include on-site training for up to five (5) individuals on administration and maintenance of the system.
- Vendor's solution shall include the ability for online recovery of Active Directory objects, and must allow for restoration of individual attributes on objects as well.

PURCHASING AFFIDAVIT

West Virginia Code §5A-3-10a states: No contract or renewal of any contract may be awarded by the state or any of its political subdivisions to any vendor or prospective vendor when the vendor or prospective vendor or a related party to the vendor or prospective vendor is a debtor and the debt owed is an amount greater than one thousand dollars in the aggregate

DEFINITIONS:

“Debt” means any assessment, premium, penalty, fine, tax or other amount of money owed to the state or any of its political subdivisions because of a judgment, fine, permit violation, license assessment, defaulted workers’ compensation premium, penalty or other assessment presently delinquent or due and required to be paid to the state or any of its political subdivisions, including any interest or additional penalties accrued thereon.

“Debtor” means any individual, corporation, partnership, association, limited liability company or any other form or business association owing a debt to the state or any of its political subdivisions. “Political subdivision” means any county commission; municipality; county board of education; any instrumentality established by a county or municipality; any separate corporation or instrumentality established by one or more counties or municipalities, as permitted by law; or any public body charged by law with the performance of a government function or whose jurisdiction is coextensive with one or more counties or municipalities. “Related party” means a party, whether an individual, corporation, partnership, association, limited liability company or any other form or business association or other entity whatsoever, related to any vendor by blood, marriage, ownership or contract through which the party has a relationship of ownership or other interest with the vendor so that the party will actually or by effect receive or control a portion of the benefit, profit or other consideration from performance of a vendor contract with the party receiving an amount that meets or exceed five percent of the total contract amount.

EXCEPTION: The prohibition of this section does not apply where a vendor has contested any tax administered pursuant to chapter eleven of this code, workers’ compensation premium, permit fee or environmental fee or assessment and the matter has not become final or where the vendor has entered into a payment plan or agreement and the vendor is not in default of any of the provisions of such plan or agreement.

LICENSING: Vendors must be licensed and in good standing in accordance with any and all state and local laws and requirements by any state or local agency of West Virginia, including, but not limited to, the West Virginia Secretary of State’s Office, the West Virginia Tax Department, West Virginia Insurance Commission, or any other state agencies or political subdivision. Furthermore, the vendor must provide all necessary releases to obtain information to enable the Director or spending unit to verify that the vendor is licensed and in good standing with the above entities.

CONFIDENTIALITY: The vendor agrees that he or she will not disclose to anyone, directly or indirectly, any such personally identifiable information or other confidential information gained from the agency, unless the individual who is the subject of the information consents to the disclosure in writing or the disclosure is made pursuant to the agency’s policies, procedures and rules. Vendors should visit www.state.wv.us/admin/purchase/privacy for the Notice of Agency Confidentiality Policies.

Under penalty of law for false swearing (West Virginia Code, §61-5-3), it is hereby certified that the vendor acknowledges the information in this said affidavit and are in compliance with the requirements as stated.
