- 1. Awards will be made in the best interest of the State of West Virginia.
- 2. The State may accept or reject in part, or in whole, any bid.
- 3. All quotations are governed by the West Virginia Code and the Legislative Rules of the Purchasing Division.
- 4. Prior to any award, the apparent successful vendor must be properly registered with the Purchasing Division and have paid the required \$125.00 registration fee.
- 5. All services performed or goods delivered under State Purchase Orders/Contracts are to be continued for the term of the Purchase Order/Contract, contingent upon funds being appropriated by the Legislature or otherwise being made available. In the event funds are not appropriated or otherwise available for these services or goods, this Purchase Order/Contract becomes void and of no effect after June 30.
- 6. Payment may only be made after the delivery and acceptance of goods or services.
- 7. Interest may be paid for late payment in accordance with the West Virginia Code.
- 8. Vendor preference will be granted upon written request in accordance with the West Virginia Code.
- 9. The State of West Virginia is exempt from federal and state taxes and will not pay or reimburse such taxes.
- 10. The Director of Purchasing may cancel any Purchase Order/Contract upon 30 days written notice to the seller.
- 11. The laws of the State of West Virginia and the *Legislative Rules* of the Purchasing Division shall govern all rights and duties under the Contract, including without limitation the validity of this Purchase Order/Contract.
- **12.** Any reference to automatic renewal is hereby deleted. The Contract may be renewed only upon mutual written agreement of the parties.
- **13. BANKRUPTCY:** In the event the vendor/contractor files for bankruptcy protection, this Contract may be deemed null and void, and terminated without further order.
- 14. Request for Bids

The West Virginia Public Service Commission is seeking bids to supply and install a Multimedia Presentation System for its Main Hearing Room in the main building located at 201 Brooks Street in Charleston. This system shall include an advanced audio system, cameras, displays, control system and outputs for live audio/video streaming.

The project shall include delivery, installation, removal of packing material, cabling or other parts required, custom software and quick response for any technical issues during the warranty period.

Due to the limited space and access above the ceiling all cabling shall be kept to a minimum and be as efficient as possible. All cabling shall be above the ceiling or in the walls (there shall be no exposed wiring). Any modifications shall be approved by the state's representative before installation.

Technical Description

Displays

Audio System

One of the primary goals of the project is to greatly enhance the quality of the room audio. The successful vendor shall replace all existing speakers with high quality two-way speakers. Additionally, the speakers shall be divided into at least six zones. These zones will cause the audio to be attenuated when a microphone is operated in that particular zone in order to provide better feedback control and more audio volume. All audio signaling, mixing and processing shall be in digital format. No analog devices (except for amplifiers and wireless microphone system) will be accepted.

These zones shall include:

Presentation Switching and Cameras for Streaming

The system shall include switching for composite video and RGB (VGA) signals. This switching will occur automatically for streaming. Manual control shall be provided by a wireless touch panel or via "e-Control".

Cameras provided shall be high resolution, mini-dome, variable lens type. Cameras shall operate using 24 volt AC power. Other Considerations

The successful vendor shall be required to remove all existing equipment and cabling from the existing equipment rack cabinet (equipment is to be set aside for proper disposal to state surplus property) and conduits, as well as providing AC power distribution as needed inside the cabinet.

The system shall include a UPS for all critical components.

All cabling used above the ceiling shall be plenum fire rated. Penetration of any walls above the ceiling shall require fire stop sealant.

Because of the limitations of the room construction and conduits, all cabling shall be UTP type cabling.

"Related party" means a party, whether an individual, corporation, partnership, association, limited liability company or any other form or business association or other entity whatsoever, related to any vendor by blood, marriage, ownership or contract through which the party has a relationship of ownership or other interest with the vendor so that the party will actually or by effect receive or control a portion of the benefit, profit or other consideration from performance of a vendor contract with the party receiving an amount that meets or exceed five percent of the total contract amount.

EXCEPTION: The prohibition of this section does not apply where a vendor has contested any tax administered pursuant to chapter eleven of this code, workers' compensation premium, permit fee or environmental fee or assessment and the matter has not become final or where the vendor has entered into a payment plan or agreement and the vendor is not in default of any of the provisions of such plan or agreement.

LICENSING: Vendors must be licensed and in good standing in accordance with any and all state and local laws and requirements by any state or local agency of West Virginia, including, but not limited to, the West Virginia Secretary of State's Office, the West Virginia Tax Department, West Virginia Insurance Commission, or any other state agencies or political subdivision. Furthermore, the vendor must provide all necessary releases to obtain information to enable the Director or spending unit to verify that the vendor is licensed and in good standing with the above entities.

CONFIDENTIALITY: The vendor agrees that he or she will not disclose to anyone, directly or indirectly, any such personally identifiable information or other confidential information gained from the agency, unless the individual who is the subject of the information consents to the disclosure in writing or the disclosure is made pursuant to the agency's policies, procedures and rules. Vendors should visit **www.state.wv.us/admin/purchase/privacy** for the Notice of Agency Confidentiality Policies.
