GENERAL TERMS & CONDITIONS REQUEST FOR QUOTATION (RFQ) AND REQUEST FOR PROPOSAL (RFP)

- 1. Awards will be made in the best interest of the State of West Virginia.
- The State may accept or reject in part, or in whole, any bid.
- 3. All quotations are governed by the West Virginia Code and the Legislative Rules of the Purchasing Division.
- 4. Prior to any award, the apparent successful vendor must be properly registered with the Purchasing Division and have paid the required \$125.00 registration fee.
- 5. All services performed or goods delivered under State Purchase Orders/Contracts are to be continued for the term of the Purchase Order/Contract, contingent upon funds being appropriated by the Legislature or otherwise being made available. In the event funds are not appropriated or otherwise available for these services or goods, this Purchase Order/Contract becomes void and of no effect after June 30.
- 6. Payment may only be made after the delivery and acceptance of goods or services.
- 7. Interest may be paid for late payment in accordance with the West Virginia Code.
- 8. Vendor preference will be granted upon written request in accordance with the West Virginia Code.
- 9. The State of West Virginia is exempt from federal and state taxes and will not pay or reimburse such taxes.
- 10. The Director of Purchasing may cancel any Purchase Order/Contract upon 30 days written notice to the seller.
- 11. The laws of the State of West Virginia and the *Legislative Rules* of the Purchasing Division shall govern all rights and duties under the Contract, including without limitation the validity of this Purchase Order/Contract.
- 12. Any reference to automatic renewal is hereby deleted. The Contract may be renewed only upon mutual written agreement of the parties.
- 13. BANKRUPTCY: In the event the vendor/contractor files for bankruptcy protection, this Contract may be deemed null and void, and terminated without further order.
- 14. HIPAA Business Associate Addendum The West Viginia State Government HIPAA Business Associate Addendum (BAA), approved by the Attorney General, and available online at the Purchasing Division's web site (http://www.state.wv.us/admin/purchase/vrc/hipaa.htm) is hereby made part of the agreement. Provided that, the Agency meets the definition of a Covered Entity (45 CFR §160.103) and will be disclosing Protected Health Information (45 CFR §160.103) to the vendor.

- 2. SPECIFICATIONS: Items offered must be in compliance with the specifications. Any deviation from the specifications must be clearly indicated by the bidder. Alternates offered by the bidder as EQUAL to the specifications must be clearly defined. A bidder offering an alternate should attach complete specifications and literature to the bid. The Purchasing Division may waive minor deviations to specifications.
- 3. Complete all sections of the quotation form.
- 4. Unit prices shall prevail in cases of discrepancy.
- 5. All quotations are considered F.O.B. destination unless alternate shipping terms are clearly identified in the quotation.
- 6. BID SUBMISSION: All quotations must be delivered by the bidder to the office listed below prior to the date and time of the bid opening. Failure of the bidder to deliver the quotations on time will result in bid disqualifications.

- 1. Page 22, Section 24- The vendors agrees to hold two (1) day training sessions per year at two locations selected by the Division of Public Transit.
- 2. Page 22, Section 25 of RFQ, Remove information for Chuck Bowman and ADD new buyer, Frank Whittaker- frank.m.whittaker@wv.gov and telephone number is (304) 558-2316.
- 3. Page 27, Section 5.1, change to read that the vendor will supply a 270 amp alternator or Approved Equal built to Milspec standards for gas engine only. Ford diesel to be equipped with the dual OEM alternators (120/140) and the Chevy chassis diesel option to be equipped with the OEM dual alternators (150/150).
- 4. Page 35, Section 6.2 ADD (e) acceptable systems to include TransAir 712 Super, Carrier 622 Max or Approved Equals meeting the above specifications.
- 5. Page 36, Section 7.3 Remove one of the sections. The RFQ only requires one circulation fan.
- 6. Page 45, Section 12.1- Windshield to be OEM tinted if standard. Remove the requirement to have a graduated dark band at the top.
- 7. Section 45, Section 13.0- add to first sentence to read fully adjustable heated outside rear view mirrors with auto shut off feature.
- 8. Page 50, Section 20.1, Add the word CLEAR in front of protected under the heading STROBE LIGHT. The strobe light is to have a clear lens.
- 9. Page 51, Section 20.2- Option 5: Heading to read REPEL CLOTH PASSENGER SEATS.
- Page 52, NEW Section 20.11, Add Option 14: GM3500 Gas Chassis- A gas engine to be provided on a GM chassis. SEE ATTACHED NEW OPTION PAGE.
