3. All quotations are governed by the *West Virginia Code* and the *Legislative Rules* of the Purchasing Division.
4. Prior to any award, the apparent successful vendor must be properly registered with the Purchasing Division and have paid the required \$125.00 registration fee.
5. All services performed or goods delivered under State Purchase Orders/Contracts are to be continued for the term of the Purchase Order/Contract, contingent upon funds being appropriated by the Legislature or otherwise being made available. In the event funds are not appropriated or otherwise available for these services or goods, this Purchase Order/Contract becomes void and of no effect after June 30.
6. Payment may only be made after the delivery and acceptance of goods or services.
7. Interest may be paid for late payment in accordance with the *West Virginia Code*.
8. Vendor preference will be granted upon written request in accordance with the *West Virginia Code*.
9. The State of West Virginia is exempt from federal and state taxes and will not pay or reimburse such taxes.
10. The Director of Purchasing may cancel any Purchase Order/Contract upon 30 days written notice to the seller.
11. The laws of the State of West Virginia and the *Legislative Rules* of the Purchasing Division shall govern all rights and duties under the Contract, including without limitation the validity of this Purchase Order/Contract.
12. Any reference to automatic renewal is hereby deleted. The Contract may be renewed only upon mutual written agreement of the parties.

SPECIFICATIONS

The West Virginia Nursing Facility, hereinafter referred to as WVVNF, located at One Freedoms Way, Clarksburg, WV 26301 is seeking bids from therapy vendors who provide physical therapy, occupational therapy and speech therapy at the facility. Interested therapy vendors are required to provide all services noted herein to be considered as therapy vendors.

Brief Background of Facility

The WVVNF is a newly constructed facility. It was constructed as a 120 bed nursing home for the purpose of providing nursing home services to the military veterans of WV. The WVVNF plans to provide intermediate and skilled services as defined by the Centers for Medicare and Medicaid Services (CMMS) and special care services for veterans with Alzheimer's per the WV Licensure Rules for Alzheimer's.

The building has three (3) floors with the 3rd being the administrative/lobby area, 2nd 40 resident rooms, large therapy area and staff supply room, 1st floor 40 resident rooms 20 of which are private rooms located in a designated area for special care services.

Once the facility meets the requirements to be licensed in the State of WV and certification by the VA, the facility will admit residents to occupy the entire facility. During this increase of occupancy, the plan is to work towards meeting the requirements to participate in the Medicaid and Medicare programs and to license the special care unit to service residents with Alzheimer's.

Vendor Requirements

The successful vendor should submit proof of their ability to meet or exceed the following criteria, and /or provide the following information with the bid. Documentation must be submitted prior to the award of the contract.

- a) Must be licensed to conduct business in the State of West Virginia.
- b) Must be available to provide therapy services 7 days per week.
- c) Must provide therapists that are licensed and/or certified as required by the State of West Virginia Therapy and Licensure Board and shall be in good standing with the boards.
- d) Must provide evidence/documentation for a minimum of 3 years experience working in treatment of dementia related illnesses and 2 hours of Alzheimer training as per Nursing Home Licensure Rules.
- e) Must provide Medicare Part B provider Number.
- f) Must identify a primary therapist to work with the facility.
- g) Must provide documentation as to how vendor will support facility to maintain compliance with required reporting/record keeping requirements. (Examples: MDS, therapy evaluations, customer satisfaction monitoring, denials management)
- h) Must provide schedule of support staff to meet needs of facility.
- i) Must provide evidence of compliance with the Civil Rights Act of 1964 and the Americans with Disabilities Act.
- j) Must provide a complete list of clinical and clinically related services.
- k) Will provide a minimum of eight (8) hours training annually to facility staff to include restorative therapy professional.

- l) Must provide a certificate of insurance from an insurance provider acceptable to the State of West Virginia in amounts not less than \$1,000,000 per occurrence and \$3,000,000 aggregate for general and professional liability, such coverage to remain in effect throughout the term of the agreement.
- m) Must provide a list of three (3) references from a current nursing facility. At least one (1) must be from a current client and one (1) must be from a nursing facility with whom the vendor has had a business relationship for at least two (2) years.
- n) Must be available to participate in appropriate committees.
- o) Must be knowledgeable and comply with the rules and regulations that govern nursing homes in the state of West Virginia and Veterans Administration i.e. WV Licensure Rules for Nursing Homes; Medicaid – Medicare.

In that the above is required data and information set, the vendor should identify by notation or other acceptable method each specific element or elements above in their submission.

BID FORM

There are a total estimated 350 hours per month of physical therapy / occupational therapy and speech therapy. This number of hours could fluctuate according to the facility census. Whether more or less, vendor will be required to provide the services by physician orders in a timely manner as needed or as requested by the facility.

PURCHASING AFFIDAVIT

West Virginia Code §5A-3-10a states: No contract or renewal of any contract may be awarded by the state or any of its political subdivisions to any vendor or prospective vendor when the vendor or prospective vendor or a related party to the vendor or prospective vendor is a debtor and the debt owed is an amount greater than one thousand dollars in the aggregate

DEFINITIONS:

"Debt" means any assessment, premium, penalty, fine, tax or other amount of money owed to the state or any of its political subdivisions because of a judgment, fine, permit violation, license assessment, defaulted workers' compensation premium, penalty or other assessment presently delinquent or due and required to be paid to the state or any of its political subdivisions, including any interest or additional penalties accrued thereon.

"Debtor" means any individual, corporation, partnership, association, limited liability company or any other form or business association owing a debt to the state or any of its political subdivisions. "Political subdivision" means any county commission; municipality; county board of education; any instrumentality established by a county or municipality; any separate corporation or instrumentality established by one or more counties or municipalities, as permitted by law; or any public body charged by law with the performance of a government function or whose jurisdiction is coextensive with one or more counties or municipalities. "Related party" means a party, whether an individual, corporation, partnership, association, limited liability company or any other form or business association or other entity whatsoever, related to any vendor by blood, marriage, ownership or contract through which the party has a relationship of ownership or other interest with the vendor so that the party will actually or by effect receive or control a portion of the benefit, profit or other consideration from performance of a vendor contract with the party receiving an amount that meets or exceed five percent of the total contract amount.

EXCEPTION: The prohibition of this section does not apply where a vendor has contested any tax administered pursuant to chapter eleven of this code, workers' compensation premium, permit fee or environmental fee or assessment and the matter has not become final or where the vendor has entered into a payment plan or agreement and the vendor is not in default of any of the provisions of such plan or agreement.

LICENSING: Vendors must be licensed and in good standing in accordance with any and all state and local laws and requirements by any state or local agency of West Virginia, including, but not limited to, the West Virginia Secretary of State's Office, the West Virginia Tax Department, West Virginia Insurance Commission, or any other state agencies or political subdivision. Furthermore, the vendor must provide all necessary releases to obtain information to enable the Director or spending unit to verify that the vendor is licensed and in good standing with the above entities.

CONFIDENTIALITY: The vendor agrees that he or she will not disclose to anyone, directly or indirectly, any such personally identifiable information or other confidential information gained from the agency, unless the individual who is the subject of the information consents to the disclosure in writing or the disclosure is made pursuant to the agency's policies, procedures and rules.
