GENERAL TERMS & CONDITIONS REQUEST FOR QUOTATION (RFQ) AND REQUEST FOR PROPOSAL (RFP)

- 1. Awards will be made in the best interest of the State of West Virginia.
- 2. The State may accept or reject in part, or in whole, any bid.
- 3. All quotations are governed by the West Virginia Code and the Legislative Rules of the Purchasing Division.
- 4. Prior to any award, the apparent successful vendor must be properly registered with the Purchasing Division and have paid the required \$125 fee.
- 5. All services performed or goods delivered under State Purchase Order/Contracts are to be continued for the term of the Purchase Order/Contracts, contingent upon funds being appropriated by the Legislature or otherwise being made available. In the event funds are not appropriated or otherwise available for these services or goods, this Purchase Order/Contract becomes void and of no effect after June 30.
- 6. Payment may only be made after the delivery and acceptance of goods or services.
- 7. Interest may be paid for late payment in accordance with the West Virginia Code.
- 8. Vendor preference will be granted upon written request in accordance with the West Virginia Code.
- 9. The State of West Virginia is exempt from federal and state taxes and will not pay or reimburse such taxes.
- 10. The Director of Purchasing may cancel any Purchase Order/Contract upon 30 days written notice to the seller.
- 11. The laws of the State of West Virginia and the *Legislative Rules* of the Purchasing Division shall govern all rights and duties under the Contract, including without limitation the validity of this Purchase Order/Contract.
- 12. Any reference to automatic renewal is hereby deleted. The Contract may be renewed only upon mutual written agreement of the parties.
- 13. BANKRUPTCY: In the event the vendor/contractor files for bankruptcy protection, this Contract may be deemed null and void, and terminated without further order.
- 14. HIPAA BUSINESS ASSOCIATE ADDENDUM: The West Virginia State Government HIPAA Business Associate Addendum (BAA), approved by the Attorney General, and available online at the Purchasing Division's web site (http://www.state.wv.us/admin/purchase/vrc/hipaa.htm) is hereby made part of the agreement. 1. Attached is a copy of the Vendor Sign-In sheet from the pre-bid meeting held yesterday here at the park. We had a total of five vendors in attendance.

 We discussed the all parts of the RFQ and discovered errors that will require an addendum. I have attached a copy of the pages requiring correction with the suggested revisions.

3. The overall majority of the errors are area specific (i.e. listed as for area four but is actually to be installed in another). As we will be installed by park personnel, I did not consider this to be a significant issue. I apologize for that assumption.

There are two errors that are significant however:

- a. The Primetime Swing, Add-a-Bay, and seats must be deleted from the Swimming Pool playground.
- b. A Gametime Tuff-Clad bench must be added to the Area 1 playground.

5. These errors were discussed with the vendors present.

6. As this is my project here at Holly River, I take full responsibility for the oversights and sincerely apologize for them.

Park personnel will install all playground equipment. The award may be split if it is in the best interest of the West Virginia Division of Natural Resources.

Color scheme of equipment must be coordinated with Holly River State Park. Color of items will be selected from manufacturer's standard colors.

A mandatory pre-bid conference will be held on April 7, 2009, at Holly River State Park Headquarters at 1:00 p.m. A failure to attend the mandatory pre-bid conference will result in bid disqualification. An individual may not represent more than one firm at the pre-bid conference.
