2. The State may accept or reject in part, or in whole, any bid.
3. All quotations are governed by the *West Virginia Code* and the *Legislative Rules* of the Purchasing Division.
4. Prior to any award, the apparent successful vendor must be properly registered with the Purchasing Division and have paid the required \$125.00 registration fee.
5. All services performed or goods delivered under State Purchase Orders/Contracts are to be continued for the term of the Purchase Order/Contract, contingent upon funds being appropriated by the Legislature or otherwise being made available. In the event funds are not appropriated or otherwise available for these services or goods, this Purchase Order/Contract becomes void and of no effect after June 30.
6. Payment may only be made after the delivery and acceptance of goods or services.
7. Interest may be paid for late payment in accordance with the *West Virginia Code*.
8. Vendor preference will be granted upon written request in accordance with the *West Virginia Code*.
9. The State of West Virginia is exempt from federal and state taxes and will not pay or reimburse such taxes.
10. The Director of Purchasing may cancel any Purchase Order/Contract upon 30 days written notice to the seller.
11. The laws of the State of West Virginia and the *Legislative Rules* of the Purchasing Division shall govern all rights and duties under the Contract, including without limitation the validity of this Purchase Order/Contract.

The West Virginia State Police are soliciting bids for a major renovation of the forensic Firearm/Toolmark Section indoor firing range, located in South Charleston. The following specifications must be met in full by the successful vendor. The design of the new range is centered on Savage Range Systems or equivalent products.

The range size is approximately one hundred and ten (110) feet long, twenty (20) feet wide, and eleven (11) feet high.

SPECIFICATIONS

- Decontaminate for lead of the entire range system including all walls, ceiling, floors and area behind the trap. This will include removal of the existing armor escalator trap, and removal and decontamination of sprayed on acoustic materials and Tectum panels from the entire range. This work will be done by 40-hour certified technicians in accordance with all applicable EPA requirements. Vendor must include any and all EPA documentation regarding disposition and disposal of hazardous waste material.
- Supply new range equipment:
