Technical Questions and Answers

Question#1: The specification does not clearly state whether the underlying built-up roof is to be removed. In one area it states "removing existing ballasted roofing and insulation" (Pg 11 of RFQ; first sentence under "Scope") and in another "remove existing roof and appurtenances." (Same Page, third sentence under "Scope") Is the successful contractor to remove all roofing material to expose the deck?

Answer#1: Contractor must remove all roofing material to expose the deck.

Question#2: The specification states "work will include ANY of the following: flashing replacement, replacing parapet copings if necessary, repainting where applicable, replacing gutters & downspouts, and other work necessary to provide a complete, watertight roofing system." Can this be clarified on the roof as to the exact extent of metal to be replaced?

Answer#2: The specification should state "work will include ALL of the following: flashing replacement, provide parapet copings, repainting all exposed metal and other work necessary to provide a complete, watertight roofing system."

Question#3: What type and thickness of insulation is to be installed? A 20 year warranty requires a minimum of 1.5" ISO. If recovering a minimum of 1" ISO is required.

Answer#3: Contractor will provide a minimum of 3" ISO.

Question#4: Is the roof to be fully tapered? Is tapered ISO to be installed on this project? Should there be pre-formed saddling between drains?

Answer#4: Taper to drains.

Question#5: The specifications list 2 options for all metal. Please specify which 1 of the 2 is to be used.

Answer#5: Aluminum. Red Brick in color.

Question#6: Are there any basement or underground utilities present, as indicated in the specifications? (Per Page 12 of the RFQ)

Answer#6: Contractor is responsible for contacting Miss Utility prior to beginning work.

Question#7: Can a crane be set up next to the building? Where?

Answer#7: Barring a utility obstacle (as in Question & Answer #6), a crane could be set up on the front or rear side of the building. Contractor will repair to original any damage caused by the crane. (Ground, sidewalk etc.) Also, obtain necessary written permits from the City of South Charleston for the closure of any streets or alleyways prior to beginning work. Copy must be provided to Owner prior to beginning work.

GENERAL TERMS & CONDITIONS REQUEST FOR QUOTATION (RFQ) AND REQUEST FOR PROPOSAL (RFP)

- 1. Awards will be made in the best interest of the State of West Virginia.
- 2. The State may accept or reject in part, or in whole, any bid.
- 3. All quotations are governed by the West Virginia Code and the Legislative Rules of the Purchasing Division.
- 4. Prior to any award, the apparent successful vendor must be properly registered with the Purchasing Division and have paid the required \$125 fee.
- 5. All services performed or goods delivered under State Purchase Order/Contracts are to be continued for the term of the Purchase Order/Contracts, contingent upon funds being appropriated by the Legislature or otherwise being made available. In the event funds are not appropriated or otherwise available for these services or goods, this Purchase Order/Contract becomes void and of no effect after June 30.
- 6. Payment may only be made after the delivery and acceptance of goods or services.
- 7. Interest may be paid for late payment in accordance with the West Virginia Code.
- 8. Vendor preference will be granted upon written request in accordance with the West Virginia Code.
- 9. The State of West Virginia is exempt from federal and state taxes and will not pay or reimburse such taxes.
- 10. The Director of Purchasing may cancel any Purchase Order/Contract upon 30 days written notice to the seller.
- 11. The laws of the State of West Virginia and the *Legislative Rules* of the Purchasing Division shall govern all rights and duties under the Contract, including without limitation the validity of this Purchase Order/Contract.
- 12. Any reference to automatic renewal is hereby deleted. The Contract may be renewed only upon mutual written agreement of the parties.
- 13. BANKRUPTCY: In the event the vendor/contractor files for bankruptcy protection, this Contract may be deemed null and void, and terminated without further order.
- 14. HIPAA BUSINESS ASSOCIATE ADDENDUM: The West Virginia State Government HIPAA Business Associate Addendum (BAA), approved by the Attorney General, and available online at the Purchasing Division's web site (http://www.state.wv.us/admin/purchase/vrc/hipaa.htm) is hereby made part of the agreement. Provided that, the Agency meets the definition of a Cover Entity (45 CFR §160.103) and will be disclosing Protected Health Information (45 CFR §160.103) to the vendor.
- 15. WEST VIRGINIA ALCOHOL & DRUG-FREE WORKPLACE ACT: If this Contract constitutes a public improvement construction contract as set forth in Article 1D, Chapter 21 of the West Virginia Code ("The West Virginia Alcohol and Drug-Free Workplace Act"), then the following language shall hereby become part of this Contract: "The contractor and its subcontractors shall implement and maintain a written drug-free workplace policy in compliance with the West Virginia Alcohol and Drug-Free Workplace Act, as set forth in Article 1D, Chapter 21 of the West Virginia Code. The contractor and its subcontractors shall provide a sworn statement in writing, under the penalties of perjury, that they maintain a valid drug-free work place policy in compliance with the West Virginia and Drug-Free Workplace Act. It is understood and agreed that this Contract shall be cancelled by the awarding authority if the Contractor: 1) Fails to implement its drug-free workplace policy; 2) Fails to provide information regarding implementation of the contractor's drug-free workplace policy at the request of the public authority; or 3) Provides to the public authority false information regarding the contractor's drug-free workplace policy."

INSTRUCTIONS TO BIDDERS

- 1. Use the quotation forms provided by the Purchasing Division.
- 2. SPECIFICATIONS: Items offered must be in compliance with the specifications. Any deviation from the specifications must be clearly indicated by the bidder. Alternates offered by the bidder as EQUAL to the specifications must be clearly defined. A bidder offering an alternate should attach complete specifications and literature to the bid. The Purchasing Division may waive minor deviations to specifications.
- 3. Complete all sections of the quotation form.
- 4. Unit prices shall prevail in case of discrepancy.
- 5. All quotations are considered F.O.B. destination unless alternate shipping terms are clearly identified in the quotation.
- **6. BID SUBMISSION:** All quotations must be delivered by the bidder to the office listed below prior to the date and time of the bid opening. Failure of the bidder to deliver the quotations on time will result in bid disqualifications: Department of Administration, Purchasing Division, 2019 Washington Street East, P.O. commencing?
Answer#8: No

Question#9: Will access to the roof be available through the roof hatch?

Answer#9: Yes, but Contractor must coordinate with Owner. Note that other renovations

to the building may be occurring simultaneously with the re-roofing
