Pre-bid Addendum August 20, 2008 HHR90059 FMRS Roof

Change Section 18.1 to read:

Bidders shall submit one lump sum bid for all the work as specified and also 18.11 a square foot unit price for replacement of the gypsum deck and 18.12 a square foot unit price for replacement of the metal deck...

Add to Section 3.5:

Saddles and crickets will be required around the raised areas of the roof to properly divert water to the drain.

Questions and Answers:

- Q. What subsurface material exists under the rubber roof?
- A. Mansuetto & Sons, Inc. previously did a roof cut and they believe the roof under the rubber roof is 4-ply and gravel and 1-2" of perlite insulation. However, the foregoing information is for informational purposes only and should not be relied upon to bid the work. Any roofing contractor wanting to know exact field conditions should return to the site and cut the roof for themselves.
- Q. What is necessary to submit for the Drug Free Work Place Requirement?
- A. Affidavit as specified on page 17.
- Q. May we dispose of ballast on site?
- A. Yes, but probably would be on the grounds of Pinecrest Hospital
