**REQUEST FOR QUOTATION (RFQ) AND REQUEST FOR PROPOSAL (RFP)**

1. Awards will be made in the best interest of the State of West Virginia.
2. The State may accept or reject in part, or in whole, any bid.
3. All quotations are governed by the *West Virginia Code* and the *Legislative Rules* of the Purchasing Division.
4. Prior to any award, the apparent successful vendor must be properly registered with the Purchasing Division and have paid the required \$125 fee.
5. All services performed or goods delivered under State Purchase Order/Contracts are to be continued for the term of the Purchase Order/Contracts, contingent upon funds being appropriated by the Legislature or otherwise being made available. In the event funds are not appropriated or otherwise available for these services or goods, this Purchase Order/Contract becomes void and of no effect after June 30.
6. Payment may only be made after the delivery and acceptance of goods or services.
7. Interest may be paid for late payment in accordance with the *West Virginia Code*.
8. Vendor preference will be granted upon written request in accordance with the *West Virginia Code*.
9. The State of West Virginia is exempt from federal and state taxes and will not pay or reimburse such taxes.
10. The Director of Purchasing may cancel any Purchase Order/Contract upon 30 days written notice to the seller.
11. The laws of the State of West Virginia and the *Legislative Rules* of the Purchasing Division shall govern all rights and duties under the Contract, including without limitation the validity of this Purchase Order/Contract.
12. Any reference to automatic renewal is hereby deleted. The Contract may be renewed only upon mutual written agreement of the parties.
13. **BANKRUPTCY:** In the event the vendor/contractor files for bankruptcy protection, this Contract may be deemed null and void, and terminated without further order.

Specifications and services shall consist of the following:

Operation, repair and maintenance, monitoring and sampling of an existing 200,000 gallon per day sewage collection and treatment system consisting of a mechanically cleaned bar screen, a 178,000 gallon Orbal aeration, two (2) 28,200 gallon clarifiers, an ultraviolet disinfection system with a 756 gallon ultraviolet disinfection chamber, a 3,030 gallon post aeration unit, a 6,000 gallon sludge mixing tank, a 74,000 gallon sludge holding tank, an 8,000 gallon wetwell return and other necessary appurtenances.

The Huttonsville Correctional Center shall be responsible for maintenance as it pertains to repair or replacement of motors; electrical controls; gear boxes; pumps, valves; flow metering equipment; trash pumps; handrails; bar screens; lights, both inside and outside; generators, or any other item that is needed to complete daily operational requirements. The Contractor will notify Huttonsville immediately upon discovery of faulty equipment via telephone to the Director of Maintenance followed by a written work request. Huttonsville shall respond immediately upon notification. Additionally, Huttonsville shall maintain the grounds, such as mowing and snow removal.

The Contractor shall be responsible for preventative maintenance to include greasing equipment, checking oil levels, belts and exercise valves; inspecting the UV system, lift station control panel and bar screen for proper operation.

The Huttonsville Correctional Center shall be responsible for the purchase of any and all chemicals required to keep the facility in compliance with its NPDES Permit. The Contractor shall complete a request for needed chemicals a minimum of ten (10) working days in advance of the exhaustion of chemical supply. Huttonsville shall obtain and deliver chemicals in a timely manner.

The Contractor shall conduct operations and maintenance visits in accordance with all operational standards and guidelines mandated by the West Virginia Department of Environmental Protection.

The Contractor shall provide all labor, materials and bear expenses necessary to include: laboratory analysis, cleaning supplies and garbage removal. Garbage removal shall follow guidelines established by Tygart Valley Sanitation and consist of properly bagging dry trash for deposit in dumpster; trash material from the bar screen shall be stored in a basket provided to drain and dry before depositing loose into dumpster. The Huttonsville Correctional Center will pay for pick up and removal from the site in a timely manner. Additionally, Huttonsville shall have the responsibility for sludge hauling should it be determined that land application is no longer viable.

The Contractor shall provide all labor, materials and bear the cost for analysis, all waste water samples required by various governmental regulatory agencies.

The cost of re-sampling due to delays or improper sampling will be the responsibility of the Contractor.

The Contractor must be available to meet with regulatory agency personnel or inspectors.

The Contractor will be responsible for the payment of any fines assessed by a regulatory agency as a result of the Contractor's failure to perform under the specifications of this Agreement. Specifically, the Contractor will ONLY be held liable for gross negligence of their duties as outlined by the Department of Environmental Protection or Environmental Protection Agency. Payment for any fines and fees, if assessed, for Contractor's gross negligence found by these regulatory agencies shall be made by the Contractor.

The Contractor must maintain all required files, records and permits in accordance with applicable regulations. Copies of all transactions and reporting data, including maintenance logs, will be provided to the Associate Warden of Operations by the 10th of the month for the previous month's activities.

The Contractor will be required to respond twenty-four hours a day, seven days a week, for emergencies. Emergency response time must be stated in the Agreement and will respond on site no more than two hours from the time of notification.

The Contractor's employee(s) assigned under this Agreement shall submit to a criminal background check performed by Huttonsville Correctional Center at no cost to the Contractor.

The Contractor's employee(s) assigned under this Agreement must attend an on site forty (40) hour Orientation training program. The Contractor shall bear the cost of wages for this training.

This Agreement will begin on November 1, 2008. The Contractor will be paid on a monthly basis. an invoice shall be submitted to the Huttonsville Correctional Center Business Office by the 5th of the month for the previous month's service.

## PURCHASING AFFIDAVIT

### VENDOR OWING A DEBT TO THE STATE:

*West Virginia Code* §5A-3-10a provides that: No contract or renewal of any contract may be awarded by the state or any of its political subdivisions to any vendor or prospective vendor when the vendor or prospective vendor or a related party to the vendor or prospective vendor is a debtor and the debt owed is an amount greater than one thousand dollars in the aggregate.
