REQUEST FOR QUOTATION (RFQ) AND REQUEST FOR PROPOSAL (RFP)

1. Awards will be made in the best interest of the State of West Virginia.
2. The State may accept or reject in part, or in whole, any bid.
3. All quotations are governed by the *West Virginia Code* and the *Legislative Rules* of the Purchasing Division.
4. Prior to any award, the apparent successful vendor must be properly registered with the Purchasing Division and have paid the required \$125 fee.
5. All services performed or goods delivered under State Purchase Order/Contracts are to be continued for the term of the Purchase Order/Contracts, contingent upon funds being appropriated by the Legislature or otherwise being made available. In the event funds are not appropriated or otherwise available for these services or goods, this Purchase Order/Contract becomes void and of no effect after June 30.
6. Payment may only be made after the delivery and acceptance of goods or services.
7. Interest may be paid for late payment in accordance with the *West Virginia Code*.
8. Vendor preference will be granted upon written request in accordance with the *West Virginia Code*.
9. The State of West Virginia is exempt from federal and state taxes and will not pay or reimburse such taxes.
10. The Director of Purchasing may cancel any Purchase Order/Contract upon 30 days written notice to the seller.
11. The laws of the State of West Virginia and the *Legislative Rules* of the Purchasing Division shall govern all rights and duties under the Contract, including without limitation the validity of this Purchase Order/Contract.
12. Any reference to automatic renewal is hereby deleted. The Contract may be renewed only upon mutual written agreement of the parties.

The WV Public Service Commission (WV PSC) is seeking someone to provide legal, technical and consultant services related to a Commercial Vehicle Analysis Reporting System (CVARS) Grant that requires this agency, under the direction of the Transportation Division, to conduct an on-site investigation of each law entity in this state regarding their crash data records, review for compliance, and instruct on appropriate rules and statutes required for this program. The successful contractor must be available to render such services as soon as practicable, but in any event no later than April 1, 2009 and may be required to work up to 35 hours or more per week and be available upon request.

The minimum requirements, qualifications and expertise include:

1. Knowledge of Public Service Commission statutes and rules pertaining to transportation.
2. Knowledge on the utilization, interpretation and analysis of Federal Motor Carrier Safety Administration (FMCSA) - Analysis and Information on line.
3. Knowledge of the utilization, interpretation and analysis of SafetyNet Program and data.
4. Knowledge of the utilization, interpretation and analysis of Motor Carrier Management Information System (MCMIS) program and data.
5. Knowledge and understanding of Motor Carrier Safety Assistance Program (MCSAP) program guidelines and requirements.
6. Knowledge of State of West Virginia Law Enforcement entities and law enforcement procedures.
7. Working knowledge of Division of Highways and Division of Motor Vehicle requirements.
8. Working knowledge of WV PSC Safety and Weight Enforcement structure.
9. Working Knowledge of WV PSC Safety Program and Safety Regulations.
10. Knowledge of Federal Motor Carrier Safety Administration program and Federal Motor Carrier Safety Regulations.

11. Ability to draft appropriate rules or statutes necessary to implement program.
12. Ability to provide legal representation of Enforcement Section of the Transportation Division of the WV PSC relative to the crash report forms, rules, statues and general legislation within the program goals and objectives. Vendor shall have an active law license in West Virginia.
13. Shall have a working relationship with the commercial motor vehicle safety industry and related federal and state agencies to enhance the ability to serve as a liaison between the entities to facilitate a working dialogue.
14. Applicant must have had full time experience in the management of a large subordinate staff of safety enforcement, administrative, and professional personnel in a regulatory agency setting, including implementation of federal grant programs, including grants administered by the Federal Motor Carrier Safety Administration, U.S. Department of Transportation. The applicant/vendor shall supply, on request by the Agency, a resume of their experience.
15. Awarded vendor shall be a WV registered vendor.
16. Vendor will travel as required to fulfill this grant under the terms and conditions of the travel management office of the State of West Virginia.
17. Vendor shall have the ability to subcontract to eligible vendors under the same terms and conditions as stated above. Subcontracted vendor shall have working knowledge and be able to travel also. The Vendor will be responsible for the payment to the subcontractors. Must be able to utilize appropriately qualified individuals, working under adequate supervision, to achieve program goals within the budget awarded with the contract/grant.
18. Applicant shall provide references with particular knowledge of experience in all of the above and/or regulatory work.
19. Vendor shall have knowledge of, and experience with, state implementation of a Commercial Vehicle Analysis report System (CVARS) grant.

- 20. Vendor shall have knowledge of, and experience with, crash data quality and timeliness requirements imposed on WV Public Service Commission by its participation in the CVARS grant program.

Furthermore, the vendor must provide all necessary releases to obtain information to enable the Director or spending unit to verify that the vendor is licensed and in good standing with the above entities.

 _____ Bidder is a nonresident vendor which has an affiliate or subsidiary which employs a minimum of one hundred state residents and which has maintained its headquarters or principal place of business within West Virginia continuously for the four (4) years immediately preceding the date of this certification; **or**,
2. **Application is made for 2.5% resident vendor preference for the reason checked:**
 _____ Bidder is a resident vendor who certifies that, during the life of the contract, on average at least 75% of the employees working on the project being bid are residents of West Virginia who have resided in the state continuously for the two years immediately preceding submission of this bid; **or**,
3. **Application is made for 2.5% resident vendor preference for the reason checked:**
 _____ Bidder is a nonresident vendor employing a minimum of one hundred state residents or is a nonresident vendor with an affiliate or subsidiary which maintains its headquarters or principal place of business within West Virginia employing a minimum of one hundred state residents who certifies that, during the life of the contract, on average at least 75% of the employees or Bidder's affiliate's or subsidiary's employees are residents of West Virginia who have resided in the state continuously for the two years immediately preceding submission of this bid; **or**,
4. **Application is made for 5% resident vendor preference for the reason checked:**
 _____ Bidder meets either the requirement of both subdivisions (1) and (2) or subdivision (1) and (3) as stated above; **or**,
5. **Application is made for 3.5% resident vendor preference who is a veteran for the reason checked:**
 _____ Bidder is an individual resident vendor who is a veteran of the United States armed forces, the reserves or the National Guard and has resided in West Virginia continuously for the four years immediately preceding the date on which the bid is submitted; **or**,
6. **Application is made for 3.5% resident vendor preference who is a veteran for the reason checked:**
 _____ Bidder is a resident vendor who is a veteran of the United States armed forces, the reserves or the National Guard, if, for purposes of producing or distributing the commodities or completing the project which is the subject of the vendor's bid and continuously over the entire term of the project, on average at least seventy-five percent of the vendor's employees are residents of West Virginia who have resided in the state continuously for the two immediately preceding years.

Bidder understands if the Secretary of Revenue determines that a Bidder receiving preference has failed to continue to meet the requirements for such preference, the Secretary may order the Director of Purchasing to: (a) reject the bid; or (b) assess a penalty against such Bidder in an amount not to exceed 5% of the bid amount and that such penalty will be paid to the contracting agency or deducted from any unpaid balance on the contract or purchase order.

By submission of this certificate, Bidder agrees to disclose any reasonably requested information to the Purchasing Division and authorizes the Department of Revenue to disclose to the Director of Purchasing appropriate information verifying that Bidder has paid the required business taxes, provided that such information does not contain the amounts of taxes paid nor any other information deemed by the Tax Commissioner to be confidential.

Under penalty of law for false swearing (*West Virginia Code*, §61-5-3), Bidder hereby certifies that this certificate is true and accurate in all respects; and that if a contract is issued to Bidder and if anything contained within this certificate changes during the term of the contract, Bidder will notify the Purchasing Division in writing immediately.
