- 3. All quotations are governed by the West Virginia Code and the Legislative Rules of the Purchasing Division
- 4. Prior to any award, the apparent successful vendor must be properly registered with the Purchasing Division and have paid the required \$125 fee
- 5. All services performed or goods delivered under State Purchase Order/Contracts are to be continued for the term of the Purchase Order/Contracts, contingent upon funds being appropriated by the Legislature or otherwise being made available. In the event funds are not appropriated or otherwise available for these services or goods, this Purchase Order/Contract becomes void and of no effect after June 30
- 6. Payment may only be made after the delivery and acceptance of goods or services
- 7. Interest may be paid for late payment in accordance with the West Virginia Code
- 8. Vendor preference will be granted upon written request in accordance with the West Virginia Code
- 9. The State of West Virginia is exempt from federal and state taxes and will not pay or reimburse such taxes

#### PROCUREMENT SPECIFICATIONS

#### 3.1 General Requirements

The mission/purpose of this project is to provide Chief of Staff Services for Welch Community Hospital. The Chief of Staff shall manage the medical affairs of the Hospital in cooperation with, and under the direction of the Hospital administration and shall recognize that it is essential that the medical and hospital administration function jointly in a manner that provides high quality medical and hospital care to protect the patient and minimize the liability of the State in providing healthcare.

#### 3.2 SCOPE OF WORK:

The vendor is to quote services of providing Chief of Staff Services, these services are to include, but are not limited to, the following:

- a Vendor shall serve as Chairman for the Executive Committee, Credentials
  Committee, and Quality Assurance Committee. Serving on other various committees
  may be required.
- b. Shall be available for consultative and administrative issues at all times.
- c. Shall be available for two (2) hours per week of scheduled time with the Medical Staff Secretary.
- d. Shall be available for four (4) to six (6) hours per month scheduled for medical staff meeting days which occur on the fourth (4<sup>th</sup>) Thursday of each month.

- e. Vendor will provide medical administration services to the hospital's medical staff and provide guidance and direction to all physicians with privileges to practice at the Hospital.
- f. Vendor will be accountable to the Department, through the Hospital Administrator, for the professional activities and quality of medicine at the Hospital.
- g Vendor must review monthly shift and standby schedules to provide adequate coverage. These schedules shall be provided to the Hospital administration no later than five (5) working days prior to the beginning of each month.
- h. Vendor will direct educational programs for the medical staff nurses, paramedical personnel and attending physicians as appropriate and necessary.
- i. Vendor will define and delineate Medical Staff policies, standards and functions with the aid of nursing, administration, and medical staff committees.
- j. Vendor will consult in planning, organizing, and managing space, facilities, and equipment utilized by the medical staff.
- k. Vendor will schedule and conduct regular meetings of the medical staff.
- 1. Vendor will participate in and direct medical care in the Hospital's disaster planning and exercises.
- m. Vendor will provide input to administration, based on participation in community activities on behalf of the Hospital, regarding community needs for medical care.
- n. Vendor will direct and participate in medical staff quality assurance activities as required by JCAHO and other regulator agencies, as appropriate
- o. Vendor will strive to improve medical health care delivery.
- p Vendor will orient new physician staff members to the medical staff as appropriate
- q. Vendor will establish a methodology for dealing with patient complaints and staff conflicts.
- r Vendor will establish and develop a medical audit program for evaluation of medical care rendered by the medical staff.
- s Vendor will consult with professional and subordinate medical staff and students concerning prescribed medical and treatment areas requiring improvement in the medical program
- t. Vendor will prescribe and direct various therapy activities
- u. Vendor will promote good health practices and advise local personnel on problems.
- v. Vendor will assist the Hospital in obtaining and maintaining all proper licenses and accreditations.
- w. Vendor will actively participate in various other medical staff activities and responsibilities, including teaching and attendance at required meetings.
- x Vendor will maintain professional qualifications, competency and licensure, including a current narcotics number.
- y Vendor will apply for and maintain staff and clinical privileges.
- z. Participate in Hospital's medical staff organization as described in this section.

#### 4. Invoices and Progress Payments:

Vendor shall submit a signed and dated time sheet stating time spent on Chief of Staff duties monthly. The time sheet is to be submitted to the Hospital Administrator by the fifth (5<sup>th</sup>) of the following month. The time sheet shall include (1) Date, (2) time spent (hours and/or minutes), and (3) description of services rendered. There must be a

minimum of twenty (20) hours per month spent of Chief of Staff duties. All time sheets must be submitted in a format approved by the hospital.

### 5. Independent Contactor Status

In the performance of the work, duties and obligations under this Contract, it is mutually understood and agreed upon that the Contractor is at all times acting and performing as an independent contractor and no principal-agent or employer-employee relationship is contemplated by the parties to this Agreement. The Hospital shall neither have nor exercise any control or direction over the methods by which Contractor or physician employees under his control perform their work. The sole interest and responsibility of the Hospital is to ensure the services offered by the Department covered by this Contract shall be performed and rendered in a competent, efficient and satisfactory manner All Standards of medical practice and professional duties of the Contractor shall be determined by the medical staff of the Hospital. All applicable provisions of law and other rules and regulations of any and all governmental authorities relating to licensure and regulatory of physicians and hospitals and to the operation of the department shall be fully complied with by all parties hereto. In addition, the parties shall also operate and conduct the department in accordance with the standards and recommendations of the Joint Commission on Accreditation of Hospitals, the bylaws of the Hospital, and the bylaws, rules and regulation of the medical staff as may be in effect from time to time The provisions of this Agreement shall not be interpreted to conflict with the intent of the parties that the legal status of the Contractor shall at all times be that of an independent contractor.
