### GENERAL TERMS & CONDITIONS REQUEST FOR QUOTATION (RFQ) AND REQUEST FOR PROPOSAL (RFP)

- 1. Awards will be made in the best interest of the State of West Virginia.
- 2. The State may accept or reject in part, or in whole, any bid.
- 3. All quotations are governed by the West Virginia Code and the Legislative Rules of the Purchasing Division.
- 4. Prior to any award, the apparent successful vendor must be properly registered with the Purchasing Division and have paid the required \$125 fee.
- 5. All services performed or goods delivered under State Purchase Order/Contracts are to be continued for the term of the Purchase Order/Contracts, contingent upon funds being appropriated by the Legislature or otherwise being made available. In the event funds are not appropriated or otherwise available for these services or goods, this Purchase Order/Contract becomes void and of no effect after June 30.
- 6. Payment may only be made after the delivery and acceptance of goods or services.
- 7. Interest may be paid for late payment in accordance with the West Virginia Code.
- 8. Vendor preference will be granted upon written request in accordance with the West Virginia Code.
- 9. The State of West Virginia is exempt from federal and state taxes and will not pay or reimburse such taxes.
- 10. The Director of Purchasing may cancel any Purchase Order/Contract upon 30 days written notice to the seller.
- 11. The laws of the State of West Virginia and the *Legislative Rules* of the Purchasing Division shall govern all rights and duties under the Contract, including without limitation the validity of this Purchase Order/Contract.
- 12. Any reference to automatic renewal is hereby deleted. The Contract may be renewed only upon mutual written agreement of the parties.
- 13. BANKRUPTCY: In the event the vendor/contractor files for bankruptcy protection, the State may deem this contract null and void, and terminate such contract without further order.
- 14. HIPAA BUSINESS ASSOCIATE ADDENDUM: The West Virginia State Government HIPAA Business Associate Addendum (BAA), approved by the Attorney General, and available online at the Purchasing Division's web site (http://www.state.wv.us/admin/purchase/vrc/hipaa.htm) is hereby made part of the agreement. - 15. ## Purchase Requisition Type of Purchase Landfill Maintenance

To provide all equipment materials and labor to install and modify an existing leachate line at the Wyoming County Landfill so as to provide a back wash system to back wash solids and sediments from the existing leachate line. Please see attached specifications.

**General Conditions:** A mandatory Pre-bid Conference will be held at the Wyoming County Landfill, Airport Road, Pineville, WV 24874.

This contract shall provide for all labor, materials, transportation, tools, equipment, supplies, and incidentals to: 1) Transport an existing storage tank from Welch WWTP to the Wyoming County Landfill, 2) Excavate a road and tank pad location for the back wash tank, 3) Provide piping and electrical (including tank heater and clock gauge) for back wash tank, 4) Modify existing plumbing in force main pump house to allow a back washing of existing leachate lines, 5) Clean Existing Wet Well, Leachate Tanks and Associated Plumbing, 6) Disposal of Debris and Leachate, and 7) Seeding and Mulching of disturbed or bare areas.

The contractor shall provide equipment suitable to the WV DEP for performing the work. Any modifications to this contract shall be requested in writing and shall be approved or disapproved in writing by the WV DEP.

Item #1: Transport Leachate Tank: The contractor shall transport an existing leachate tank with secondary containment from the Welch WWTP to the Wyoming County Landfill. This tank is owned by the WV-DEP and will be used as storage for the back wash at the Wyoming County Landfill. This is a steel tank with holds approximately 2500 gallons and is 8 feet tall, 8 feet wide and 16 feet long. The contractor will be responsible for loading, transporting and unloading the tank.

Item #1 "Transport Leachate Tank" will be measured and paid as a "lump sum" unit, cost including all labor, equipment, materials, transportation, and incidentals to obtain results satisfactory to the DEP.

Item #2: Leachate Tank Pad and Road. Contractor shall excavate a road way and pad for the leachate storage tank to be placed in an approximate area as designated on Attachment A. The tank pad shall be placed at a location and elevation so as to allow a minimum of a 1% grade on the back wash discharge line between the pump house and storage tank.

The roadway leading to the tank shall be excavated, as needed, to provide access to the tank. The roadway and tank shall be stabilized by track walking and compacting to a point visually approved by DEP. The roadway and tank area shall be under laid with a 6 oz filter fabric. The tank pad shall be approximately 10' wider and 10' longer than the tank footprint, and the road way shall be 12' wide. The tank pad and roadway shall be covered with a 12 inch thick layer of #1 stone. All areas of disturbance shall be mulched and seeded as per Item 8.

Item #2a "Leachate Tank Pad and Road Excavation" will be measured and paid as a "lump sum" unit, cost including all labor, equipment, materials, transportation, and incidentals to cut in road and tank pad, compact area, place tank on pad and regrade site so as to provide results satisfactory to the DEP.

Item #2b "Leachate Tank Pad and Road Stone" will be measured and paid as a "per ton" unit, cost. Payment will be based to actual truck weight tickets with the 6 oz filter fabric being incidental to this cost. Work shall including all labor, equipment, materials, transportation, and incidentals to obtain results satisfactory to the DEP.

Item #3: Leachate Tank Heater: The contractor shall provide and install a 220 single phase tank heater compatible with the existing tank being non-corrosive and non-explosive. Installation of Heater and all associated electrical work shall be conducted by a WV certified electrician. All electrical wiring shall be direct burial type and enclosed in electrical conduit. All connections shall be waterproof type.

Item #3 "Leachate Tank Heater" Will be measured and paid as a "per each" unit cost including all labor, equipment, materials, transportation, and incidentals to provide and install the tank heater.

Item #4: Leachate Tank Clock Gauge: The contractor shall provide and install a Clock Gauge for the measuring of the amount of liquid inside the leachate Storage Tank. The Clock Gauge shall meet the specifications of the Morrison 818F 2" Female NPT Clock Gauge (or approved equivalent) which is used for measuring liquid level in above ground storage tanks. Readout format shall be a standard 12 hour clock face.

Item #4 "Leachate Tank Clock Gauge" Will be measured and paid as a "per each" unit cost including all labor, equipment, materials, transportation, and incidentals to provide and install the tank clock gauge.

Item #5: Pump House Modification: The contractor shall modify existing pump house plumbing so as to create a flexible 2" connection to the existing 3" cleanout. (see Attachment B) This connection will allow quick connection and disconnect and it shall feed to a 2" HDPE DR 13.5 line to be installed by the contractor. The contractor will install a 2" Welded HDPE DR 13.5 line (as supplied by Lee Supply or approved equivalent) from this connection to the 2500 gallon tank. This will require boring thru the existing concrete floor and burying a line between the pump house and tank. The 2 inch HDPE line shall be placed in an excavated trench and backfilled with compacted material. Specifications for all connections and materials shall be

provided to DEP for approval prior to installation. All areas of disturbance shall be mulched and seeded as per Item 8.

Item #5 "Pump House Modification" will be measured and paid as a "lump sum" unit, cost including all labor, equipment, materials, transportation, and incidentals to obtain results satisfactory to the DEP.

Item #6: Existing Tank and Wet Well Cleaning: Contractor shall provide all equipment manpower and necessary permits to clean all sediments and solids from the existing leachate storage tank and wet well. All debris and sediments shall be removed down to a clean concrete pad. These areas are considered enclosed space entry and all OSHA and Safety Regulations shall be met and adhered to, Including an Enclosed Space Entry Permit.

Contractor shall clean the main connector lines between the Wet Well and Pump House and the Pump House and Existing Leachate Storage Tank by jetting and/or vacuuming until lines are clear and clean. This work shall include inner and outer tank as well as any connecting piping and drains. This work shall be coordinated with the existing pump house maintenance contractor, Carl Roark, so as to provide a thorough cleaning and inspection of the system at one time.

Disposal of debris and liquids associated with this cleaning shall be paid for in Item 7 Debris Hauling and Disposal below.

Item #6 "Existing Tank and Wet Well Cleaning" will be measured and paid as a "lump sum" unit, cost including all labor, equipment, materials, transportation, and incidentals to obtain results satisfactory to the DEP.

Item #7: Debris Hauling and Disposal: The contractor will be responsible for collecting storing transporting and disposal costs of all debris (liquids and solids) generated in the execution of this contract. This will include solids and sludges from the tank cleaning, liquids, rinsate, and sludges from the line and connector jetting. The contractor will be responsible for any analytical testing, permit applications, application fees and special requirements required for disposal at a permitted disposal facility.

The contractor shall also be responsible for the emptying of the leachate backwash tank and disposing of the leachate at a permitted facility for a period of one year. This will include any analytical testing of the leachate, loading, transportation and disposal costs of the leachate line back wash. DEP will contact the contractor when the tank needs emptying and the contactor will completely empty the tank within 48 hours of notification. This work will be paid under item 7b below.

Item #7a "Debris Hauling and Disposal-Solids" will be measured and paid as a "per ton" unit, cost including all labor, equipment, materials, transportation, permits and disposal costs for solids and sludges which cannot be disposed of as a liquid. All disposals shall be so as to provide results satisfactory to the DEP.

Item #7b "Debris Hauling and Disposal-Liquids" will be measured and paid as a "per gallon" unit, cost including all labor, equipment, materials, transportation, permits and disposal costs for liquid leachate. All disposals shall be so as to provide results satisfactory to the DEP.

Item #8: Seeding and Mulching, Contractor shall furnish all labor, equipment, and materials necessary to lime, fertilize, seed, and mulch all disturbed or bare areas.

Limestone: Lime shall be as an agricultural grade pulverized dolomitic limestone containing a minimum of 10 percent MgCO<sub>3</sub> and not less than 95 percent total carbonates. Measure fineness such that not less than 75 percent passes through a #100 sieve and 100 percent passes through a #10 sieve. Apply lime at a rate of 2 tons per acre.

Fertilizer shall be a commercial-grade fertilizer of 10-20-10 composition and of uniform gradation. Apply fertilizer at a rate of 500 lbs/acre.

Mulch consists of straw, including baled wheat or oat straw or baled grass hay. Straw mulch shall be dry and reasonably free of weed seeds, sticks or other foreign material. Apply straw mulch at the rate of 2 tons/acre and anchor with 100 gallons/acre asphalt emulsion or 750 lbs/acre wood cellulose fiber.




