REQUEST FOR QUOTATION (RFQ) AND REQUEST FOR PROPOSAL (RFP)**

1. Awards will be made in the best interest of the State of West Virginia.
2. The State may accept or reject in part, or in whole, any bid.
3. All quotations are governed by the *West Virginia Code* and the *Legislative Rules* of the Purchasing Division.
4. Prior to any award, the apparent successful vendor must be properly registered with the Purchasing Division and have paid the required \$125 fee.
5. All services performed or goods delivered under State Purchase Order/Contracts are to be continued for the term of the Purchase Order/Contracts, contingent upon funds being appropriated by the Legislature or otherwise being made available. In the event funds are not appropriated or otherwise available for these services or goods, this Purchase Order/Contract becomes void and of no effect after June 30.
6. Payment may only be made after the delivery and acceptance of goods or services.
7. Interest may be paid for late payment in accordance with the *West Virginia Code*.
8. Vendor preference will be granted upon written request in accordance with the *West Virginia Code*.
9. The State of West Virginia is exempt from federal and state taxes and will not pay or reimburse such taxes.
10. The Director of Purchasing may cancel any Purchase Order/Contract upon 30 days written notice to the seller.

### Enhancing Electronic Health Record Keeping

#### In West Virginia's Public Schools

##### Scope of Work

The West Virginia Department of Education is soliciting application program development for capturing specific health related information from the health screening of children on a Personal Digital Assistant (PDA). The application will have to sync with the West Virginia Education Information System (WVEIS) student records for the downloading of roster information into the PDA and the uploading of specific health data into WVEIS.

Student information in WVEIS is stored on an IBM I-series computer in DB2-400 data bases with separate files/libraries maintained for each school district. Students are identified by a unique student number created when the student is enrolled. Since the health screenings will take place before all the kindergarten students are enrolled, a scheme for providing a proxy number must be devised. On an upload of the student data, the proxy number will be easily identified so that it can be directed to a holding place until the student is enrolled.

The specific data to be gathered using the PDA includes but is not limited to the following:

- Height and weight with calculation of Body Mass index reliable on student DOB, gender and date of measurement collection (height and weight).
- Vision screening as currently set up in WVEIS school health screen with objective data, codes and date of the screening.
- Hearing screening as currently set up in WVEIS school health screen with objective data, codes and date of the screening.
- Immunization records as currently set up in WVEIS school health screen with month, day and year space for dates (01/01/2001) and codes.
- School Screening "Referral Source" as currently set up in the WVEIS Student Wellness Screen.

The program should have alerts regarding the importance of confidentiality and privacy for individual school health records through a portable device. The application screens must be simple for easy data input with minimal typing required. The use of buttons, check boxes and other such selection options is encouraged.



**Bidder Qualifications**

The vendor must be experienced in PDA programming and interfacing those applications with other platforms. The vendor must have completed at least two school related PDA applications within the last year using a PDA for gathering data and syncing the PDA device with a student management information system for student records uploading and downloading. The bidder must complete the project within two months of the issuance of the purchase order. This includes completion of the PDA work as well as the interfacing programs for uploading and downloading student data (sync). The operating system to be used is Windows Mobile for Pocket PC.

**Terms and Conditions of the Contract**

It is anticipated that this contract will be issued as an open-ended contract. Billing will be received after completion of the work and will reflect the cost of the actual hours required to complete the required work. Additional hours, if any, will be used to provide support and minor modifications to the software over the next twelve months. Vendor will be expected to bill monthly for actual hours used to complete the tasks.

The primary programming work, documentation for use of the product and training must be completed within two months of the issuance of the purchase order.

The purchase order for this contract will be issued to the low bidder who meets the qualifications. The successful bidder will be notified by purchase order from the West Virginia Purchasing Division.

The Agency shall not be responsible for or pay any costs incurred by the bidders in the preparation of the bidding submitted in response to this RFQ.

The Agency shall not be responsible for any work performed by the successful bidder prior to the effective date of this contract.

**Item Pricing**

Vendors are being asked to quote prices in response to this RFQ. Vendors must realize that quantities, when provided, are estimates and will be used in the evaluation of the RFQ. However, it is the intent of the RFQ that this contract be awarded as an open-ended contract. The actual quantities needed is anticipated to fluctuate and unknown at this time. The vendor's rate will be established as a result of this award, but the quantity of items needed will be considered open-ended, to be authorized in advance by the WVDOE.

- Bidder is a resident vendor who certifies that, during the life of the contract, on average at least 75% of the employees working on the project being bid are residents of West Virginia who have resided in the state continuously for the two years immediately preceding submission of this bid; or,

3. Application is made for 2.5% resident vendor preference for the reason checked:

- Bidder is a nonresident vendor employing a minimum of one hundred state residents or is a nonresident vendor with an affiliate or subsidiary which maintains its headquarters or principal place of business within West Virginia employing a minimum of one hundred state residents who certifies that, during the life of the contract, on average at least 75% of the employees or Bidder's affiliate's or subsidiary's employees are residents of West Virginia who have resided in the state continuously for the two years immediately preceding submission of this bid; or,

4. Application is made for 5% resident vendor preference for the reason checked:

- Bidder meets either the requirement of both subdivisions (1) and (2) or subdivision (1) and (3) as stated above; or,

- Bidder is a resident vendor who is a veteran of the United States armed forces, the reserves or the National Guard, if, for purposes of producing or distributing the commodities or completing the project which is the subject of the vendor's bid and continuously over the entire term of the project, on average at least seventy-five percent of the vendor's employees are residents of West Virginia who have resided in the state continuously for the two immediately preceding years.

Bidder understands if the Secretary of Revenue determines that a Bidder receiving preference has failed to continue to meet the requirements for such preference, the Secretary may order the Director of Purchasing to: (a) reject the bid; or (b) assess a penalty against such Bidder in an amount not to exceed 5% of the bid amount and that such penalty will be paid to the contracting agency or deducted from any unpaid balance on the contract or purchase order.

By submission of this certificate, Bidder agrees to disclose any reasonably requested information to the Purchasing Division and authorizes the Department of Revenue to disclose to the Director of Purchasing appropriate information verifying that Bidder has paid the required business taxes, provided that such information does not contain the amounts of taxes paid nor any other information deemed by the Tax Commissioner to be confidential.
