Consumer Advocate Division Public Service Commission 2010 and 2011 ENEC Proceedings

The Consumer Advocate Division of the Public Service Commission is soliciting proposals for the provision of consulting services in connection with the annual rate filings of utility subsidiaries of American Electric Power (AEP) and Allegheny Power (Allegheny) in 2010 and 2011. The Consumer Advocate Division will intervene in both proceedings on behalf of residential customers of AEP and Allegheny.

The rate filings will concern changes to each utility's "Expanded Net Energy Charge" or "ENEC" in West Virginia. Each case will involve a review of actual ENEC costs for the historical review period. Each case will also include a consideration of projected ENEC costs for the year that the new ENEC rates are to be in effect. AEP will file its ENEC request on March 1 and Allegheny will file its request on September 1. The consultant will be expected to provide expert testimony on all cost and revenue issues involved in the ENEC proceedings and appear as an expert witness before the Public Service Commission of West Virginia on behalf of the Consumer Advocate Division.

The successful contractor must be available to render services within one week of the award of the contract. The minimum requirements, qualifications and expertise include all of the following 9 (nine) requirements and are to be provided upon request

- 1. Experience testifying in at least 2 proceedings before the West Virginia Public Service Commission (PSC) on issues pertaining to ratemaking for electric utilities.
- 2. Ability to certify that the consultant has reviewed each of the PSC prior rulings in ENEC proceedings over the last 10 years.
- 3. Experience testifying in at least 2 regulatory proceedings on issues involving coal markets and coal transportation in Appalachia.

PURCHASING AFFIDAVIT

West Virginia Code §5A-3-10a states: No contract or renewal of any contract may be awarded by the state or any of its political subdivisions to any vendor or prospective vendor when the vendor or prospective vendor or a related party to the vendor or prospective vendor is a debtor and the debt owned is an amount greater than one thousand dollars in the aggregate

DEFINITIONS:

"Debt" means any assessment, premium, penalty, fine, tax or other amount of money owed to the state or any of its political subdivisions because of a judgment, fine, permit violation, license assessment, defaulted workers' compensation premium, penalty or other assessment presently delinquent or due and required to be paid to the state or any of its political subdivisions, including any interest or additional penalties accrued thereon

'Debtor" means any individual, corporation, partnership, association, Limited Liability Company or any other form or business association owing a debt to the state or any of its political subdivisions. "Political subdivision" means any county commission; municipality; county board of education; any instrumentality established by a county or municipality; any separate corporation or instrumentality established by one or more counties or municipalities, as permitted by law; or any public body charged by law with the performance of a government function or whose jurisdiction is coextensive with one or more counties or municipalities. "Related party" means a party, whether an individual, corporation, partnership, association, limited liability company or any other form or business association or other entity whatsoever, related to any vendor by blood, marriage, ownership or contract through which the party has a relationship of ownership or other interest with the vendor so that the party will actually or by effect receive or control a portion of the benefit, profit or other consideration from performance of a vendor contract with the party receiving an amount that meets or exceed five percent of the total contract amount

EXCEPTION: The prohibition of this section does not apply where a vendor has contested any tax administered pursuant to chapter eleven of this code, workers' compensation premium, permit fee or environmental fee or assessment and the matter has not become final or where the vendor has entered into a payment plan or agreement and the vendor is not in default of any of the provisions of such plan or agreement
