GENERAL TERMS & CONDITIONS REQUEST FOR QUOTATION (RFQ) AND REQUEST FOR PROPOSAL (RFP)

1. Awards will be made in the best interest of the State of West Virginia.
2. The State may accept or reject in part, or in whole, any bid.
3. Prior to any award, the apparent successful vendor must be properly registered with the Purchasing Division and have paid the required \$125 fee.
4. All services performed or goods delivered under State Purchase Order/Contracts are to be continued for the term of the Purchase Order/Contracts, contingent upon funds being appropriated by the Legislature or otherwise being made available. In the event funds are not appropriated or otherwise available for these services or goods this Purchase Order/Contract becomes void and of no effect after June 30.
5. Payment may only be made after the delivery and acceptance of goods or services.
6. Interest may be paid for late payment in accordance with the *West Virginia Code*.
7. Vendor preference will be granted upon written request in accordance with the *West Virginia Code*.
8. The State of West Virginia is exempt from federal and state taxes and will not pay or reimburse such taxes.
9. The Director of Purchasing may cancel any Purchase Order/Contract upon 30 days written notice to the seller.
10. The laws of the State of West Virginia and the *Legislative Rules* of the Purchasing Division shall govern the purchasing process.
11. Any reference to automatic renewal is hereby deleted. The Contract may be renewed only upon mutual written agreement of the parties.
12. **BANKRUPTCY:** In the event the vendor/contractor files for bankruptcy protection, the State may deem this contract null and void, and terminate such contract without further order.

Temperature monitoring system must operate with the following requirements:

- System accuracy must be +/- 1°C including error in the sensor plus digitizing electronics in a range of 0°C (32°F) to 100°C (212°F).
- The system must require no user calibration.
- Each temperature sensor must be individually, digitally identified by a permanent serial number.
- Each temperature sensor must be able to internally store sensor location information and start time in the sensor for easy identification and verification of time of use.
- Each temperature sensor shall record the time and temperature at a minimum of 1 hour intervals for a minimum of 28 days.
- Each temperature sensor must record the high and low temperature events while recording temperature readings in increments of 1 hour for 28 days.
- Sensor leads must be extendable using ordinary copper wire.
- Sensor leads must be able to be trimmed to a shorter length and used without rewiring a connector to the end of the leads before use.
- For reason of mechanical strength, the sensor wires must be 18 gauge or larger.
- Temperature data from the system must be uninterruptable and unalterable.
- Each sensor shall upon download of the information, produce a secure (unalterable) file that identifies the logger by its serial number and the start date.
- The temperature sensor data must be able to be viewed on a hand held reader device in the field for immediate review and decision making.
- The temperature sensor data must be able to be downloaded onto a hand held data reader device for data transport and transfer onto a computer.
- Cables or other applicable hardware shall be supplied with each hand held data reader device so that the data may be transferred onto a computer.
- An Operation Manual and carrying case shall be supplied with each hand held data reader device.
- The system must have software to manage the temperature sensor data that must include serial number, name, location and graphing capabilities for temperature readings. A copy of this software shall be included with each hand held data reader device.
- The system software must include graphic capabilities of including multiple sensors in the same graph. At least 16 temperature sensors must be able to be viewed on the same graph. The software must include graphs that automatically display differential temperatures and comparisons to cold weather thresholds.
- Recording equipment shall allow intermediate downloading of measurements to a computer without restarting the device or interrupting the datalogging process.

Also, along with the material being specified, the Supplier shall provide customer support including training at MCS&T Division on how to install and operate the temperature monitoring system. A representative from the Supplier shall also be available for consultation and troubleshooting on projects where this system is used.

Certification and application* is hereby made for Preference in accordance with *West Virginia Code*, §5A-3-37.  Bidder is a resident vendor who certifies that, during the life of the contract, on average at least 75% of the employees working on the project being bid are residents of West Virginia who have resided in the state continuously for the two years immediately preceding submission of this bid; or,
3. **Application is made for 2.5% resident vendor preference for the reason checked:**
 Bidder is a nonresident vendor employing a minimum of one hundred state residents or is a nonresident vendor with an affiliate or subsidiary which maintains its headquarters or principal place of business within West Virginia employing a minimum of one hundred state residents who certifies that, during the life of the contract, on average at least 75% of the employees or Bidder's affiliate's or subsidiary's employees are residents of West Virginia who have resided in the state continuously for the two years immediately preceding submission of this bid; or,

Bidder understands if the Secretary of Revenue determines that a Bidder receiving preference has failed to continue to meet the requirements for such preference, the Secretary may order the Director of Purchasing to: (a) reject the bid; or (b) assess a penalty against such Bidder in an amount not to exceed 5% of the bid amount and that such penalty will be paid to the contracting agency or deducted from any unpaid balance on the contract or purchase order.

By submission of this certificate, Bidder agrees to disclose any reasonably requested information to the Purchasing Division and authorizes the Department of Revenue to disclose to the Director of Purchasing appropriate information verifying that Bidder has paid the required business taxes, provided that such information does not contain the amounts of taxes paid nor any other information deemed by the Tax Commissioner to be confidential.

PURCHASING AFFIDAVIT

West Virginia Code §5A-3-10a states: No contract or renewal of any contract may be awarded by the state or any of its political subdivisions to any vendor or prospective vendor when the vendor or prospective vendor or a related party to the vendor or prospective vendor is a debtor and the debt owned is an amount greater than one thousand dollars in the aggregate

DEFINITIONS:

"Debt" means any assessment, premium, penalty, fine, tax or other amount of money owed to the state or any of its political subdivisions because of a judgment, fine, permit violation, license assessment, defaulted workers' compensation premium, penalty or other assessment presently delinquent or due and required to be paid to the state or any of its political subdivisions, including any interest or additional penalties accrued thereon.

"Debtor" means any individual, corporation, partnership, association, Limited Liability Company or any other form or business association owing a debt to the state or any of its political subdivisions. "Political subdivision" means any county commission; municipality; county board of education; any instrumentality established by a county or municipality; any separate corporation or instrumentality established by one or more counties or municipalities, as permitted by law; or any public body charged by law with the performance of a government function or whose jurisdiction is coextensive with one or more counties or municipalities. "Related party" means a party, whether an individual, corporation, partnership, association, limited liability company or any other form or business association or other entity whatsoever, related to any vendor by blood, marriage, ownership or contract through which the party has a relationship of ownership or other interest with the vendor so that the party will actually or by effect receive or control a portion of the benefit, profit or other consideration from performance of a vendor contract with the party receiving an amount that meets or exceed five percent of the total contract amount.

EXCEPTION: The prohibition of this section does not apply where a vendor has contested any tax administered pursuant to chapter eleven of this code, workers' compensation premium, permit fee or environmental fee or assessment and the matter has not become final or where the vendor has entered into a payment plan or agreement and the vendor is not in default of any of the provisions of such plan or agreement.
