GENERAL TERMS & CONDITIONS REQUEST FOR QUOTATION (RFQ) AND REQUEST FOR PROPOSAL (RFP)

1. Awards will be made in the best interest of the State of West Virginia.
2. The State may accept or reject in part, or in whole, any bid.
3. Prior to any award, the apparent successful vendor must be properly registered with the Purchasing Division and have paid the required \$125 fee.
4. All services performed or goods delivered under State Purchase Order/Contracts are to be continued for the term of the Purchase Order/Contracts, contingent upon funds being appropriated by the Legislature or otherwise being made available. In the event funds are not appropriated or otherwise available for these services or goods this Purchase Order/Contract becomes void and of no effect after June 30.
5. Payment may only be made after the delivery and acceptance of goods or services.
6. Interest may be paid for late payment in accordance with the *West Virginia Code*.
7. Vendor preference will be granted upon written request in accordance with the *West Virginia Code*.
8. The State of West Virginia is exempt from federal and state taxes and will not pay or reimburse such taxes.
9. The Director of Purchasing may cancel any Purchase Order/Contract upon 30 days written notice to the seller.
10. The laws of the State of West Virginia and the *Legislative Rules* of the Purchasing Division shall govern the purchasing process.
11. Any reference to automatic renewal is hereby deleted. The Contract may be renewed only upon mutual written agreement of the parties.
12. **BANKRUPTCY:** In the event the vendor/contractor files for bankruptcy protection, the State may deem this contract null and void, and terminate such contract without further order.

1. To what extent will siblings outside the target age range be included in the pilot project?

Answer:

All siblings will be assessed using the same process as the children within the target age range. Any identified needs will be addressed, including additional assessments, services, etc.

2. Is the Child and Adolescent Needs and Strength (CANS) assessment used for all foster care children or will it just be used by the pilot sites?

Answer:

Initially, WVCANS will be used for children identified at the pilot sites (counties). During this same time period, we will also be training & certifying individuals to administered the WVCANS for CAPS, Regional Clinical Review Process and Community Based Teams.

3. Is the CANS intended for ongoing service planning or just for use upon a child's removal from the home?

Answer:

WVCANS is intended to used as an on-going tool.

4. Who administers the CANS (e.g., BCF caseworkers, providers, clinical staff)?

Answer:

Providers, which could include clinical staff, will be trained and certified to administer the WVCANS. BCF caseworkers will have an understanding of how the WVCANS is used in the decision-making process specific to the child.

5. Is CANS information recorded in the state's case management system?

Answer:

No, not at this time.

6. Have the pilots begun in the regions and counties?

Answer:
