GENERAL TERMS & CONDITIONS REQUEST FOR QUOTATION (RFQ) AND REQUEST FOR PROPOSAL (RFP)

1. Awards will be made in the best interest of the State of West Virginia.
2. The State may accept or reject in part, or in whole, any bid.
3. Prior to any award, the apparent successful vendor must be properly registered with the Purchasing Division and have paid the required \$125 fee.
4. All services performed or goods delivered under State Purchase Order/Contracts are to be continued for the term of the Purchase Order/Contracts, contingent upon funds being appropriated by the Legislature or otherwise being made available. In the event funds are not appropriated or otherwise available for these services or goods this Purchase Order/Contract becomes void and of no effect after June 30.
5. Payment may only be made after the delivery and acceptance of goods or services.
6. Interest may be paid for late payment in accordance with the *West Virginia Code*.
7. Vendor preference will be granted upon written request in accordance with the *West Virginia Code*.
8. The State of West Virginia is exempt from federal and state taxes and will not pay or reimburse such taxes.
9. The Director of Purchasing may cancel any Purchase Order/Contract upon 30 days written notice to the seller.
10. The laws of the State of West Virginia and the *Legislative Rules* of the Purchasing Division shall govern the purchasing process.
11. Any reference to automatic renewal is hereby deleted. The Contract may be renewed only upon mutual written agreement of the parties.
12. **BANKRUPTCY:** In the event the vendor/contractor files for bankruptcy protection, the State may deem this contract null and void, and terminate such contract without further order.
13. **HIPAA BUSINESS ASSOCIATE ADDENDUM:** The West Virginia State Government HIPAA Business Associate Addendum (BAA), approved by the Attorney General, is available online at www.state.wv.us/admin/purchase/vrc/hipaa.htm and is hereby made part of the agreement. Addendum to CME11021 Vendor Questions

Question 1:

Will this RFQ be awarded to one and only one vendor, or is there a possibility of multiple awards?

Response to Question 1:

This RFQ will be awarded to one and only one vendor.

Question 2:

Are subcontractors allowed for individual tests that are not performed in-house?

Response to Question 2:

Yes, subcontractors are allowed for individual tests that are not performed in-house with the understanding that OCME's contract is with the vendor awarded the contract and all terms and conditions of the contract are the responsibility of the awarded vendor.

Question 3:

On the list of services to be provided:

Toxicology laboratories have different scopes and/or reporting limits for several of the classes of compounds requested (i.e. metals, inhalants, amphetamines, etc.). How would the difference in the individual laboratories scope and performance be judged/graded to account for these differences?

Response to Question 3:

The selected lab must offer a broad range of metals testing and comprehensive panels for inhalant compounds. For amphetamine-type drugs (sympathomimetic amines), labs must be able to perform chiral analysis for differentiation of ephedrine/pseudoephedrine. Similarly, labs must be able to distinguish levorphanol from the desmethyl metabolite of dextromethorphan.

Question 4:

What are the payment terms associated with this RFQ?

Response to Question 4:

The payment terms associated with this RFQ is 30 days after receipt of invoice.

Question 5:

With respect to the possible two 1-year renewal periods:

Is the bid price expected to be guaranteed for both renewal periods or the percent discount? Is there a mechanism (through CPI or other index) that would allow for price increases for the second and third year?

Response to Question 5:

The bid price and the percent discount will be guaranteed for both renewal periods. If contract is renewed, price increases will not be allowed for the renewal period(s).
