REQUEST FOR QUOTATION (RFQ) AND REQUEST FOR PROPOSAL (RFP)

1. Awards will be made in the best interest of the State of West Virginia.
2. The State may accept or reject in part, or in whole, any bid.
3. Prior to any award, the apparent successful vendor must be properly registered with the Purchasing Division and have paid the required \$125 fee.
4. All services performed or goods delivered under State Purchase Order/Contracts are to be continued for the term of the Purchase Order/Contracts, contingent upon funds being appropriated by the Legislature or otherwise being made available. In the event funds are not appropriated or otherwise available for these services or goods this Purchase Order/Contract becomes void and of no effect after June 30.
5. Payment may only be made after the delivery and acceptance of goods or services.
6. Interest may be paid for late payment in accordance with the *West Virginia Code*.
7. Vendor preference will be granted upon written request in accordance with the *West Virginia Code*.
8. The State of West Virginia is exempt from federal and state taxes and will not pay or reimburse such taxes.
9. The Director of Purchasing may cancel any Purchase Order/Contract upon 30 days written notice to the seller.
10. The laws of the State of West Virginia and the *Legislative Rules* of the Purchasing Division shall govern the purchasing process.
11. Any reference to automatic renewal is hereby deleted. The Contract may be renewed only upon mutual written agreement of the parties.

Relocation of Existing Facility

The West Virginia Division of Juvenile Services is Soliciting Bids for the relocation of a 28' X 74' modular office space at its Wayne County WV location.

Scope of work:

I. Building Materials

Materials- Vendor will furnish all materials for installation and finishes at the mate line of the building to include: interior walls, floors and ceiling and exterior roof, walls, gutters and venting.

II. Delivery and Installation

Transport- Vendor will be responsible for the transport of the building units to the new site.

Architectural Engineering- Vendor will be responsible for the payment of all building permits, B&O taxes and architectural drawings and fees.

Site Work/Foundations- Excavation, footers, water and sewer, landscape, trench repair, grading and vapor barrier is the responsibility of the contractor. Modular building finished floor is to be a minimum 36" from ground. The concrete block foundation will conform to design and construction of the existing foundation. Split block facing will be selected from standard colors approved by the owner.

Installation- The contractor will complete installation of the facility to include interior and exterior finishes.

Concrete Walks - Concrete walks at all entrance doors with ramps as necessary at the main entrance to comply with ADA. Furnish and install concrete access walks at the three (3) entrance doors, for an estimated 80 linear feet of walkway. Any additional walk way will be calculated on a per foot basis. Install the compacted gravel base as required for the installation of the 4" reinforced concrete slabs. Saw cut the masonry at the door sills to achieve 4"

minimum bearing. Provide expansion joint at each door entrance. Sidewalk is to be 42" in width.

Note: Concrete used will be a 5 bag concrete fiber mix. Rebar will be used at the site and will be 3/8" in diameter. Sidewalk will have a single rebar along the perimeter. Sidewalk will be at a minimum 42" in width and the length of the sidewalk will be determined at pre-bid meeting.

Landscaping- Landscaping will be done by the owner; contractor will provide a fine grade finish with seed and mulch for all disturbed areas.

Electric/Plumbing- Contractor will provide all necessary materials and labor to connect a 200 amp overhead electrical service to the existing mast and meter socket. Contractor will provide all necessary materials and labor to connect a 4 inch sewer line from the building to the onsite sewer connection and a 1 inch water line from the meter to the building. (Distance to be determined at the pre-bid meeting)

III. Mobilization of the Wayne building.

Removal of finishes and masonry as required for separating of the units, packaging for transport, and removing the building units from the foundation will be the responsibility of the vendor. Vendor will furnish running gear (axels, tires, and hitches).

Refuse- vendor will be responsible for the disposal of any and all refuse associated with relocation and installation.

Completion Date- Vendor will have ninety (90) calendar days from the day of award to complete this project. There will be a final walkthrough by DJS staff upon completion.

Warranty - The warranty will be for a period of 1 year for materials and workmanship associated with the removal and installation of the building. Roof work will be approved by the manufacturer and inspected by them at the cost of the contractor.

Wage Rates: Prevailing wage rate will apply to this project.

Prior to any award, the apparent successful vendor must be properly registered with the Purchasing Division.

This will be awarded to the vendor with the lowest bid meeting all of the specifications.

There will be a mandatory pre-bid meeting on Monday, December 20, 2010 at 11:00 a.m. located at the Wayne County Youth Report Center. Failure to attend this mandatory pre-bid meeting will result in disqualification of the bid.

PURCHASING AFFIDAVIT

"Related party" means a party, whether an individual, corporation, partnership, association, limited liability company or any other form or business association or other entity whatsoever, related to any vendor by blood, marriage, ownership or contract through which the party has a relationship of ownership or other interest with the vendor so that the party will actually or by effect receive or control a portion of the benefit, profit or other consideration from performance of a vendor contract with the party receiving an amount that meets or exceed five percent of the total contract amount.

EXCEPTION: The prohibition of this section does not apply where a vendor has contested any tax administered pursuant to chapter eleven of this code, workers' compensation premium, permit fee or environmental fee or assessment and the matter has not become final or where the vendor has entered into a payment plan or agreement and the vendor is not in default of any of the provisions of such plan or agreement.
