GENERAL TERMS & CONDITIONS REQUEST FOR QUOTATION (RFQ) AND REQUEST FOR PROPOSAL (RFP)

- 1. Awards will be made in the best interest of the State of West Virginia.
- 2. The State may accept or reject in part, or in whole, any bid.

3. Prior to any award, the apparent successful vendor must be properly registered with the Purchasing Division and have paid the required \$125 fee.

- 4. All services performed or goods delivered under State Purchase Order/Contracts are to be continued for the term of the Purchase Order/Contracts, contingent upon funds being appropriated by the Legislature or otherwise being made available. In the event funds are not appropriated or otherwise available for these services or goods this Purchase Order/Contract becomes void and of no effect after June 30.
- 5. Payment may only be made after the delivery and acceptance of goods or services.
- 6. Interest may be paid for late payment in accordance with the West Virginia Code.
- 7. Vendor preference will be granted upon written request in accordance with the West Virginia Code.
- 8. The State of West Virginia is exempt from federal and state taxes and will not pay or reimburse such taxes.
- 9. The Director of Purchasing may cancel any Purchase Order/Contract upon 30 days written notice to the seller.
- 10. The laws of the State of West Virginia and the Legislative Rules of the Purchasing Division shall govern the purchasing process.
- 11. Any reference to automatic renewal is hereby deleted. The Contract may be renewed only upon mutual written agreement of the parties.
- 12. BANKRUPTCY: In the event the vendor/contractor files for bankruptcy protection, the State may deem this contract null and void, and terminate such contract without further order.
- 13. The vendor must provide all necessary releases to obtain information to enable the director or spending unit to verify that the vendor is licensed and in good standing with the above entities.

The West Virginia State Police is requesting competitive bids for Field Sobriety Testers (FST). The FST contract will be available for all State, County, and local agencies to purchase from. This contract will also remain in effect for further purchases of the products listed. All products bid must be new equipment no rebuilt or refurbished equipment will be accepted.

Vendors shall bid an Intoximeter ALCO Sensor FST or Equal.

All specifications shall equal or exceed the below listed specifications. If you put you exceed a specification please annotate on separate paper the line item number and how you exceed the specification.

It is preferred that all vendors submit product information data sheets along with pictures with their quote.

Vendors shall use the provided specification sheet with separate sheet for explanations.

Vendors shall use the provided quotation sheet to submit their bids, shipping shall be included in price quote.

FST SPECIFICATIONS YES NO **APPROVALS** 1. The instrument must meet the US DOT Model Specifications for Evidential Breath Testing Devices and is listed on the NHTSA CPL. PHYSICAL DIMENSIONS 2. The instrument must be hand-held. 3. The instrument must not weigh more than 0.5 lbs / 229 grams / 8.0 ounces. 4. The instrument must fit in a standard shirt pocket. Its dimensions shall not exceed 6 inches in height by 3 inches in width by 1.5 inches in depth. The grip area of the instrument does not have a width greater than 2.5 inches. **POWER REQUIREMENTS** 5. The device shall have a self contained power supply 6. At room temperature (22°C), the instrument, with a set of new batteries, shall provide enough power to perform a minimum of 1000 tests with the back light display illuminated. 7. 8. The instrument must have a low battery indicator.

10. The instrument must display the numeric reported alcohol result in characters with a minimum height of 10 mm.
11. The instrument shall be capable of making an audible tone when the instrument is powered ON, when the instrument is ready to accept a sample, when subject is blowing, and when the result or a status message is displayed.

12. The instrument display must be a LED or a back lit LCD for easy viewing in low light conditions.
CASING AND HANDLING FEATURES
13. Each instrument shall be supplied with a hard plastic protective carrying case. The case must be designed to hold a minimum of five individually wrapped mouthpieces.
