GENERAL TERMS & CONDITIONS REQUEST FOR QUOTATION (RFQ) AND REQUEST FOR PROPOSAL (RFP)

1. Awards will be made in the best interest of the State of West Virginia.
2. The State may accept or reject in part, or in whole, any bid.
3. Prior to any award, the apparent successful vendor must be properly registered with the Purchasing Division and have paid the required \$125 fee.
4. All services performed or goods delivered under State Purchase Order/Contracts are to be continued for the term of the Purchase Order/Contracts, contingent upon funds being appropriated by the Legislature or otherwise being made available. In the event funds are not appropriated or otherwise available for these services or goods this Purchase Order/Contract becomes void and of no effect after June 30.
5. Payment may only be made after the delivery and acceptance of goods or services.
6. Interest may be paid for late payment in accordance with the *West Virginia Code*.
7. Vendor preference will be granted upon written request in accordance with the *West Virginia Code*.
8. The State of West Virginia is exempt from federal and state taxes and will not pay or reimburse such taxes.
9. The Director of Purchasing may cancel any Purchase Order/Contract upon 30 days written notice to the seller.
10. The laws of the State of West Virginia and the *Legislative Rules* of the Purchasing Division shall govern the purchasing process.
11. Any reference to automatic renewal is hereby deleted. The Contract may be renewed only upon mutual written agreement of the parties.

Health Education Assessment Project

The West Virginia Department of Education, Division of Educator Quality and System Support, Office of Healthy Schools, provides leadership, training and support for schools and their communities designed to improve collaboration and ensure the health and educational achievement of children in a safe, nurturing and disciplined environment. This office has developed a health education assessment designed to reflect the Content Standards and Objectives that are the basis of curriculum designs for grades PreK-12.

The purpose of the Request for Quotation (RFQ) is to seek bids from vendors qualified to provide the West Virginia Department of Education an online platform to deliver the Health Education Assessment Project for 6th, 8th and high school students.

Scope of Work: The WVDE Health Education Assessment Project (HEAP) is designed to assist health education professionals in schools, districts and the state in assessing student knowledge based upon the WV Health/Wellness Education Content Standards and Objectives. The successful bidder will be expected to work with the Office of Healthy Schools in developing and implementing an online assessment platform to accomplish this task statewide in grades 6, 8 and high school (maximum of 60,000 students per year).

Vendors must realize that student enrollments are estimates and that the actual number of students completing the assessments will fluctuate and are unknown at this time. The vendor's rate will be established at the cost per pupil completing an assessment.

Procurement Specifications

Deliverables – Vendor will deliver:

1. Develop the website with PC and MAC compatibility in electronic format no later than thirty (30) days after award of bid.
2. The website will be dedicated to deliver three different assessment modules
3. Beta version of the three assessments must be developed in order for the WVDE to review and prove effectiveness before a final version is implemented.
4. The website will contain a logo selected by the WVDE
5. The website will have onsite registration capability.
6. The website must be password protected.
7. Assessment instructions will be provided with each module.
8. Provide online cross tabulation capability using site, county, regional and state aggregations
9. Provide online provision of raw assessment data and grading using site, county, regional and state aggregations.
10. Provide customized reporting capacity throughout assessment period using site, county, regional and state aggregations.
11. The website will allow text field entries capability.

12. Provide the WVDE with a semi-annual data aggregation and feedback report of completed assessments at school, district and state levels.
13. Provide a 1 (one) day on-site training for 15 participants.
14. Develop an online tutorial to assist teachers and students.
15. Provide a toll-free or online customer assistance to be available 9:00 – 4:00 Monday through Friday.

Vendor Qualifications:

PURCHASING AFFIDAVIT

West Virginia Code §5A-3-10a states: No contract or renewal of any contract may be awarded by the state or any of its political subdivisions to any vendor or prospective vendor when the vendor or prospective vendor or a related party to the vendor or prospective vendor is a debtor and the debt owed is an amount greater than one thousand dollars in the aggregate.

DEFINITIONS:

"Debt" means any assessment, premium, penalty, fine, tax or other amount of money owed to the state or any of its political subdivisions because of a judgment, fine, permit violation, license assessment, defaulted workers' compensation premium, penalty or other assessment presently delinquent or due and required to be paid to the state or any of its political subdivisions, including any interest or additional penalties accrued thereon.

"Debtor" means any individual, corporation, partnership, association, limited liability company or any other form or business association owing a debt to the state or any of its political subdivisions. "Political subdivision" means any county commission; municipality; county board of education; any instrumentality established by a county or municipality; any separate corporation or instrumentality established by one or more counties or municipalities, as permitted by law; or any public body charged by law with the performance of a government function or whose jurisdiction is coextensive with one or more counties or municipalities. "Related party" means a party, whether an individual, corporation, partnership, association, limited liability company or any other form or business association or other entity whatsoever, related to any vendor by blood, marriage, ownership or contract through which the party has a relationship of ownership or other interest with the vendor so that the party will actually or by effect receive or control a portion of the benefit, profit or other consideration from performance of a vendor contract with the party receiving an amount that meets or exceed five percent of the total contract amount.

EXCEPTION: The prohibition of this section does not apply where a vendor has contested any tax administered pursuant to chapter eleven of this code, workers' compensation premium, permit fee or environmental fee or assessment and the matter has not become final or where the vendor has entered into a payment plan or agreement and the vendor is not in default of any of the provisions of such plan or agreement.
