1. Awards will be made in the best interest of the State of West Virginia.
 2. The State may accept or reject in part, or in whole, any bid.
 3. Prior to any award, the apparent successful vendor must be properly registered with the Purchasing Division and have paid the required \$125 fee.
 4. All services performed or goods delivered under State Purchase Order/Contracts are to be continued for the term of the Purchase Order/Contracts, contingent upon funds being appropriated by the Legislature or otherwise being made available. In the event funds are not appropriated or otherwise available for these services or goods this Purchase Order/Contract becomes void and of no effect after June 30.
 5. Payment may only be made after the delivery and acceptance of goods or services.
 6. Interest may be paid for late payment in accordance with the *West Virginia Code*.
 7. Vendor preference will be granted upon written request in accordance with the *West Virginia Code*.
 8. The State of West Virginia is exempt from federal and state taxes and will not pay or reimburse such taxes.
 9. The Director of Purchasing may cancel any Purchase Order/Contract upon 30 days written notice to the seller.
 10. The laws of the State of West Virginia and the *Legislative Rules* of the Purchasing Division shall govern the purchasing process.

Specifications

Purpose: This contract will be for mold remediation of the parts storeroom of the West Virginia Division of Highways Morgan County Headquarters located at 166 DOH Lane, Berkeley Springs, WV.

Work shall be performed as specified in Scope of Work and will include mold remediation; cleaning, removal and disposal of mold damaged or contaminated building materials, removal and salvage of parts and paper work, treatment of the room with an antimicrobial solution, and post remediation testing and certification of mold elimination.

Replacement of damaged building materials and shelving will be handled by others.

Mandatory On-Site Pre-Bid Meeting: A mandatory on-site pre-bid meeting will be conducted on 08/10/11 @10:00 at the project site. All prospective bidders must be in attendance in order to be allowed to submit a bid. The purpose of the pre-bid meeting is to allow prospective bidders the opportunity to review the project site.

All interested Vendors are required to be represented at this meeting. Failure to attend shall result in the disqualification of the bid. 1.0 SCOPE OF WORK

The successful Vendor shall:

- B. Seal the Parts Storeroom from the remainder of the interior of the garage structure during removal to prevent the spread of microbial spores and/or debris.
- C. Remove and dispose of all water and/or mold damaged building material, fixtures and/or domestic items. Including plywood drop ceiling throughout the parts storage room, the gypsum-board shelves from the metal-frame shelving units, cardboard boxes, and other cellulose-based materials.
- D. Remove the parts and equipment located in the parts storage room salvaging metal parts and parts enclosed in plastic or plastic-wrapped containers. However, any parts or accessories stored in impacted cardboard boxes should be removed from the boxes, cleaned, clearly marked, and stored in new containers, if necessary. New containers will be provided by the Division of Highways.
- E. Stored files and other needed paper goods should be placed in new, clean plastic containers and evaluated on a container by container basis to inspect for suspect microbial growth with a DOH representative. New containers will be provided by DOH.

- F. WVDOH will designate a facility employee liaison to direct the remediation contractor on what materials/parts can or should be salvaged from the parts storage room prior to remediation activities.
- G. All debris should be promptly cleaned and sealed in an air tight manner. Building materials and furnishings that are contaminated with mold growth shall be double-bagged using 6-mil polyethylene sheeting to minimize the dispersion of mold spores throughout the building. Large items that have heavy mold growth should be covered with polyethylene sheeting and sealed with duct tape before they are removed from the parts room.
- H. The remediated areas shall be cleaned using a disinfecting solution and vacuumed with a vacuum equipped with a High Efficiency Particulate Air (HEPA) filter.
- I. Any remaining affected structural members, such as wooden wall and/or roof joists above the drop ceiling, the CMU walls, and the concrete slab floor, are to be treated with an antimicrobial solution to kill any active growth, lightly sanded or otherwise cleaned to remove microbial contamination, and treated with an antimicrobial paint or preservative to prevent any further microbial growth.
- J. The vendor will be responsible for all post remediation testing and certification of mold elimination, and as well as any testing and monitoring required during the project.
- K. Work is to be completed within 30 days of the Notice to Proceed.

2.0 QUALIFICATIONS

- A. Vendor must provide supporting documents regarding their firm and staff qualifications and experience in completing similar projects; references and copies of any firm or staff certifications or degrees applicable to this project; descriptions of past projects completed entailing the location of the project, project manager name and contact information, type of project, and what the project goals and objectives were and how they were met.
