1. Awards will be made in the best interest of the State of West Virginia.
2. The State may accept or reject in part, or in whole, any bid.
3. Prior to any award, the apparent successful vendor must be properly registered with the Purchasing Division and have paid the required \$125 fee.
4. All services performed or goods delivered under State Purchase Order/Contracts are to be continued for the term of the Purchase Order/Contracts, contingent upon funds being appropriated by the Legislature or otherwise being made available. In the event funds are not appropriated or otherwise available for these services or goods this Purchase Order/Contract becomes void and of no effect after June 30.
5. Payment may only be made after the delivery and acceptance of goods or services.
6. Interest may be paid for late payment in accordance with the *West Virginia Code*.
7. Vendor preference will be granted upon written request in accordance with the *West Virginia Code*.
8. The State of West Virginia is exempt from federal and state taxes and will not pay or reimburse such taxes.
9. The Director of Purchasing may cancel any Purchase Order/Contract upon 30 days written notice to the seller.
10. The laws of the State of West Virginia and the *Legislative Rules* of the Purchasing Division shall govern the purchasing process.
11. Any reference to automatic renewal is hereby deleted. The Contract may be renewed only upon mutual written agreement of the parties.
12. **BANKRUPTCY:** In the event the vendor/contractor files for bankruptcy protection, the State may deem this contract null and void, and terminate such contract without further order.

2. SCOPE OF WORK

To furnish culvert pipe liner and culvert inlet bells to the Division of Highways for all ten Districts to be delivered to Division of Highways' project sites and/or Division of Highways' District storage yards located throughout the State.

3. REQUIREMENTS

All culvert pipe liners and culvert inlet bells supplied under this contract shall be manufactured in accordance with American Association of State Highway Official Standard Specification, AASHTO Designation M326-08. Reference: <http://transportation.org>.

All lubricant, gaskets and sealants necessary for installation shall be supplied by the awarded vendor at no additional cost.

4. BIDDING INSTRUCTIONS

Bidders may submit bids for any or all sizes of culvert pipe liner listed on the Bid Schedule in Section 9 and Section 10.

NOTE: Bid Schedule Section 9 = Price per foot In-Stock Lengths
Bidder must provide In-Stock Length(s) with bid.

Bid Schedule Section 10 = Price per foot for Non-Stock Lengths
At the time of need, the Non-Stock Length will be provided to the awarded Vendor on the Agency Release.

Bidders may submit bids for any or all sizes of culvert inlet bells to fit each diameter size of culvert pipe liner listed on the Bid Schedule in Section 11.

Bidders should be aware that the quantities listed on the Bid Schedule, Section 9, Section 10 and Section 11 are estimates only.

Any qualification of bids or any modification of the specifications or conditions governing the bids may be cause for their rejection.

5. CONTRACT AWARD

Qualified vendors who submit a valid low bid will be awarded a contract for those items for which their bid is lowest per District. The State of West Virginia reserves the right to make multiple awards on this contract when it is in the best interest of the State.

6. DELIVERY

An Agency Release will be issued to the awarded Vendor at the time delivery is needed. The Agency Release will provide the actual quantity of culvert pipe liner and/or culvert inlet bells needed along with the Division of Highways project site address and/or the Division of Highways District storage site address and will also include a Division of Highways' contact's name and phone number.

The vendor shall notify the Division of Highways' contact listed on the Agency Release forty-eight (48) hours in advance of delivery to ensure personnel are available for unloading.

Delivery will be FOB Origin, Freight Prepaid and Added to the invoice.

7. VENDOR'S INVOICE

Vendor's invoices must be submitted in original and one copy and contain the following:

- a. The Agency Release Number and this Contract Number.
- b. Item number and description, total quantity, unit price and the total cost of the material furnished.
- c. Prepaid Freight charges.

Note: Under no circumstance will the Division of Highways accept, or pay for, quantities of material in excess of the quantity stated on the Agency Release.

8. PURCHASING CARD ACCEPTANCE

PURCHASING AFFIDAVIT

"Related party" means a party, whether an individual, corporation, partnership, association, limited liability company or any other form or business association or other entity whatsoever, related to any vendor by blood, marriage, ownership or contract through which the party has a relationship of ownership or other interest with the vendor so that the party will actually or by effect receive or control a portion of the benefit, profit or other consideration from performance of a vendor contract with the party receiving an amount that meets or exceed five percent of the total contract amount.

EXCEPTION: The prohibition of this section does not apply where a vendor has contested any tax administered pursuant to chapter eleven of this code, workers' compensation premium, permit fee or environmental fee or assessment and the matter has not become final or where the vendor has entered into a payment plan or agreement and the vendor is not in default of any of the provisions of such plan or agreement.
