GENERAL TERMS & CONDITIONS REQUEST FOR QUOTATION (RFQ) AND REQUEST FOR PROPOSAL (RFP)

1. Awards will be made in the best interest of the State of West Virginia.
 2. The State may accept or reject in part, or in whole, any bid.
 3. Prior to any award, the apparent successful vendor must be properly registered with the Purchasing Division and have paid the required \$125 fee.
 4. All services performed or goods delivered under State Purchase Order/Contracts are to be continued for the term of the Purchase Order/Contracts, contingent upon funds being appropriated by the Legislature or otherwise being made available. In the event funds are not appropriated or otherwise available for these services or goods this Purchase Order/Contract becomes void and of no effect after June 30.
 5. Payment may only be made after the delivery and acceptance of goods or services.
 6. Interest may be paid for late payment in accordance with the *West Virginia Code*.
 7. Vendor preference will be granted upon written request in accordance with the *West Virginia Code*.
 8. The State of West Virginia is exempt from federal and state taxes and will not pay or reimburse such taxes.
 9. The Director of Purchasing may cancel any Purchase Order/Contract upon 30 days written notice to the seller.
 10. The laws of the State of West Virginia and the *Legislative Rules* of the Purchasing Division shall govern the purchasing process.
 11. Any reference to automatic renewal is hereby deleted. The Contract may be renewed only upon mutual written agreement of the parties.
 12. **BANKRUPTCY:** In the event the vendor/contractor files for bankruptcy protection, the State may deem this contract null and void, and terminate such contract without further order.

- 1) **Question:** Where can we access for a review the referenced completed first phases that include the analysis of the current system and recommendations for the future system?

Answer: All information prepared during the existence of the Comprehensive Behavioral Health Commission has been made available electronically at www.wvcbhc.org and is available for review.

- 2) **Question:** In order to provide a cost total an estimation of the number of hours is needed. Is there a minimum/maximum number of hours expected or will this be based on the consultation hours used in the first phase and if so, what was that number?

Answer: There is no minimum or maximum number of hours set forth in the RFQ, however it should be noted that the previous annual contract hours were approximately 160. Hours will need to be proposed based upon the vendors estimates of number of hours needed to achieve the requirements set forth in the RFQ by project team member level.

- 3) **Question:** Who or what entity provided the facilitation for the first phase?

Answer: The West Virginia University Center for Entrepreneurial Studies and Development (WVU-CESD)

- 4) **Question:** Is it anticipated that all of the groups and interested parties involved in phase one will continue to participate with the development and implementation process or may there be new members added to the group(s).

Answer: The existing members will remain a part of the Commission and process. In addition to the previous/current members, HB3021 which passed during the 2011 Legislative Session calls for the addition of two additional members.
