GENERAL TERMS & CONDITIONS REQUEST FOR QUOTATION (RFQ) AND REQUEST FOR PROPOSAL (RFP)

1. Awards will be made in the best interest of the State of West Virginia.
2. The State may accept or reject in part, or in whole, any bid.
3. Prior to any award, the apparent successful vendor must be properly registered with the Purchasing Division and have paid the required \$125 fee.
4. All services performed or goods delivered under State Purchase Order/Contracts are to be continued for the term of the Purchase Order/Contracts, contingent upon funds being appropriated by the Legislature or otherwise being made available. In the event funds are not appropriated or otherwise available for these services or goods this Purchase Order/Contract becomes void and of no effect after June 30.
5. Payment may only be made after the delivery and acceptance of goods or services.
6. Interest may be paid for late payment in accordance with the *West Virginia Code*.
7. Vendor preference will be granted upon written request in accordance with the *West Virginia Code*.
8. The State of West Virginia is exempt from federal and state taxes and will not pay or reimburse such taxes.
9. The Director of Purchasing may cancel any Purchase Order/Contract upon 30 days written notice to the seller.
10. The laws of the State of West Virginia and the *Legislative Rules* of the Purchasing Division shall govern the purchasing process.
11. Any reference to automatic renewal is hereby deleted. The Contract may be renewed only upon mutual written agreement of the parties.
12. **BANKRUPTCY:** In the event the vendor/contractor files for bankruptcy protection, the State may deem this contract null and void, and terminate such contract without further order.

**Apple Grove State Fish Hatchery
Purchase of Alfalfa Meal, Soybean Meal and Dried Molasses
Open End Contract**

The West Virginia Division of Natural Resources is requesting bids for the purchase alfalfa meal, soybean meal and dried molasses for the Apple Grove State Fish Hatchery. All items are to be F.O.B. Destination. Freight or delivery charges must be included in the unit cost of each item. The hatchery will call the successful vendor one week in advance for delivery and all items will be ordered as needed. The award may be split if it is in the best interest of the West Virginia Division of Natural Resources.

Alfalfa Meal

50 lb. bag of alfalfa meal. All orders will be placed in two (2) ton increments. Total orders off this open-end contract are not expected to exceed twenty-eight (28) tons in a one-year contract period. Alfalfa meal must meet the following specifications:

- Must contain 100% alfalfa meal;
- Must contain a minimum of 17% protein; and
- Must contain a minimum of 32% crude fiber.

Soybean Meal

50 lb. bag of soybean meal. All orders will be placed in one (1) ton increments. Total orders of this open-end contract are not expected to exceed fourteen (14) tons in a one-year contract period. Soybean meal must meet the following specifications:

- Must be 100% soybean meal;
- Must contain a minimum of 44% protein; and
- Must contain a minimum of 7% crude fiber.

Dried Molasses

50 lb. bag of dried molasses. All orders will be placed in two (2) ton increments. Total orders off this open-end contract are not expected to exceed sixteen (16) tons in a one-year contract period. Dried molasses must meet the following specifications:

- Must contain at least 6% crude protein; and
- Must contain a maximum of 20% crude fiber.

Please note that the alfalfa and soybean meal will be ordered together and therefore, can be delivered at the same time.

By submission of this certificate, Bidder agrees to disclose any reasonably requested information to the Purchasing Division and authorizes the Department of Revenue to disclose to the Director of Purchasing appropriate information verifying that Bidder has paid the required business taxes, provided that such information does not contain the amounts of taxes paid nor any other information deemed by the Tax Commissioner to be confidential.

PURCHASING AFFIDAVIT

West Virginia Code §5A-3-10a states: No contract or renewal of any contract may be awarded by the state or any of its political subdivisions to any vendor or prospective vendor when the vendor or prospective vendor or a related party to the vendor or prospective vendor is a debtor and the debt owed is an amount greater than one thousand dollars in the aggregate.

DEFINITIONS:

"Debt" means any assessment, premium, penalty, fine, tax or other amount of money owed to the state or any of its political subdivisions because of a judgment, fine, permit violation, license assessment, defaulted workers' compensation premium, penalty or other assessment presently delinquent or due and required to be paid to the state or any of its political subdivisions, including any interest or additional penalties accrued thereon.

"Debtor" means any individual, corporation, partnership, association, limited liability company or any other form or business association owing a debt to the state or any of its political subdivisions. "Political subdivision" means any county commission; municipality; county board of education; any instrumentality established by a county or municipality; any separate corporation or instrumentality established by one or more counties or municipalities, as permitted by law; or any public body charged by law with the performance of a government function or whose jurisdiction is coextensive with one or more counties or municipalities. "Related party" means a party, whether an individual, corporation, partnership, association, limited liability company or any other form or business association or other entity whatsoever, related to any vendor by blood, marriage, ownership or contract through which the party has a relationship of ownership or other interest with the vendor so that the party will actually or by effect receive or control a portion of the benefit, profit or other consideration from performance of a vendor contract with the party receiving an amount that meets or exceeds five percent of the total contract amount.

EXCEPTION: The prohibition of this section does not apply where a vendor has contested any tax administered pursuant to chapter eleven of this code, workers' compensation premium, permit fee or environmental fee or assessment and the matter has not become final or where the vendor has entered into a payment plan or agreement and the vendor is not in default of any of the provisions of such plan or agreement.
