GENERAL TERMS & CONDITIONS
REQUEST FOR QUOTATION (RFQ) AND REQUEST FOR PROPOSAL (RFP)

1. Awards will be made in the best interest of the State of West Virginia.
2. The State may accept or reject in part, or in whole, any bid.
3. Prior to any award, the apparent successful vendor must be properly registered with the Purchasing Division and have paid the required \$125 fee.
4. All services performed or goods delivered under State Purchase Order/Contracts are to be continued for the term of the Purchase Order/Contracts, contingent upon funds being appropriated by the Legislature or otherwise being made available. In the event funds are not appropriated or otherwise available for these services or goods this Purchase Order/Contract becomes void and of no effect after June 30.
5. Payment may only be made after the delivery and acceptance of goods or services.
6. Interest may be paid for late payment in accordance with the *West Virginia Code*.
7. Vendor preference will be granted upon written request in accordance with the *West Virginia Code*.
8. The State of West Virginia is exempt from federal and state taxes and will not pay or reimburse such taxes.
9. The Director of Purchasing may cancel any Purchase Order/Contract upon 30 days written notice to the seller.
10. The laws of the State of West Virginia and the *Legislative Rules* of the Purchasing Division shall govern the purchasing process.
11. Any reference to automatic renewal is hereby deleted. The Contract may be renewed only upon mutual written agreement of the parties.
12. **BANKRUPTCY:** In the event the vendor/contractor files for bankruptcy protection, the State may deem this contract null and void, and terminate such contract without further order.
13. **HIPAA BUSINESS ASSOCIATE ADDENDUM:** The West Virginia State Government HIPAA Business Associate Addendum (BAA), approved by the Attorney General, is available online at www.state.wv.us/admin/purchase/vrc/hipaa.htm and is hereby made part of the agreement. Provided that the Agency meets the definition of a Cover Entity (45 CFR §160.103) and will be disclosing Protected Health Information (45 CFR §160.103) to the vendor.

The vendor must provide all necessary releases to obtain information to enable the director or spending unit to verify that the vendor is licensed and in good standing with the above entities.
16. **ANTITRUST:** In submitting a bid to any agency for the State of West Virginia, the bidder offers and agrees that if the bid is accepted the bidder will convey, sell, assign or transfer to the State of West Virginia all rights, title and interest in and to all causes of action it may now or hereafter acquire under the antitrust laws of the United States and the State of West Virginia for price fixing and/or unreasonable restraints of trade relating to the particular commodities or services purchased or acquired by the State of West Virginia. Such assignment shall be made and become effective at the time the purchasing agency tenders the initial payment to the bidder.

Vendor Question #1:

It appears that this RFQ does not require a formal proposal response. Can you confirm that we are only being asked to provide the completed bid price sheet and the key staff resumes. Can you please let me know if we need to provide anything else?

BPH Response to Vendor Question #1:

As required under "Bid Requirements" in the Request for Quotation (RFQ), vendors are required to:

1. Complete, sign, and date the Bid Price Sheet
2. Provide resumes for key staff that will be assigned to this contract depicting the following vendor experience as required under "Vendor Requirements" of the RFQ.
 - A minimum of nine years experience working with the Centers for Disease Control (CDC), National Breast and Cervical Cancer Early Detection Programs (NBCCEDP)
 - A minimum of eight years experience developing add-on-data systems to CaST, including a minimum of eight years experience developing CaST add-on applications.

The vendor awarded this contract will be required to submit a copy of its liability insurance as described under "Insurance Requirements" of the RFQ prior to a purchase order being issued.

The vendor awarded this contract will be required to submit a copy of its Workers Compensation coverage prior to a purchase order being issued.

Vendor Question #2:

We noticed that there is not a deliverable for maintenance and support once the system is installed and accepted. While we will be training the users and handing off the system to West Virginia, it's been our experience with our other CaST Add-on data system clients, that it's helpful to have us available for the following year to answer any additional questions and address any issues that might arise after the system goes into use and your users acclimate to the new system. Would the State like to consider adding another deliverable or labor category hourly rates for this support?

BPH Response to Vendor Question #2:

As required under "Software Requirements" of the RFQ, vendor will provide all software/application codes which upon receipt will become the property of OMCFH. Codes will be open for modification by OMCFH or another vendor as deemed necessary by OMCFH. After vendor fulfills the requirements of this RFQ, continued vendor maintenance and support is not required. If additional needs arise in the future, a separate contract will be negotiated and awarded.
