


Question #1: Is there any chance you could provide a few photos of the existing vests?



Answer #1: A sample of the vest supplied on the most recent Contract was not available. However, photos as requested of a vest that is manufactured closely to the specifications of the RFQ are shown below. Note that the front closure of the vest shown does not meet the Contract specifications and that the size of the lettering is not as is specified in the RFQ.




Outer front

Question #2: May I please have the "ADOPT-A-HWY" lettering in vectorized format?

Answer #2: A .dxf format electronic file containing the specified ADOPT-A-HWY lettering has been posted along with the electronic version of the RFQ on the state purchasing bulletin website. However, note that if the Vendor is required to provide a sample vest, it is required to have screen printed lettering or a screen printed logo on it, but the sample logo or lettering does not have to match what is specified in the Contract RFQ in regards to the specific lettering and size. For the sample, we are only interested in reviewing the quality of the Vendor's screen printing.
