2. Work time on cooler & freezers doors must be alternated as follows:

One cooler and one Freezer door on same side must be worked on together.
3. Vendors can have material delivered to warehouse upon notice to warehouse of delivery.
4. In section 3.1.1.15 of the Bi-Part Freezer Door Specs, it is to read as follows:

Two Electric Bi-Part Freezer Doors must be One (1) three button station, open, close, stop, mounted within five (5) feet of floor.
5. In section 3.1.2.13 of the Bi-Part Cooler Doors, it is to read as follows:

Two Electric Bi-Part Cooler Doors must be one (1) three button station, open, close, stop, mounted within five (5) feet of floor.
