- 2: The building addition area is to be undercut approximately seven feet and replaced with engineered fill instead of augur cast aggregate piles per the Terracon report and the Earthwork specification defines engineered fill as granular (crush n run gravel).

All engineered fill is not required to be granular. Please refer to Section 4.2.2 Material Requirements in the Geotechnical Engineering Report by Terracon, dated January 23, 2013, for additional fill types and locations.
