Q.1. We understand that the schedule for testimony by other parties in this case is yet to be determined, but that the Company has proposed that Staff and Intervenor testimony be due February 8, 2013. Can the Consumer Advocate Division provide any estimates of when Intervenor testimony will be due? In particular, if the testimony is due in February 8, the winning consultant will only have a month to issue discovery, review responses, complete the analyses, and prepare the testimony.

A.1. All of the intervenor parties submitted a proposed schedule (on December 17, 2012) which, if adopted, would require testimony to be filed on March 26, 2013. The Commission has not issued an order adopting any schedule. If the Consumer Advocate Division believes the Commission is unlikely to require testimony on February 8, but the consultant will be required to meet that date if necessary.

Q.2 Does Consumer Advocate Division expect the consultant to prepare any analyses of the cost at which the Companies are proposing to acquire Harrison, or is the consultant to take that as a given?

A.2. The fair market write-up of the Harrison plant will be an issue in the case. The consultant should be prepared to analyze the impact of Harrison with and without the write-up impact. The consultant is not expected to prepare an alternative fair market analysis.

Q.3. Does the Consumer Advocate Division expect the consultant to address the ratemaking mechanism the Companies are proposing to recover their cost of acquiring Harrison?

A.3. No. That issue will be addressed by a witness from the Consumer Advocate Division's staff.
