TAX13001 Questions & Answers

- 1Q. In the past 12 months, multiple vendors have offered responses to heat-applied cigarette tax stamp RFP's issued by State Department's of Revenue. In several instances, States have awarded contracts based solely on price to vendors with limited prior experience in delivering, issue free, production quality tax stamp products for affixation to packs of cigarettes. This has required States to delay introduction of tax stamps or issue purchase orders to alternate vendors for provision of tax stamps after contract awards. In order to protect the State from experiencing such delays and prevent emergency purchase orders, would the State consider adding a formal evaluation criteria to the RFP that requires vendors to describe their past experience and qualification for meeting the general requirements as described in section 3.1 of RFP?
- 1A. A section can be added to ask the vendor to supply their past experience and qualification for meeting the general requirements as described in section 3.1 of the RFQ. However, this was not submitted as a "RFP" and therefore cannot be assigned points or evaluated for this extra paperwork that is turned in. The bid will still be evaluated and awarded based on the lowest bidder that meets the mandatory specifications listed in the RFQ.
- 2Q. Section 8. Required Documents Will the State accept Professional Liability insurance in lieu of the bonds requested in the RFP? We currently provide this to numerous State customers.
- 2A. No. (The solicitation is a RFQ)
- 3Q. Section 3.1.10.1 With cutting edge technology in flexographic print we are actually capable of printing multiple layered stamps with improved color, design, and security features all with improved adhesion and stamp transfer. Is this technology acceptable as an alternative process?
- 3A. No, we prefer to purchase the stamp as requested in the specs, the same as we currently have in inventory.
- 4Q. Section 3.1.10.1 Is the State willing to review samples to formulate an opinion regarding Question #2?
- 4A. We've already seen the stamps and would prefer to purchase the stamps that we currently have in inventory.
