RFQ# 631400006: DOT answers to the submitted questions

Questions for Bid #'s 631400006

- 1.) 3.1.3 Are You currently utilizing the software in ImVision?
 - 3.1.3 The Structured Infrastructure Cable Telecommunications Distribution System must be compatible with the existing DOT CommScope iPatch / ImVision system.

DOT has purchased the ImVision (iPatch) software; it is currently installed on a DOT server and is in an implementation period.

- 2.) 3.1.4 The specification consists of Chatsworth, CommScope, SPI, Geist, Hager, Tripp-Lite and so on. This would not be a single manufacturer.
 Can you please explain in further detail what you mean by this statement?
 - 3.1.4 All copper cable and fiber as well as all termination and installation material used must be from a single manufacture and provide a 15 year warranty.

This requirement refers to the copper and fiber materials only. This would include (not limited to) cable, patch panels, outlets, faceplate, surface mount boxes, fiber jumpers, copper patch cables, and other material as required by the manufacture to meet their requirements to issue the 15 year warranty.

3.) Can the bid opening be delayed one week?

No. At this point DOT does not see a reason to delay the bid opening.

Technical Questions for State of WV RFQ# 631400006 (District 4 and 5 Cabling)

1) Page 28, Section 3.2 indicates that there are two DMV locations (Morgantown and Fairmont). Section 3.2.1 states, "Installation of 96 Cat-6A Jacks as required"; does this mean there are 96 Cat-6A jacks in each of the two locations for a total of 192 jacks?

Yes. The bid would be for 96 Cat-6A jacks in each of the locations.

Page 20, Section 1 indicates that there are 12 DOH County HQ locations in District 4 and
 Section 3.4.1 states, "Installation of up to 36 Cat-6 Jacks as required"; does this mean there are up to 36 Cat-6 jacks in each of the twelve locations for a total of 432 jacks?

Yes. The bid would be for 36 Cat-6A jacks in each of the locations.

3) Page 20, Section 1 indicates that there are 16 DOH Substation locations. Section 3.5.1 states, "Installation of up to 24 Cat-6 Jacks as required"; does this mean there are up to 24 Cat-6 jacks in each of the sixteen locations for a total of 384 jacks?

Yes. The bid would be for 24 Cat-6A jacks in each of the locations.

4) It is my understanding that this project is a Prevailing Wage (Davis-Bacon Act) project. Is this correct?

Yes. It is a WV State constriction project and by law requires prevailing wages to be paid.

5) It was discussed in the Pre-bid meeting on 12/3/13 that the State desires that the Vendor have an RCDD on staff as well as current SYSTIMAX Certification. Is this a requirement of the RFQ?

The Vendor must have a **BICSI RCDD®** (Registered Communications Distribution Designer) with **OSP** (Outside Plant Specialty) on staff that will be ultimately responsible for this project. The RCDD must have experience in the installation of **outside plant and** structured cabling telecommunications distribution systems the size and scope as the one specified in this project. A list of the structured cabling telecommunications distribution systems that includes at minimum fiber connectivity between four buildings in a campus environment with 100 horizontal cabling runs in two separate buildings must be provided to display the ability of the RCDD to oversee this project. Should the RCDD assigned to this project change during the installation, the new RCDD assigned must meet all requirements of the RFQ.

The Vendor must have CommScope, Siemon and BICSI Registered Installers and Technicians or equal on staff and assign them to this project. The project shall be staffed at all times by certified Installers and Technicians

The vendor must provide a telecommunications technician with experience cross connecting fiber cabling, analog, and digital systems in a multi-building campus environment. A list of previous projects shall be available upon request.

The vendor must also provide a project clerk for up to 10 hours weekly as deemed necessary by The State and /or The Vendor.

- The vendor is responsible for the removal of abandoned cable after migration to the new cable is complete. At a minimum;
 - Abandoned Cable Removal Language Source: 2005 NEC
 - 770.3(A) Spread of Fire or Products of Combustion. "The accessible portion of abandoned optical fiber cables shall be removed."
 - 800.52(B) Spread of Fire or Products of Combustion. "The accessible portion of abandoned communications cables shall not be permitted to remain."
 - 820.3 Spread of Fire or Products of Combustion. "The accessible portion of abandoned coaxial cables shall be removed."
 - 830(A) Spread of Fire or Products of Combustion. "The accessible portion of abandoned network-powered broadband communication cables shall be removed."

> The available work hours:


- As discussed, final work hours will be set with the successful vendor during the kick off meeting.

> Fiber extension:


- As discussed additional fiber will be installed by the vendor connecting the Bridge Maintenance Building and the Shop.
