## ATTACHMENT A

Questions:

Q1: Per Answer A1, page 3, of Attachment A, the Agency estimates 350 male inmates and 50 female inmates. However, COR61659 – Attachment C – Cost Sheet includes an estimate of 300 male inmates as the Description for Item #2 is for "50 – 100 Male Inmates". Would the Agency consider changing the Description of Item #2 to "0 – 100 Male Inmates" making the total estimate for the male inmates equal 350? Alternatively, would the Agency consider adding a new line item to provide for a per diem for "0 – 49 Male Inmates"?

A1: See revised cost sheet - Attachment C.

Q2: The Note on COR61659 – Attachment C – Cost Sheet currently reads as "Vendor shall invoice Agency based on number of inmates housed in Vendor's facility as of last day of each month". Since the population may fluctuate up or down each day of each month and consistent with industry practice, will the Agency consider changing the Note to read as "Vendor shall invoice Agency based on number of inmates housed in Vendor's facility as of midnight for each day of each month"?

A2: See revised cost sheet – Attachment C.

Agency agrees to change the notation to read: "Vendor shall invoice the Agency on a monthly basis, based on the number of inmates housed in Vendor's facility as of midnight for each day of the month".

Q3: Please provide the DOC's policies and procedures.

A3: Vendors should contact Betty Slack with the WV Division of Corrections to obtain copies of the WV Division of Corrections policy and procedures.

- Q4: On page 12, Answer A63, in reference to commissary pricing, states that a price sheet is attached. That price sheet was not included in Addendum No. 2. Please provide the referenced price sheet.
- A4: The commissary price list is attached inadvertently omitted from Addendum No. 2 issued on 10/29/2013.

***The following question needed a follow-up answer as stated in Addendum No. 2 issued 10/29/13. The question number and response in Addendum No. 2 was Q20 and A20.***

- Q5: Page 28, Project Specifications, Section 5.28, Vendor's Assumption of Risk Relating to Constitutional Limitations and Indemnification. Subsection 5.28.2 indicates that the Vendor will assume all risk of liability for any claim brought by a prisoner relating in any way to the inmate's placement in the Vendor's facility. As a Vendor under the contract, we would have no control over the circumstances that give rise to these claims; therefore, we cannot agree to assume the risk of liability for inmates' claims relating to their placement in our facility. Will the State agree to delete section 5.28.2 in its entirety? In the alternative to deletion, will the State agree to work with the Vendor to negotiate a reasonable and mutually agreeable clause that appropriately allocates the risk associated with these claims?
- A5: Agency submits the following amendment to Section 5.28.

**5.28 Vendor's Assumption of Risk Relating to Constitutional Limitations and Indemnification**

- 5.28.1 The Vendor must expressly acknowledge that Article III § 5 of the West Virginia Constitution provides that “[n]o person shall be transported out of, or forced to leave the State for any offense committed within the same. . .” This clause has been held to mean that state prisoners cannot be incarcerated within facilities outside of the state. Ray v. McCoy, 174 W.Va. 1, 321 S.E.2d 90 (1984). At least one state with a similar prohibition has since reached a different conclusion about the effect of housing prisoners outside of the state of conviction. Daye v. State, 171 Vt. 475, 769 A.2d 630 (2000) citing Olim v. Wakinekona, 461 U.S. 238, 248, 103 S.Ct. 1741, 75 L.Ed.2d 813 (1983).
- 5.28.2 However, the scope of this agreement shall be solely limited to the incarceration of prisoners willing to consent to their transfer to a facility operated by the Vendor. The Vendor shall defend, indemnify, and hold harmless the State of West Virginia, the Division of Corrections, and their officials, agents, and employees from and against any claims brought by a prisoner relating to the prisoner's housing or placement within a facility operated by the Vendor. Said indemnification shall not be applicable to any claim, injury, death, or damage to property arising out of any act or omission on the part of the state, its officers, agents, servants, or independent contractors (other than the Owner/Operator) who are directly responsible to the State.

- 5.28.3 The Vendor must defend in any action at law, indemnify, and hold harmless the State of West Virginia, the Division of Corrections, and their officials, agents, and employees from and against any claim or cause of action which arises from any act or omission by the Vendor or any of the Vendor's employees or subcontractors, including the following:
- 5.28.3.1 Any claims or losses for services rendered by the vendor or persons performing or supplying services in connection with the performance of the contract;
  - 5.28.3.2 Any claims or losses to any person injured or damaged by the willful or negligent actions of the vendor, its officers or employees in the performance of the contract;
  - 5.28.3.3 Any claims or losses resulting to any person injured or damaged by the vendor, its officers or employees by the publication, translation, reproduction, delivery, performance, use or disposition of any data processed under the contract in a manner not authorized by the contract, or by federal or state regulations or statutes;
  - 5.28.3.4 Any failure of the vendor, its officers or employees to adhere to applicable laws, including but not limited to labor laws and minimum wage laws;
  - 5.28.3.5 Any constitutional, federal, state, or civil rights claim brought against the State, Agency or its officers, agents or employees, related to the prison facilities or treatment of the prisoners housed therein;
  - 5.28.3.6 Any claims, losses, demands or causes of action arising out of the Vendor's activities in this state; and
  - 5.28.3.7 Attorney fees or court costs arising from any habeas corpus actions or other inmate suits which may arise, including, but not limited to, attorney fees for the State's representation, any court appointed representation of any inmate, and the costs of any special judge who may be appointed to hear such actions.
