During the pre bid meeting we were told that compressed air piping could be of the flex type. The specifications state that schedule 40, threaded ,black iron steel pipe is to be used. Please clarify.

ANSWER:

The specifications do call for air piping to be iron pipe out to the area of each exhibit.

Drops from the valve to the animatronic elements can be flexible.

We choose hard pipe to make sure there aren't any malfunctions that could damage anything in the museum.

Flexible tubing is not as durable and could get cut or punctured.
