What pads are required for this bid Pedi-pads II model number 8900-0810-01, CPR-D Padz (One Piece Pad) model number 8900-0800-01, Stat-Pads II Multi Function Electrodes model number 8900-0801-01? Note only the CPR-D Padz have a five year shelf-life.
