 - **A.1.**Building 16 is connected to the State Ethernet system Connection to the Building 11 building automation system should be done over the existing ethernet with a bacnet interface at the building automation system.
- 2. What are the requirements for connecting to Bldg 11? Ethernet, Bacnet, or EST Network? And are there provisions by the state for this data pathway within building 16?
 - A.2. See response to question A.1 above.
- 3. The specification calls for an audio evacuation system, but the prints call for horn strobes instead of speaker strobes. Please clarify.
 - A.3. Provide speaker strobes.
- 4. The specification calls for a system printer connected to the fire alarm. Is there to be a printer, and if so where will this printer be placed?
 - A.4. A separate printer for the fire panel is not required.
- 5. There was made mention at the walkthrough that the CO detectors would not have to have sounder bases. Please clarify if that is correct.
 - A.5. Provide sounder bases in the eight classrooms. Set for low db output.
- What type of Fire Alarm system is currently in place here and is it planned to add to existing or replace with new I do not see any details as of yet on the bid site.
 - A.6. The plans and specifications specify replacing the existing panel with a new panel located at the west entrance to the building..
