ATTACHMENT A

Addendum #5 for LSH14035

1. Question: The original specification was for 2 layers of 2" insulation. The response to question 6 in addendum 2 calls for insulation to be tapered at ½" slope per foot. Typically, a minimum thickness at the roof drains is specified as well. Can a minimum thickness of tapered insulation at the drains be provided? Another way of doing this is to specify an average R-value for the tapered insulation system. As the original specification was for 2 layers of 2", which is an R-24.2, you could specify that the average R-value of the insulation system is to be R-24.2. Either a minimum thickness or an average R-value is required to supply the tapered insulation system.

Answer: Install a 2.5" minimum thickness, 1/8" slope per foot, fully tapered insulation system over the entire roof area. Average R-value of tapered insulation system shall be R-25. Add wood blocking, as necessary, at perimeters to maintain a constant perimeter edge height equal to or above the maximum height of tapered insulation.
