- A1: To replace Section 4.1, Contract Award, in its entirety and replace with the following:
 - 4.1 Contract Award: The Contract is intended to provide Agencies with a purchase price for the Contract Items. The Contract shall be awarded to the Vendor that provides the Contract Items meeting the required specifications for the lowest overall total cost as shown on the Pricing Pages. The intention is to award one contract, however, if judged to be in the best interest of the State of West Virginia, the award may be split.

- A2: To produce metal printing plates to mount on presses. To eliminate the need for negatives, stripping and burning of plates. To upgrade our operation to increase productivity.
- Q3: What are the hardware and software components.
- A3: Hardware:

 - b) Firestation Controller and Flat panel display
 - c) Dimension air management system
 - d) Offline plate washer (2 stage)
 - e) Combo plate punch
