The Federal Transit Administration's "Third Party Contracting Circular" (4220.1F), requires grantees (the Division) to conduct procurements in a manner that prohibits the use of statutorily or administratively imposed in-State or local geographical preferences in the evaluation of bids or proposals, except in those cases where applicable Federal statutes expressly mandate or encourage geographic preference. This RFQ should have no in state vendor preference since a portion of the funding for this project comes from the Federal Transit Administration and is subject to 49 U.S.C. § 5325. Applying Geographical Preference to this RFQ would jeopardize the receipt of Federal funds; therefore, the Division of Public Transit would like to invoke subsection d of the West Virginia Code § 5A-3-37 which states that in-state vendor preference shall not apply to this procurement since it is partially or entirely funded with Federal Transit Administration funds.
